

**Part I (Pre –Qualification Part)**

- 1) Bidders who are interested in supply are required to submit their offer in TWO PART (Pre –Qualification & Technocommercial Cum Price part) through our website i.e. [www.uraniumcorp.in](http://www.uraniumcorp.in) or [www.tenderwizard.com/UCILEPROC](http://www.tenderwizard.com/UCILEPROC) subject to meeting pre qualification criteria and terms & condition of our NIT (as per annexure -2). Bidders who are not meeting the pre-qualification criteria and not confirming all NIT terms & condition in part-1 (i.e. Pre-qualification Part) their offer will be rejected and their price part shall not be opened. Offer submitted in single part will out rightly be rejected. However, for submitting the offer through E–procurement please contact following persons of I.T.I.

- 2) Tender submission time on due date : Upto 11:30 AM  
 Tender opening time on due date : 12:30 PM onward.
- 3) **Pre –Qualification Criteria:** (As per Annexure-3)  
 (Bidder must submit all the required information and scan copy of all the required documents in support of PQC as well as Tender fees and EMD if applicable, failing which their offer will be rejected.)
- 4) **TENDER FEE:** Parties who are interested to participate in the tender may do so by depositing **Rs. 300/-** as tender fee deposited in SBI (any branch) through SBI challan as per format available to UCIL website: [www.uraniumcorp.in](http://www.uraniumcorp.in) **OR** by demand draft (DD) drawn on State Bank of India, Jaduguda Branch ( Code no. 0227) drawn in favour of URANIUM CORPORATION OF INDIA LTD. Documentary evidence regarding tender document fee submitted through SBI challan/ Demand Draft (DD) i.e. scan copy of the same must be uploaded along with Techno Commercial Part. Subsequently hard copy of challan/DD should be reached us on or before due date in a sealed envelope super scribing “TENDER FEES” tender ref. no & due date without which the offer shall be rejected. Exemption to tender fee will be allowed to company / units registered with MSME /SSI/ NSIC / Director of Industries of State, Cottage Industries approved by the State Authority subject to submission of scan copy of valid documentary evidence.
- 5) **EARNEST MONEY DEPOSIT (E.M.D):** the EMD amount shall be Rs. 10000/-. EMD may be submitted by way of a demand draft/ Banker cheque drawn on State Bank of India, Jaduguda Branch (Code No. 0227) drawn in favour of URANIUM CORPORATION OF INDIA LTD. EMD shall not bear any interest. EMD may also be submitted in the form of Bank Guarantee.  
 In case where the EMD is provided in form of BG in the prescribed format to be attached with the tender, the BG shall be obtained from a scheduled commercial / nationalized bank. The genuineness of BG should be checked from the issuing bank. The offers received from tenderers without EMD and/or tender cost shall be summarily rejected except where exemption is provided in the tender.  
 MSME/NSIC/Small Scale Industries (SSI) with current valid registration with state or central govt. shall be exempted from payment of EMD (after ensuring that the registration in case of SSI) pertains to the class of items/stores/works for which the tender is floated.  
 EMD is liable to be forfeited if:
  - a) The tenderer changes the terms and conditions or prices or withdraw his quotation subsequent to the date of opening.
  - b) The tenderer fails to accept the order when placed or fails to commence supplies/works after accepting the order
  - c) In case bidder submits false/fabricated documents.
  - d) In case bidder fails to submit security deposit within 30 days of receipt of work/purchase order by the authority competent to conclude supply contract order
- 6) All terms & conditions indicated in Part II is required to be accepted by the bidders in totality in Part I (Pre qualification Part) and indicate one line confirmation in Part I i.e. **“All Tender terms & conditions indicated in Techno-commercial cum Price part (as per Annexure 2) have been agreed by us in totality”** failing which their offer will be rejected and price part shall not be opened.
- 7) Bidders who are not registered with UCIL for RTGS payment .They should provide Bank details, Scan copy of Pan Card and GSTIN number (if applicable) & copy of cancelled cheque leaf along with Pre qualification Part.

**Part II (Technocommercial Cum Price Part)**  
**NIT TERMS & CONDITIONS**

- 1) Following terms & conditions is required to be accepted by the participated bidders in totality and also mentioned one line confirmation in Part I (Pre qualification Part) that **"Specification and All Tender terms & conditions indicated in Techno-commercial cum Price part (as per Annexure 2) have been agreed by us in totality"** Failing which their offer will be rejected and price part shall not be opened.
- 2) **Basis of Evaluation:** offer submitted by the bidder shall be in two part .Evaluation of L1 (Lowest) bidder shall be done based on their lowest landed quoted rate subject to qualify in Part I i.e. Pre Qualification Part. Bidder should quote their rate both figures as well as in words. In case of any discrepancy in figure and words rate, then rate written in words will be final.
- 3) Bidders whose name exists in our **dormant list (Adverse Remarks Register)** their offer will not be considered.
- 4) **Price term:** Bidders should submit their offer on F.O.R. destination basis for supply of materials at our Jaduguda/Narwapahar/Turamdih Stores. .No other price term is acceptable. All freight and insurance charges will be borne by the bidder.
- 5) **Validity:** Offer validity should be 120 days from the due date of tender.
- 6) **Payment term:** Bidder should quote payment term as "100% payment will be made within 30 days from the date of receipt & acceptance of material "
- 7) **Quantity:** Quantity or stores indicated herein is approximate only and purchaser is not bound to order of full quantity and your offer should be valid for part quantity also.
- 8) **Sample:** Sample, if called for, shall be submitted free of all charges and the same may not be returned to the tenderer.
- 9) **Delivery Schedule:** Bidder should indicate their best delivery schedule.
- 10) Offers must be submitted positively within the due date. Tenders will not be accepted after 11.30 A.M on the due date of submission of offers.
- 11) **Taxes:** All taxes shall be claimed at actual prevailing at the time of dispatch. Documentary proof shall be submitted.
- 12) Bidder should submit their GSTIN number along with their offer as well as indicate HSN code and SAC code for their quoted materials and services respectively as the case may be.
- 13) **Firm Price:** The price should be firm till the execution of entire order quantity.
- 14) **LIQUIDATED DAMAGES (L.D) :** Liquidated Damages (LD) shall be levied where reason are attributable to supplier / contractors for delays in execution of purchase order / contract LD shall be levied @0.5% per week or part thereof on the value of unfinished supply / work order for each week of delay subject to a maximum of 5% of the total value of contract (excluding Taxes and Duties).
- 15) **SECURITY DEPOSIT:**
  - a) Security deposit (SD) shall be uniformly levied @ 5% of contract value towards satisfactory completion of the order.
  - b) SD should be submitted in the form of demand draft / bankers cheque / BG within 30 days of receipt of letter of acceptance or commencement of work at site whichever is earlier to materials department / IEC / OIC.
  - c) EMD may be adjusted towards SD. However, if EMD is submitted in the form of bank guarantee, fresh bank guarantee is to be submitted towards SD in the prescribed format to be attached with order.
  - d) Security deposit may be recovered while releasing the first payment to the party in case the same is not deposited by the supplier.
  - e) Supplier/Contractor is also permitted to furnish BG in favour of Uranium Corporation of India Ltd. in the prescribed format towards security deposit.
  - f) Additional amount of SD due to enhancement in scope of work is also to be obtained.

The SD & retention money shall stand forfeited in favour of UCIL, without any further notice to the contractor in the following circumstance:

  - a) In case of any failure whatsoever on the part of the contractor at any time during performance of his part of the contract including the extended periods of contract, where notice is given and time of rectification allowed.
  - b) If the contractor indulges at any time in any subletting / sub-contracting of any portion of the work without approval of UCIL.
- 16) **BANK GUARANTEES (B.Gs)**
  - a) Bank guarantees wherever stipulated should be as per our proforma & issued by an Indian Nationalised bank/ Scheduled bank.
  - b) They shall be valid for periods as under.
    - i) For Earnest Money Deposit: Till expiry of the quotation.
    - ii) For Security Deposit: Till satisfactory completion of order.
  - c) All bank guarantees shall provide for claim period of 6 months after the expiry date.
  - d) If the bank guarantees are furnished with validity periods less than as stipulated above or in the likelihood of the order not being executed within the stipulated delivery schedule, it will be your responsibility to arrange for extension of the validity of BGs as necessary and furnish the same well in advance of the expiry of the bank guarantee failing which we will be at liberty to invoke the bank guarantee.
- 17) **CANCELLATION OF ORDER:** It will be your endeavour to execute the purchase order to our satisfaction. In case of your failure to do so, the order is liable to be cancelled.

- 18) **FORCE MAJEURE**: Force majeure is an event beyond the control of supplier/contractor and not involving the supplier's/contractor's fault or negligence and which is not foreseeable. Such events may include, but are not restricted to acts of the purchaser/contractor either in its sovereign or contractual capacity, wars or revolution, hostility, acts of public enemy, civil commotion, floods, explosions, epidemics, quarantine restrictions, strikes, lockouts and freight embargoes or any other event which UCIL may deem fit to consider so. The decision about force majeure shall rest with UCIL which shall be final and binding. Force Majeure clause has to be compulsorily embedded in the order.  
If there is delay in performance or other failures by the supplier/contractor to perform obligations under its contract due to event of a Force Majeure, the supplier/contractor shall not be held responsible for such delays/failures.  
If a Force Majeure situation arises, the supplier/contractor shall promptly notify the purchaser in writing of such conditions and the cause thereof within fifteen days of occurrence of such event. Unless otherwise directed by the purchaser in writing, the supplier shall continue to perform its obligations under the contract as far as reasonable/practical and shall seek all reasonable alternative means for performance not prevented by the Force Majeure event.  
If the performance in whole or in part or any obligation under this contract is prevented or delayed by any reason of Force Majeure for a period of exceeding sixty days, UCIL may at its option terminate the contract without any financial repercussion on either side.
- 19) **ARBITRATION**: All disputes or difference whatsoever arising between the parties out of or relating to the contract shall be settled through discussions between the Chairman & Managing Director of UCIL and the Authorised signatory of the contractor. In case an amicable settlement is not arrived at, the matter will be settled through Arbitration by appointment of sole Arbitrator as approved by CMD,UCIL.  
The provisions of The Arbitration & Conciliation Act, 1996, and Rules made there under and/or any statutory modifications or re-enactment thereof for the time being in force shall apply to such arbitration proceedings. The language of the arbitration proceedings shall be English and the place of arbitration proceedings shall be the concerned UCIL unit where the contract is executed .  
For Global tender this clause may be modified by the competent authority on case to case basis.
- 20) **JURISDICTION**: The courts within the local limits of whose jurisdiction the place from which the purchase order is issued is situated only shall, subject to Arbitration Clause, have jurisdiction to deal with and decide any matter arising out of this contract.
- 21) Preference will be given to parties as per Govt. guidelines in vogue.
- 22) **PRICE PREFERENCE FOR MICRO & SMALL INDUSTRIES**:  
a. In tender, participating Micro and Small Enterprises quoting price within price band of L1+15 percent shall also be allowed to supply a portion of requirement by bringing down their price to L1 price in a situation where L1 price is from someone other than a Micro and Small Enterprise and such Micro and Small Enterprise shall be allowed to supply at least 20 percent of total tendered value.  
b. In case of more than one such Micro and Small Enterprise, the supply shall be shared proportionately (to tendered quantity)
- 23) **MSME (SC/ST)**: Supporting documents related to MSME (SC/ST) organization to be submitted along with techno - commercial bid.
- 24) Other Terms & conditions as in "Instructions to Tenderers & General conditions of contract" (enclosed) shall also apply.
- 25) **NOTE**: The eligibility be decided strictly based on documents submitted at the time of receipt of tenders. No additional documents be allowed to be submitted after receipt of tenders but there is no bar to seek clarification or authentication of submitted documents. However in case of poor response, with a view to increase the competition, admission of additional documents to meet the PQC may be allowed subject to the condition that  
a) "Poor response" implies when less than three bids are found suitable on the basis of submitted eligible documents as per NIT.  
b) The additional documents should not be issued subsequent to last date of receipt of tender as mentioned in the NIT.  
c) The bidder submitting additional documents has submitted EMD and tender cost as prescribed in NIT.
- 26) In the event of supply please provide the GST registration details along with invoice and raise the invoice as per the provision of GST Act. Information required under GST are furnished below :-

**Pre-Qualification Criteria :**

1. Capabilities and Manufacturing:

Following documents are required in support of above:

- a) Copy of GST / sales Tax / VAT registration certificate
  - b) Must have the valid forest department license to carry on the timber merchandise.
2. Experience & Past Performance: Bidder should have experience having successfully completed purchase order / Rate contracts for supply of timbers in any of the current / last three financial years. Any P.O. copy / rate contract copy with reputed parties / PSU / PWDs / Railways shall be submitted in support of the above.
3. Transit Permit (TP) issued by the forest department provided along with the supply has to be made in the name of the bidder not in the name of other third parties. A self declaration has to be given for this.
