- i) Experience of having successfully completed SIMILAR WORK during last 07 years ending last day of mont h previous to the one in which applications are invited should be either of the following:
- a) One similar completed works costing not less than the amount equal to Rs. 11,27,950.00/-

Or

- b) Two similar completed works each costing not less than the amount equal to Rs.7,04,969.00/-
- c) Three similar completed works each costing not less than the amount equal to Rs.5,63,975.00/-

"Similar work" means experience in Maintenance Contract for Floor cleaning work OR Machine cleaning works OR House Keeping work of Building Maintenance. The bidder will have to submit copy of the relevant work order / LOI / LOA clearly indicating Work Order Value (in INR) and its completion certificate, from the client, as documentary evidence in support of their experience / credential, failing which offer shall be summarily rejected. The submitted Work Orders / LOI / LOA and Completion Certificate/ Running work shall be either English or Hindi only. Credentials other than English or Hindi language shall not be considered.

- ii) Proof of having Registered Office and workshop located and registered within the home state of the buy er i.e. Jharkhand where the services needed to be provided. - ii. Incorporation Certificate of the firm clearly mentioning office address OR

- v. Udyam/MSME/NSIC/SSI

- iii) Licence/ Labour Registration Certificate should be registered with the State of Jharkhand only.
- iv) GSTIN should be registered with the State of Jharkhand Only.
- v) MSME should be registered with JHARKHAND only within the range of EAST Singhbhum, West Singhbhum, Saraikela and Khareswa Districts.

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
