Only su ch firms need tender who can produce satisfactory evidence that they have the necessary experience & fi nancial resources and organization to undertake such work as per criteria mentioned below.

- i) The Tenderer"s average annual turnover for the work during last 03 years, ending 31st March of the pre vious financial year, should be at least Rs. 0.78 Lakhs in Audited balance sheet & profit & loss account of e ach year must be submitted by the tenderer
