Three similar completed jobs costing not less than 40% of estimated value each/Rs 14.49 lakhs each.

The Tenderer's average annual turnover for the work during last 03 years, ending 31st March of the previous financial year, should be at least 30% of estimated value Rs 10.87 lakhs,

Audited balance sheet & profit & loss account of each year must be submitted by the tenderer.

Similar works means "Repair/maintenance/laying of DI/CI/MS/HDPE pipe line work". Documentary evidence in the form of Certificates with completion date from clients and Work Order copies specifying the work and the amount of contract should be submitted.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
