PQC - 2 (Experience)

- (ii) Institutions having valid CGWA accreditation for preparation of a. Hydro-geological report and/or Modell ing. b. Certificate issued by Accreditation board of CGWA for Hydro-geological report and/or Modelling shall be submitted.
- (iii) The bidder should have experience of having completed similar work during the last seven years ending the last day of month previous to one in which the applications are invited. The bidder must attach completion certificate for each work.

Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
