Only such firms need to tender who can produce satisfactory evidence that they have the necessary experience & financial resources to undertake such work as per criteria mentioned below.

- i) Experience of having successfully completed SIMILAR WORKduring last 07 years ending last day of mont h previous to the one in which applications are invited should be either of the following:
- a) One similar completed works costing not less than the amount equal to Rs.1,20,360.00/-

Or

b) Two similar completed works each costing not less than the amount equal to Rs.75,225.00/-

Or

- c) Three similar completed works each costing not less than the amount equal to Rs.60,180.00/-
- "Similar work" means experience in Fabrication/Repairing work of RIM of underground MachineORRepairin g of Rim of HEMM OR Repairing of Hydraulic Cylinders of Underground machine. The bidder will have to sub mit copy of the relevant work order / LOI / LOA clearly indicating Work Order Value (in INR) and its complet ion certificate, from the client, as documentary evidence in support of their experience / credential, failing which offer shall be summarily rejected. The submitted Work Orders / LOI / LOA and Completion Certificate shall be eitherin English or Hindi only. Credentials other than English or Hindi language shall not be considered.
- ii) The tenderer's average annual turnover during last 03 years, ending 31st March of the previous financia I year i.e. 2021-22 should be at least Rs.45,135.00/-.Annual Report containing Profit & Loss account and B alance sheet along with ITR duly audited by CA/Cost Accountant for last 3 FYs must be submitted.
- ii) Geographical Presence: Proof of having Registered Office and workshop located and registered within the home state of the buyer i.e. Jharkhand where the services needed to be provided. Documentary evidence must be provided in the form of Municipality trade license or other such documents as per the following which satisfies as a proof of having the office establishment.
- i. Trade License issued by the local authority in the name of the FirmOR
- ii. Incorporation Certificate of the firm clearly mentioning office address OR
- iii. Electricity bill for last one year in the name of the Firm OR
- iv. GSTIN registration OR
- v. Udyam/MSME/NSIC/SSI

Scope of Work

- 1. Work will be carried out at Contractors work shop, outside the UCIL Premises.
- 2. Transportation/ Handling of Parts (to and fro), Loading & Unloading for Fabrication/ Repairing work will be in Contractors Scope, and no extra charges will be paid for the same.
- 3. Dismantling, Remetalling, Turning, Machining and Fabrication etc work has to be done as required at contractor's site.
- 4. Drilling, Tapping, Boring work, Fabrication work, locking arrangement required, is to be done as per requirement.
- 5. Finally Painting work with 2 coats of Red Oxide and then with 2 coats of Black Color to be done.
- 6. Frequent visit will be done by Engineer in-charge or his representative for inspection of the work.
- 7. Sample for Rim may be given with Gate Pass, as per availability, and the same has to be returned after completion of the work.
- 8. The work has to be completed within 90 days, after which penalty clause will be applied as per mention ed in Clause No 11 Penalty (Liquidated Damage) of Page-10.

Any clause(s) incorporated by the Buyer regarding following shall be treated as null and void and would not be considered as part of bid:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.

- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process.
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

This Bid is governed by the <u>General Terms and Conditions/सामान्य नियम और शर्त</u>, conditions stipulated in Bid and <u>Service Level Agreement</u> specific to this Service as provided in the Marketplace. However in case if any condition specified in General Terms and Conditions/सामान्य नियम और शर्ते is contradicted by the conditions stipulated in Service Level Agreement, then it will over ride the conditions in the General Terms and Conditions.
