OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract.  - a) Copy of work order of similar work in any Central / State Govt. Organization / PSU / Pu blic Listed Company clearly mentioning nature of work/ Service, various components/ It ems, period and value.
 - b) Copy of completion/ execution/ client certificate issued by end user/ owner clearly me ntioning reference to relevant work order, actual value of executed work and actual dat e of completion.

Note: - The work experience of the bidder for those works only shall be considered for evaluation purpose, which is completed before the last day of month previous to the one in which application s are invited. Hence, the works which are incomplete/ ongoing, as on the last date of the month pr evious to the one in which applications are invited, shall not be considered against eligibility.

In case the work is started prior to the eligibility period of 7 (SEVEN) years (counted backwards st arting from the last date of the month previous to the one in which applications are invited and co mpleted within the said eligibility period of 7 years, then the year of experience of the work within the said eligibility period shall be only considered against the eligibility. For calculating the eligibili ty criteria in such a case the value of work shall be taken on pro-rata basis.

- 4. **DOCUMENTARY EVIDENCE IN SUPPORT OF TURNOVER CRITERIA: -** In support of the cl aim of meeting this turnover criterion, bidder must submit following documentary proof :

Note: - If the bidder doesn't submit the P&L Statement/ Chartered Accountant Statement for T urnover for all the three years given above, and asking for the non-submitted P&L Statement/ Chartered Accountant Statement for Turnover does't fall under the conditions of para 7.3.5 on (Clarification of Bids/ Shortfall Documents) of the Manual for Procurement of Goods 2017 issue d by Ministry of Finance, department of Expenditure, in that situation the turnover shall be tak en as zero for the years for which the P&L Statement/ Chartered Accountant Statement has not been submitted by the bidder and average shall be calculated based on the submitted P&L Statements/ Chartered Accountant Statement Statement for calculating the eligibility.

5. **FINANCIAL STANDING:** Bidder must have been an income-tax assesses, and bidder has file d at least its one (01) income-tax return during the last three years ending on 31st March of th

e previous financial year [e.g. FY 2022-23 (AY 2023-24), 2021-22 (AY 2022-23), FY 2020-21 (A Y 2021-22),]. Documents/ Documentary evidence of filled ITRs to be provided by participating bidder to qualify/ meet the financial requirements of tender document.

6. **VALID HT WORKING LICENSE:** - A person having HT licence issued by any State Governme nt or Union Territory administration shall not require licence from other State Government in w hich the works are to be executed.

Any bid not complying PQC requirements may get rejected.
