The bidder should have experience of having successfully completed similar works during I ast 07 years last day of month previous to the one in which applications are invited should be either of the following:

- a. One similar work costing not less than Rs. 31.08 Lakhs.
- b. Two similar works each costing not less than Rs. 19.43 Lakhs.
- c. Three similar works each costing not less than Rs. 15.54 Lakhs.

<u>Similar Work means having experience in "Supply of Manpower for Mechanical Works/ Auto Electrical Works of repairing and maintenance of diesel vehicles and equipment's".</u>
