The Tenderer's average annual turnover for the work during last 03 years, ending 31st March of the previous financial year, should be at least 30% of estimated value Rs 6.37 lakhs, Audited balance sheet & profit & loss account of each year must be submitted by the tenderer.

Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
