The followings are the Eligibility criteria for this Non-divisible service Contract. The bidder may visit the proposed work site to get well acquaint about the site work before filling the rate/submit the tender.

1. PAST PERFORMANCE CRITERIA:

Bidder shall have successfully completed similar works to any Central / State Govt. Organization / PSU/ Pub lic Listed Company in last SEVEN (07) years ending on last date of the previous month in which BID issued as per any one of following:

I. Three(3) similar completed works costing not less than the amount equal to Rs.55.99 Lakh (40% of the es timated cost= Rs.1,39,99,708.70).

- 3. The outsourcing of diverse categories of labour on a supply-basis is the scope of work under this specifi cation, which is merely descriptive and not exhaustive. Any additional work or services judged necessary for the contract's successful execution, including those that improve the plant and equipment's dependa bility, efficiency, and availability, are supposed to be included in the scope of work. The Contractor will p erform a variety of tasks and provide a range of services, including but not limited to:
- 4. Variety of workers are needed, including mechanics, pipe fitters, assistant mechanics, assistant fitters, r iggers, helpers, welders with gas cutting capabilities, assistant welders, and others who have experience operating material handling plants and processing plants that contain rotating equipment like conveyor belts, crushers, screens, agitators, gearboxes, pumps, compressors, boilers, exhaust fans, pipe lines, an d valves. The Turner/Machinist must have practical experience using a lathe, shaping machine, slotting machine, drill machine, power hacksaw, and accuracy on machining work. They required being compete nt to use verniercalipers, micrometres, and other measuring instruments. According to the Engineer-instructions, Charge's provided labour must perform the required duties wherever and at any time within the Jaduguda Process Plant.
- 5. Carrying out the operation executing /routine /preventive /breakdown Conveyor belts, crushers, screens , agitators, gearboxes, pumps, compressors, boilers, exhaust fans, pipe lines, valves, and other mechanical equipment installed in the mill require skilled, semiskilled, and unskilled mechanical labour, such as fitters, machinists, turners, welders, riggers, and helpers (providing minimum wages, PF, ESI, bonus, and other benefits as necessary)). The contractor is required to coordinate the work at the mill site, provide the appropriate tools and tackles, a welding machine, and safety equipment.
- 6. The contractor is responsible for giving their staff the necessary tools, including tackles, safety equipm ent, and ensuring their use while working on the job site.

- 7. Facilities to be provided to the Contractor by UCIL as mentioned below:
 - I. Lubricants, gaskets, gland packing, bolts, nuts, electrodes, , gas cutting sets, consumables, pipes & pipe fittings and all spares shall be supplied by UCIL free of cost.
 - II. Space will be provided to the contractor for constructing site office, store etc of their own. Electri c power supply (415 Volts) may also be provided
 - III. Water and electricity shall be provided free of cost.
- 8. Tools &Tackles and Safety Appliances to be arranged by contractor: The contractor will submit detail lis t of equipment to be brought by them for executing this job. They should bring in at least following item s before commencing work:
 - a. Spanners of all sizes for each fitter / rigger 24 sets
 - b. Safety appliances like gumboot/ safety shoes, helmet 50 sets
 - c. Rope pulleys 6 nos
 - d. Nylon Rope 200 mtrs of 1 inch size and 200 mtrs of ½ inch sizes
 - e. Wire rope slings (upto25 mm dia x 3mtr long) 10 nos. each of different sizes
 - f. Straight grinder 2 nos
 - g. Angle Grinder- 2nos
 - h. Portable hand drilling machine 2 nos
 - i. Welding accessories like screen, goggle, hand gloves, chipping hammer, lighter etc. for Every welders/Cutter- 12 sets
 - j. Safety belt- 10nos
 - k. Safety goggles- 38 nos
 - I. First aid kit- 3 sets
 - m. Hand Gloves 50 Nos.
 - n. Welding Machine of 440 Volts 3 no.

Besides above items the contractor shall bring in all other tools and tackles as per their requirement in the Job.Contractor shall have to bring in all safety PPE (Personal Protective Equipment) for safe working at Site.

- 9. REMOVAL OF WORKMEN: The Contractor shall employ in and about the execution of the works such pers ons as are skilled and experienced in their several trades and Engineer-in-Charge shall be at liberty to o bject to and require the Contractor or to remove from the works who in the opinion of the Engineer-in-Charge misconducts himself or is incompetent or negligent in the proper performance of his duties and such person shall not be again employed upon the works without permission of the Engineer-in-charge.
- 10. If any urgent work (in respect whereof the decision of the Engineer-in-Charge shall be final and binding) becomes necessary and the Contractor unable or unwilling at once to carry it out, the Engineer-in-Charg e may by his own or other work people carry it out as he may consider necessary. If the urgent work wer

e such as the Contractor is liable under the Contract to carry out at his expense, all expenses incurred on it by the Corporation shall be recoverable from the Contractor and be adjusted or set off against any sum payable to him.

- 11. The contractor will have to give name, father's name, age, qualification detail address of all workmen, t echnicians, supervisors to be engaged along with recent passport size photograph duly attested within7 (seven) days before actual commencement of work so that permanent gate pass can be issued.
- 12. Safety & security of UCIL' materials: Tenderer will be responsible for safe keeping of materials issued by UCILon free of cost / chargeable basis and on completion of work or during the course of work all materials issued to the Tenderer should be accounted for.
- 13. Inspection of tools and tackles: Time to time the engineer-in-charge shall inspect the tools and tackles of the contractor. If he finds any tools and tackles that is not in proper shape or that may lead to safety hazard, the contractor will have to take the defective tool out of the plant premises. If the contractor can not arrange the saidtool within 7 (seven) days UCIL may provide the same on chargeable basis.
- 14. The bidder must guarantee that the necessary numbers of people in the various categories are regularly available.
- 15. According to the instructions of the engineer-in-charge, his agent, or the site-in-charge, the contractor w ill be required to hire personnel from various categories for a total of 8 (eight) working hours of general s hift and/or shift maintenance duty.
- 16. The contractor must handle breakdown jobs when they become necessary after 8 (eight) working hours. The job will have to be done continually until it is finished, per the instructions of the engineer-in-charge, depending on the state of the plant at the moment.
- 17. The scope of the contractor's work must include job coordination and supervision. The engineer-in-charg e or his representative may request a copy of your supervisor's daily output/work log for each technician when necessary.
- 18. UCIL will not provide any accommodation for your staff / labours deployed at site.
- 19. Commencement of work by the Contractor can be affected before execution of agreement but after issu e of work order / letter of intent and fulfilling of statutory requirements of Insurance by the contractor.
- 20. Working under this contract will not qualify or give any additional claim to any contract employee for e mployment in UCIL. All statutory rules and regulations applicable as per workmen's Compensation Act sh all be followed by the contractor while engaging and disengaging the Workers / Employees.
- 21. The contractor has to tackle all labour related issues and maintain smooth IR relation at site so that the job can progress uninterruptedly.
- 22. Training: Contractor shall have to bring all their labours for necessary training in Mill Training Centre bef

ore actual commencement of the work. The work shall be carried out with the help of experienced / skille d persons or ITI with NCTVT certificate holders or equivalents, etc. and supervisor having Supervisory Cer tificate of Competency is to be engaged for supervision or as per direction of the Engineer-in-charge.

- 23. Manpower details: The contractor shall submit the bio data of the persons to be employed for this work within two days of award of work. Eligibility criteria of different categories have been furnished in the NIT . The contractor will be allowed to start the work only after submission of the details / bio data. Performa of Attestation Forms (02nos.) may be obtained from site office, Mill for necessary verification of every la bourer separately and submission to the Engineer-in-charge, UCIL for onward transmission to the compet ent authority, UCIL.
- 24. Safety Rules & Regulations for contractor's employees:-UCIL's Safety Rules & Regulations for contractor 's employees will be complied strictly during the execution of various works at site. Contractor has to foll ow the Safety Rules & Regulations as per Indian Electricity Rules to do the electrical works. UCIL shall no t provide any safety appliances and tools & tackles under any circumstances. Contractor shall ensure the use of safety appliances during the work at site. Contractor will take full safety measures and arrange the necessary safety gadgets / appliances, tools & tackles, helmet, gumboot, safety belt, shockproof shoe, safety suit / uniform, goggles, gloves, apron, safety net, nose guard, ladders, trolley, wheel borrow etc. at their own expense approved by the Safety Officer (Mill), UCIL so as to ensure that no damage, loss or injury to corporation's personnel, contractors' personnel, third party or equipment are caused due to the work being carried out by contractor.

UCIL shall provide all necessary safety appliances on chargeable basis to the contractors if they will not provide to their workers for safe execution of work, if found so necessary. Contractor must report in writing (duplicate) to the Engineer-In charge or Safety Officer (Mill)-UCIL immediately on becoming aware of any accident at their site. Safety Officer (Mill) will be the competent authority to stop the work or remove the persons from job, if contractor fails to provide personal protective equipments before the commencement of work at their own cost during work execution period.

- 25. Site Investigation: The Tenderers are advised to visit the site to acquaint themselves as to the nature an d location of the work, the general and local conditions particularly those bearing upon transportation, di sposal handling and storage of materials, availability of labour, water or similar physical conditions of the site.
- 26. All work shall, unless specified otherwise, confirmed to the latest revision of relevant IS/CPWD specificat ions and codes of practice. In case of any particular aspect not specifically covered the standards, the st andard practice as may be specified by Engineer shall be final & binding.
- 27. Medical Care: The contractor shall be fully responsible for any first aid and emergency medical treatme nt to his employees. Necessary arrangement for this purpose shall be made by the contractor at the site . In serious cases medical facilities of UCIL may be available on chargeable basis.
- 28. In case, the Contractor fails to make payment of wages and deposit of PF contribution within the prescri bed period or makes short payment of wages / short deposit of PF contribution, it shall be treated as FAI LURE and action as per the provisions of General Conditions of Contract shall be taken. Further, UCIL as Principal Employer will make payment of wages in full or the unpaid balance due, as the case may be, to the resource(s) deployed by the Contractor and deposit the PF contribution with PF authorities. Such am ounts will be recovered from the Contractor either by deduction from any amount payable to the Contractor under any contract or as a debt payable by the Contractor.
- 29. After being isolated from any other systems, UCIL will issue a work permit to allow for the start of work. However, before work begins, the contractor or his site supervisor must make sure that the equipment is isolated as needed for safe operation.

- 30. The site supervisor for the bidder shall ensure that all technological trash, including steel and iron fragm ents, other foreign materials debris, etc., produced during maintenance tasks by the supplied labour is completely removed from the designated location.
- 31. The scope of activity shall include liaison with the CISF for issuance of essential gate passes to contract workers. After the legislative requirement has been met, UCIL will only submit the documentation for the issuance of a gate pass. Daily attendance will be manually validated. According to the mutually agreed-u pon performa, the Contractor is required to keep attendance records for all employees provided and to c ertify those records daily with the Engineer-in-Charge.
- 32. In accordance with the act and rules, the contractor must follow by all legal requirements pertaining to t he health, welfare, and safety of any individuals he employs. Additionally, the contractor is in charge of t he hired staff's medical care. Ex-gratia/bonus leave salaries, retrenchment benefits, etc. under statutory levies must be paid by the contractor to his staff at his own expense in accordance with the bonus legisl ation and other restrictions. In this regard, UCIL shall not make any more payments.
- 33. The contractor must keep records of the following information: a) Records of medical examinations of th eir employees before joining; b) Records of initial training before engagement to job; c) Records of contractor workers mentioning their category of employment, age, father's name, address, d) contact information, photos, information for police verification, ID documentation, etc. Records of providing PPE to contract workers are listed respectively. g) Documents proving that contract workers have no right to employ ment with UCIL, which were made on non-judicial paper costing Rs. 20 and fully attested by a Notary Public.
- 34. Adequate precautions should be made to protect the safety and security of employees who are on the j ob. When a worker or another individual who is directly or indirectly involved in the work is injured, the c ontractor is required to pay for their medical bills and other expenses. In this regard, UCIL shall be held c ompletely free from liability and indemnified in full. In order to adequately protect the workers they empl oy against danger of accident, the contractor must get an adequate insurance policy at their own expense. The contractor is responsible for ensuring that all technicians, skilled workers, and semi-skilled personnel are competent and capable of working independently.
- 35. Working heights might range up to 20 metres above the ground depending on the location. In some circ umstances, replacement employment may need to be coordinated with the plant's working or operation in order to avoid impeding production.
- 36. In some circumstances, the contractor may be asked to provide more staff on Sundays, holidays, or aro und-the-clock if UCIL deems it necessary. In such situations, no additional rate claim will be taken into consideration. Only the actual number of workers supplied will be documented.
- 37. Variation in Quantity of items:-The quantity mentioned under the "schedule of item (s) and quantities" of this tender is tentative. The actual quantity may vary from that indicated in the tender document due to actual conditions of the site or due to other reasons. The contractor shall carry out all additional work up to the total variation of +10 % of the awarded value. The other terms & conditions and rate (s) shall remain firm within this limit.
- 38. Safety appliances (PPE) shall be reimbursed to the contractor @1.5% of Cumulative Costper day per res ources as per actual attendance + GST @18% on submission of proof of supply to UCIL as per requireme nt mentioned in the bid document. The contractor shall have to supply all protective safety equipment like helmets, Safety shoes, hand gloves, safety belts etc. to his workmen at his cost as required by operat

ions. In case the contractor fail to provide the same shall be provided at his risk & cost within one month of work order acceptance, the same amount shall be deducted from the bill.

- 39. Tools & Tackles reimburse shall be reimbursed to the contractor @1% of Cumulative Cost per day per re sources as per actual attendance + GST @18% on submission of proof of supply to UCIL as per requireme nt mentioned in the bid document.
- 40. Extra Manpower duty/overtime duty for emergency Mill Shut Down/Breakdown Job During Mill Shut do wn/ Breakdown, Contractor may have to arrange extra manpower duty to ensure timely completion of jo b in scheduled time. Manpower may have to perform continuous duty/overtime duty (may be above 8 H our) for schedule liner change job/any preventive/breakdown maintenance job so as to ensure reduce s toppage of mill /plant to have optimum mill output as per requirement. Contractor may have to arrange extra manpower for maintenance during mill shut down/breakdown than our average arrange manpower as per requirement and as per instruction of engineer in Charge. For the extra manpower duty/ overtime duty, UCIL shall reimburse payment of manpower including GST and Service Charge @3.85% to contract or as per actual attendance of manpower after certification of job/manpower by engineer in charge and c ompletion of job successfully.

41. PENALTY:

A. The contractor shall maintain per day average attendance of workman as per no. of resources me ntioned in the bid document in every running month. Failure to maintain the attendance of t he workman imposition of penalty shall be as follows;

- a. No Penalty shall be deducted from monthly bill when 100% and greater or equal to 90% of ave rage attendance is maintained.
- b. 2% shall be deducted from monthly running bill when less than 90% and greater or equal to 7 5% of average attendance is maintained.
- c. 5% shall be deducted from monthly running bill when less than 75% and greater or equal to 6 0% of average attendance is maintained.
- d. 10% shall be deducted from monthly running bill when less than 60% of average attendance is maintained.
- B. Contractor must have to pay minimum wedges, PF, Bonus @8.33 % and other statutory payments to all employee monthly as per duty performed by employee and Monthly payment of all employee shall be paid (as per attendance) before 1 0th day of next coming months, if payment is not done on or before 10th day of next month to all employee then penalty shall be imposed as mentioned below.
- B) Every 0.2 % of RA bill value penalty for every one day delay of Monthly payment of any employee than 10 th day of next months Maximum upto the total penalty of Maximum 8 % of RA bill value submitted during every months period duration.

Contractor has to declare date of monthly payment of every employee in writing after monthly payment of wages to his employees in every month to ensure timely payment of employee as per labor law.

A. ESCALATION/ DE-ESCALATION:

1.1 **LABOUR COST:** The Corporation will pay monthly cost with an increase/ decrease in the monthly payable amount during the contractual period, in the event of increase/ decrease in relating to variation in

prevailing min. wages for avoiding unnecessary contingency in rate due to any changes in the minimum wages as per the Applicable Laws during the Contract period.

In case of any changes in the minimum wages as per the Applicable Laws during the Contract period, Buyer shall pay the Service Provider the difference in wage from the amount mentione d in the contract on pro rata basis.

Prevailing statutory minimum wages BASIC + VDA + overtime wages as per Factory Act rule & Minimum w ages Act + other statutory Compliances towards Social Security contributions + minimum Bonus (Under S ec.10) on pro-rata basis is to be disbursed to the deployed labour and to statutory authorities by the contr actor on monthly basis through an E-Payment mode and through a separate Challan to statutory authoritie s. Wages and other statutory Compliance's contributions shall be disbursed based on actual attendance at UCIL duty.

Reimbursement of actual disbursement of wages and other statutory compliances contributions from the a mount mentioned in the contract as per base date of min. wages will be done by UCIL to the contractor in subsequent month on submission acquaintance against disbursement of wages in the deployed labour ban k account duly signed by the deployed labour along with copy of cheque / e-payment details/ bank's state ment and through a separate Challan to statutory authorities.

In case of change in statutory wages and rates of other statutory Compliances contributions then it will be reimbursed to the contractor on actual disbursement of wages to the beneficiary and statutory authorities on submission of proof of payment to UCIL.

- **1.2 GST COST TO TOTAL TRANSACTION:**The UCIL shall pay on reimbursement basis to the total a pplicable GST @ prevailing rate as per GST rule on total transaction value (i.e. price actually paid to the se rvice provider) the amount mentioned in the contract rate. GST on penalty, interest, non-related expenses and applicable GST on forfeiture of SD/ retention money/ EMD etc. shall not payable.
- B. PENALTY/RECOVERY(S) IN THE EVENT OF FAILURE(S) BY THE SERVICE PROVIDER

As per service level Agreement (SLA) & as mentioned in SCC. In case of payment of wages to all labour is not made on or before 7th of succeeding month, failing which necessary action will be taken as deemed fit. Also, the decision of the Engineer-in-charge shall be final and binding on the parties. Should it appear to the Engineer-in-charge that the contractor(s) is/ are not properly observing and complying with the pro visions of the Contractor's Labour Regulations and Model Rules and the provisions of the Contract Labour (Regulation and Abolition) Act 1970, and the Contract Labour (R & A) Central Rules 1971, for the protection of work-people employed by the contractor(s) (hereinafter referred as "the said Rules") the Engineer-in-charge shall have power to give notice in writing to the contractor(s) requiring that the said Rules be complied with and the amenities prescribed therein be provided to the work-people within a reasonable time to be specified in the notice. If the contractor(s) shall fail within the period specified in the notice to comply with and/observe the said Rules and to provide the amenities to the work-people as aforesaid, the Engineer-in-charge shall have the power to provide the amenities hereinbefore mentioned at the cost of the contractor(s). After which the contractor will be served a notice failing which the contract will be terminated and the performance guarantee will be forfeited and the contractor will be black listed.

C. BILLING AND PAYMENT:

I. Contractors shall submit bills duly certified by designated officers of UCIL in respect of the se rvice (vehicle wise) rendered by him in duplicate on monthly basis to the Corporation (not in pi ece meal), in the prescribed Performa duly verified and certified by the user. The bills shall sho w date wise services rendered as per as per the deployed labour attendance log. Contractor is

required to submit the bills within 15 days of the following month, duly filled in all respect to the Engineer-in-Charge or his authorized person. The complete in all respects will be processed and paid within 15 days from the date of receipt by the concerned Account Section.

- II. Payment will be released for the correctly made bills normally within 30 working days from t he date of submission of bills duly certified by EIC. The Corporation shall not pay any interest f or any delayed processing of the bills.
- III. No interest shall be payable on withheld amounts.
- IV. Recovery of Income Tax applicable as per Income Tax Act from the bills.
- D. PAYING AUTHORITY: (A/c) UCIL, Jaduguda shall be the paying authority.
 - I. Startup Bidder is required to submit the documents(s) mentioning the specific goods/ job dom ains wherein they are registered for, including the application submitted to DIPP, Further, above documents(s) should be certified by the Chartered Accountant (not being an employee or a Director or not having any interest in the bidder's company/firm) and notary public with legible stamp.
 - II. All other provisions and conditions which have not been touched by SCC shall remain applicable as per GTC & SLA.

4. Buyer Added Bid Specific SLA

Text Clause(s)

SPECIAL CONDITIONS OF CONTRACT- SCOC

1. Prices:

Unless otherwise agreed to specifically in order, the price payable by UCIL to the contractor under the order shall remain firm throughout the period of contract and shall not be subject to any escalation.

If the works are provided by the contractor in accordance with this contract, Corporation will pay the contractor the price (awarded value); and reimburse the contractor for the approved expenses (as specified in the order/ contract), after the approved expenses have been incurred by the contractor. Corporation will not be liable to reimburse the contractor for expenses other than approved expenses, unless Corporation's prior approved written consent.

Bidders have to quote rate on GeM portal including GST applicable as on bid due date. The Contract Sum is the "price inclusive GST", i.e. inclusive of GST of quoted value and all taxe s & duties and all other statutory levies applicable, including costs and expenses which may be required in and for the supply, scope of work and completion of the work described, together with all general risks, liabilities and obligations set forth or implied in the docume nt upon which the tender is based.

The reimbursable costs as mentioned in the tender document shall be inclusive of GST, will be in extra on submission of valid required documents &valid tax invoices as per prevailing rate of GST payable in accordance with GST Act at the time of submission of invoices subjected to any additions or deductions due to variation under adjustment/ quantities clause and statutory variation/ imposition/ abolishment of taxes and duties, if applicable & pursuant to the contract.

2. Earnest Money Deposit (EMD) / Bid Security: -

Earnest Money *Deposit (EMD)/ Bid Security* shall be deposited by way of **demand draft (DD)** drawn in favor of "**URANIUM CORPORATION OF INDIA LIMITED**" payable at **JADUGUDA**Branch of State Bank of India [Jaduguda Branch Code no 0227]. **E.M.D. shall not bear any interest.**

The offers received from tenderers without EMD and/or tender cost shall be summarily rejected except where exemption is provided in the tender.

Earnest Money Deposit may be converted and adjusted into Security Deposit in the case of successful tenderer. The earnest money of unsuccessful tenderers will be refunded on written request (in duplicate) to the Engineer-In-charge after commencement of work under this contract.

The EMD / Bid Security will be forfeited and is liable to GST at applicable rate, if

- (i). The Tenderer modifies or withdraws his offer after due date and time of submission of the bid.
- (ii). The Tenderer resile from his offer during the validity period.
- (iii). The tender is revoked during its validity period by the Tenderer or any other breach of the bid.
- (iv). The Tenderer increases the prices unilaterally after the opening of Part I (techno-commercial) a nd during the validity period of the tender.
- (v). Subsequent to acceptance of the Letter of Award of Contract by the successful Tenderer, the T enderer refuses to enter into Contract Agreement within the specified time or its authorized extensions.
- (vi). The successful Tenderer fails to submit the Performance Guarantee (Security Deposit) within the period specified, if applicable.
- (vii). The Tenderer does not accept the correction of the Bid Price, by submission of updated bid.

The EMD/ Bid Security of the successful Tenderer to whom the contract is awarded will be r eturned or adjusted into Security Deposit (SD) after the said Tenderer provides the Contract Performance Guarantee/ Security Deposit (SD) and signs the Contract Agreement.

If the successful Tenderer fails to submit Contract Performance Guarantee/ Security Deposi t (SD)as specified within 30 (thirty) days after the date of issue of Letter of Award of Contract, or fails to sign the contract agreement then the EMD/ Bid Security amount will be forfeit ed by the Corporation, without any notice or proof of damages etc.

3. Validity of Tender: -

Bids shall be kept valid for period specified in GeM Portal from the final Due date of submis sion of bid'. A Bid valid for a shorter period may be rejected by UCIL as 'nonresponsive'. The Tenderers shall not be allowed to increase, amend or withdraw his tender within this period and if he do es so the earnest money deposit and security deposit may be forfeited.

If required, the Corporation may request the Tenderer to extend the "bid validity period". The request a nd responses thereto shall be made in writing or through GeM portal, if a tenderer accepts to extend the period of validity of bid. The tenderer accepting such request shall not modify their bid on their own. A Tenderer may refuse the request to extend the bid validity period without forfeiture of his EMD.

4. Deviation: -

ZERO DEVIATION: Deviation to terms and conditions of "Bidding Documents" may lead to rejection of bid. UCIL will accept bids based on terms & conditions of "Bidding Documents" only. Bidder may note UCIL will determine the substantial responsiveness of each bid to the Bidding Documents. For purpose of this, a substantially responsive bid is one which conforms to all terms and conditions of the Bidding Documents without deviations or reservations. UCIL's determination of a bid's responsiveness is based on the content of the bid itself without recourse to extrinsic evidence. UCIL reserves the right to raise technical and/or commercial query(s), if required, may be raised on the bidder(s). The response(s) to the same shall be in writing, and no change in the price(s) or substance of the bids shall be sought, offered or per mitted. The substance of the bid includes but not limited to prices,

5. Award of Contract:-

The Corporation will award the Contract to the successful Tenderer, whose bid/updated bid has been de termined to be substantially responsive and to be the lowest evaluated bid, provided that the Tenderer is determined to be qualified to perform the Contract satisfactorily.

6. Privilege Clause:

The Corporation reserves the right to accept or reject any Tender, and to cancel the Tender process and reject all Tenders, at any time prior to the award of Contract, without thereby incurring any liability to the affected Tenderer or Tenderers or any obligation to inform the affected Tenderer or Tenderers of the grounds for the Corporation's action..

7. SECURITY DEPOSIT (SD):

Total amount of Security deposit (SD) shall be limited to 10% of the awarded value of work. Fifty percen t (50%) of this amount (i.e. 5% of the awarded value of work) shall have to be deposited as initial security deposit at the time of execution of agreement including the amount deposited as Earnest Money.

- a) Acceptable mode of payment of Initial Security Deposit/ Earnest Money:
- (i). For deposit upto Rs. 5,000/- : Demand Draft payable at SBI, Jaduguda/ Hartopa.
- (ii). For deposit beyond Rs. 5,000/- and up to Rs. 1.00 Lakh.: DAC/TDR/FDR etc. from any Schedule Bank s duly pledged in favour of UCIL. But in case of Earnest Money of amount more than Rs. 50,000/-, the Te nd

erer should submit Bank Guarantee issued by Nationalized bank as mentioned in Para 9(a) (iii).

(iii). For deposit beyond Rs. 1.00 Lakhs: Bank Guarantee issued by Scheduled bank of jointly, severally bound with the Contractor to the purchaser for the amount same above. The terms of the said guarante e shall be such as shall be approved by the purchaser and the obtaining of such guarantee and the cost of guarantee to be so entered shall be at the expenses, in all respects, of the Contractor. The said guarantee sha

Il be valid till the expiry of the defect liability period and issue of the final certificate by the Engineer, an d with a claim period of Six months beyond it's required validity.

- (iv). In addition to the above, Running Account bills by way of percentage deductions. Such percentage deduction of retention money shall be @ 5 % of the running account bills till the full amount of s ecurity deposit is realized/ retained by the Corporation.
- b) All compensation or other sums of money payable by the Contractor under the terms of this contact or any other contact or any other account whatsoever may be deducted from or paid by sale of a sufficient

part of his security deposit or from the interest arising there from or from any sums which may be due or become due to the Contractor by the Corporation or any account whatsoever and in the event of his security deposit be reduced by reason of any such deduction or sale as aforesaid, the Contractor shall within fourteen days of receipt of notice of demand from the Engineer-in-charge make good the deficit.

c) REFUND OF SECURITY DEPOSIT:

Initial Security Deposit shall be refunded as per EIC/ OIC recommendation to the Contractor on due and satisfactory performance of contract and after completion of all compliance by the contractor towards c ondition & other related clauses as stipulated in tender documents & work order. The remaining portion of the security deposit shall be refunded to contractor on expiry of the Defects

liability period for guarantee/warranty/ performance guarantee & other related clauses as stipulated in the purchase/work order or after payment of the final bill payable whichever is later and on receipt of "n o dues

certificate" from EIC/ OIC, provided if the contractor is not liable to pay any money to UCIL under any ot her contract.

8. FORFEITURE OF SD:

The SD shall stand forfeited in favour of UCIL, without any further notice to the contractor in the following circumstances:

- o In case of any failure whatsoever on the part of the contractor at any time during perfor mance of his part of the contract including the extended periods of contract, where n otice is given and time for rectification allowed.
- o If the contractor indulges at any time in any subletting/ sub-contracting of any portion

of the work without approval of UCIL.

9. Contract Agreement:-

Contract Agreement should be executed in prescribed format on a non-judicial stamped paper within 3 0 (thirty) *days* from the date of issue of work order / L.O.I. However, no payment will be made without e xecution of contract agreement.

Within 30 days of issue of LOI, the successful Tenderer shall sign and date the contract and return it to the Corporation. Till the contract is signed, the LOI issued to the successful Tenderer shall remain binding amongst the two parties.

In the event of failure on the part of the successful Tenderer to sign the contract within the period specified above or any other time period specified by Corporation, UCIL reserves the right to terminate the L OI issued to the successful Tenderer and invokes the Bid Security or the Performance Security if submitt ed by the successful Tenderer/ action as per declaration for Bid Security.

10. Payment Terms:

Payment will be released after satisfactory completion of the work or event (in case of continuous supply of services) in all respect and certification by the Engineer In charge, UCIL within 30 days of <u>submission of tax invoices(s)</u> in original + duplicate 2 (two) copies as prescribed under rule 1 of invoices rules. Contractor shall issue tax invoice (s) after the provision of service within 30 days from the date of certification of work or event, & also mention work order no., date as well as name of work and actual date of commencement of work or event, showing the description, value, tax charges thereon and such other particulars as prescribed as per GST Act, 2017 invoice rule in their every invoice(s). Final bill will be released only after submission of Labour Report / Annual Return (in prescribed format) (in the month of January & after completion of whole work) and work completion (after completion of all obligations under the contract) letter in duplicate by the contractor.

11. <u>Tax & Duties:</u> -

The Contractor shall:

- (a) Pay and indemnify the Corporation against all taxes, duties, goods and services tax and duties, charges, ta xes payable in connection with the carrying out of Work under Contract; and
- **(b)** Provide all security required under any statutory requirement as security for the payment of any duties, ch arges, and taxes.

12. INCOME TAX & STATUTORY LEVIES:

Income Tax at the prevailing rate as applicable from time-to-time shall be deducted from CONTRACTOR's bills as per Income Tax and quoted rates shall be deemed to include this. As regards the Income Tax, surcharge on Income Tax or any other Corporate Tax or Statutory levy payable by the Tenderer for reason of the Contract awarded, then Corporation shall not bear any tax liability whatsoever, irrespective of the mode of construction of contract. The Tenderer both Indian and/or foreign shall be liable and re sponsible for payment of such tax, if attracted under the provision of Law of Land.

13. Insurance:-

The contractor shall ensure & maintain insurance against his liability for accident or injury to workmen or machineries used for the work and shall submit 2 (two) copies of the policy & receipt (s) of premiums paid or satisfactory evidence of insurance coverage at their own cost valid for whole contract period at a time for all the persons to be engaged to the Engineer-In -charge, UCIL before the commencement of work. Contractor shall also submit the proof of renewal of the same policy at least 2 (two) days before the expiry date of the previous policy to the Engineer-In-charge, UCIL. The contractor will not be allowed to carry out any activity without necessary insurance coverage (mentioning working height depend upon the job requirements and as per insurance rules) of their persons. Insurance policy shall also indemnify UCIL against any claim raised by the injured / affected workmen or his family.

14. Indemnity: -

Contractor will fully indemnify the corporation against all responsibility, any costs or expenses (includin g legal costs on an indemnity basis) and Claims of contractor's workmen in respect of personal injury or death or loss of, or damage to or interference with, any other property (whether real or personal), third party or to corporations' personnel and properties. Contractor shall abide by all the necessary pro visions of various other Labour Laws/Acts viz. ESI/Bonus, Workmen's Compensation, EPF and any other laws and rules applicable, in this regard. If on account of non-compliance with the provisions of any laws, Corporation is called upon to make any payment to or in respect of his employees, the service provider shall fully reimburse to Corporation for all such paym

ent and Corporation shall be free to make deductions on this account from the amount of P erformance Security Deposit and retention money.

15. Penalty (Liquidated Damage): -

- (a) Liquidated Damages (LD) shall be levied where reasons are attributable to supplier / contractors f or delays in execution of purchase order/ contract. LD shall be levied @0.5% per week or part the reof on the value of unfinished supply/work order for each week of delay subject to a maximum of 5% of the total value of contract (excluding Taxes and Duties). LD is liable to GST at applicable ra te.
- **(b)** For the portion of delay which is attributable to UCIL / force majeure or to the supplier / contractor , the case shall be dealt with as follows :

(i) Delay attributable to UCIL / Force majeure:

Taxes & Duties	Any increase in taxes and duties on account of statutory increas e, fresh imposition of any duty or taxes which take place during such extended period shall be admissible.
Price Variation	Price variation, if indicated in the Work Order/ Purchase Order, s hall be applicable during such extended period.

(ii) Delay attributable to Supplier / Contractor:

LD	Applicable
Taxes & Duties	Increase / fresh imposition of taxes and duties during the extend ed period will be to the account of the supplier/contractor. Any decrease in taxes and duties during the extended period will be availed by UCIL
Price Variation	Price variation, if indicated in the contract will be applicable for the work performed within the scheduled period of contract. For work executed during the extended delivery period, the rates as prevailing on the last day of the scheduled contract period only may be paid. De-escalation/reduction, if any, which takes place, shall have to be passed on to UCIL

(c) The payment of liquidated damages shall not relieve the Contractor from its obligation to complete the Works.

16. **Variation in Price:**

Unless the <u>Clause Price Adjustment</u> provides otherwisethe rates and prices quoted by the Tenderer's hall be fixed for the duration of the Contract and shall not be subject to adjustment or any account.

17. Termination for Insolvency:

The Corporation may at any time terminate the Contract by giving written notice of four weeks to the C ontractor, without any compensation to the Contractor, if the Contractor becomes bankrupt or otherwis e insolvent.

18. Defaults, Breaches, Termination, and closure of Contract

1) Termination due to Breach, Default, and Insolvency

a) Defaults and Breach of Contract

In case the contractor undergoes insolvency or receivership; neglects or defaults, or expresses in ability or disinclination to honour his obligations relating to the performance of the contract or et hical standards or any other obligation that substantively affects the Procuring Entity's rights and benefits under the contract, it shall be treated as a breach of Contract. Such defaults could includ

e inter-alia:

- i) **Default in Performance and Obligations:** if the contractor fails to deliver any or all of the Services or fails to perform any other contractual obligations (including Code of Integrity or obl igation to maintain eligibility and Qualifications based on which contract was awarded) within t he period stipulated in the contract or within any extension thereof granted by the Procuring E ntity.
- ii) **Insolvency:** If the contractor being an individual or if a firm, any partner thereof, shall at any time, be adjudged insolvent or shall have a receiving order or order for the administration of hi s estate made against him or shall take any proceeding for composition under any Insolvency Act for the time being in force or make any conveyance or assignment of his effects or enter in to any assignment or composition with his creditors or suspend payment or if the firm be dissolved under the Partnership Act, or
- iii) **Liquidation:** if the contractor is a company being wound up voluntarily, or by order of a Cour t or a Receiver, Liquidator or Manager on behalf of the Debenture-holders is appointed, or circu mstances shall have arisen which entitle the Court or Debenture-holders to appoint a Receiver , Liquidator or Manager.

b) Notice for Default:

As soon as a breach of contract is noticed, a show-cause 'Notice of Default' shall be issued to the contractor, giving two weeks' notice, reserving the right to invoke contractual remedies. After such a show-cause notice, all payments to the contractor would be temporarily withheld to safeguar dineeded recoveries that may become due on invoking contractual remedies.

c) Terminations for Default

- i) Notice for Termination for Default: In the event of unsatisfactory resolution of 'Notice of Default' within two weeks of its issue as per sub-clause above, the Procuring Entity, if so decid ed, shall by written Notice of Termination for Default sent to the contractor, terminate the cont ract in whole or in part, without compensation to the contractor.
- ii) Such termination shall not prejudice or affect the rights and remedies, including under sub-cla use below, which have accrued and/ or shall accrue to the Procuring Entity after that.
- iii) Unless otherwise instructed by the Procuring Entity, the contractor shall continue to perform the contract to the extent not terminated.
- iv) All Defect Liability obligations, if any, shall continue to survive despite the termination.

d) Contractual Remedies for Breaches/ Defaults or Termination for Default

If there is an unsatisfactory resolution within this period, the Procuring Entity shall take one; or m ore of the following contractual remedies.

- i. Temporary withhold payments due to the contractor till recoveries due to invocation of ot her contractual remedies are complete.
- ii. Call back any loaned property or advances of payment, if any, with a levy of interest at the prevailing rate (MIBID Mumbai Interbank Bid Rate).
- iii. Recover liquidated damages and invoke denial clause for delays.
- iv. Encash and/ or Forfeit performance or other contractual securities.

- v. Prefer claims against insurances, if any.
- vi. Terminate Contract for default, fully or partially including its right for Risk-and-Cost Procur ement as per following sub-clause.
- vii. **Risk and Cost Procurement** In addition to termination for default, the Procuring Entity shall be entitled, and it shall be lawful on his part, to procure Services similar to those termi nated, with such terms and conditions and in such manner as it deems fit at the "Risk and Cost" of the contractor. Such Risk and Cost Procurement must be contracted within six mont hs from the breach of Contract. The contractor shall be liable for any loss which the Procurin g Entity may sustain on that account provided the procurement, or, if there is an agreement to procure, such agreement is made. The contractor shall not be entitled to any gain on such procurement, and the manner and method of such procurement shall be in the entire discretion of the Procuring Entity. It shall not be necessary for the Procuring Entity to notify the contractor of such procurement. It shall, however, be at the discretion of the Procuring Entity to collect or not the security deposit from the firm/ firms on whom the contract is placed at the risk and cost of the defaulted firm.

Note: Regarding the Services that are not readily available in the market and where procurement difficulties are experienced, the period for making risk procurement shall be nine months ins tead of six months provided above.

viii. Initiate proceedings in a court of law for the transgression of a law, tort, and loss, not addr essable by the above means.

e) Limitation of Liability

Except in cases of criminal negligence or wilful misconduct, the aggregate liability of the contract or to the Procuring Entity, whether under the contract, in tort or otherwise, shall not exceed the t otal Contract Price, provided that this limitation shall not apply to the cost of repairing or replacin g defective equipment, or to any obligation of the contractor to indemnify the Procuring Entity concerning IPR infringement.

2) Termination for Default/ Convenience of Procuring Entity and Frustration

a) Notice for Determination of Contract

- i) The Procuring Entity reserves the right to terminate the contract, in whole or in part for its (the Procuring Entity's) convenience or frustration of Contract as per sub-clause below, by serving written 'Notice for Determination of Contract' on the contractor at any time during the currency of the contract. The notice shall specify that the termination is for the convenience of the Procuring Entity or the frustration of the contract. The notice shall also indicate inter-alia, the extent to which the contractor's performance under the contract is terminated, and the date with effect from which such termination shall become effective.
- ii) Such termination shall not prejudice or affect the rights and remedies accrued and/ or shall a ccrue after that to the Parties.
- iii) Unless otherwise instructed by the Procuring Entity, the contractor shall continue to perform the contract to the extent not terminated.
- iv) All Defect Liability obligations, if any, shall continue to survive despite the termination.
- v) The Services and incidental goods/ works that can be delivered or performed within thirty da ys after the contractor's receipt of the notice of termination shall be accepted by the Procurin g Entity as per the contract terms. For the remaining Services and incidental goods/ works, the Procuring Entity may decide:
 - (1) To get any portion of the balance completed and delivered at the contract terms, conditions, and prices; and/ or
 - (2) To cancel the remaining portion of the Services and incidental goods/ works and compens ate the contractor by paying an agreed amount for the cost incurred by the contractor, if a ny, towards the remaining portion of the Services and incidental goods/ works.

b) Frustration of Contract

- i) **Notice of Frustration Event:** Upon a supervening cause occurring after the effective date of the contract, including a change in law, beyond the control of either party whether as a resu It of the Force Majeure clause or within the scope of section 56 of the Indian Contract Act, 187 2, that makes it impossible to perform the contract within a reasonable timeframe, the affecte d party shall give a 'Notice of Frustration Event' to the other party giving justification. The part ies shall use reasonable efforts to agree to amend the contract, as may be necessary to compl ete its performance. However, if the parties cannot reach a mutual agreement within 60 days of the initial notice, the Procuring Entity shall issue a 'Notice for Determining the contract' and terminate the contract due to its frustration as in the sub-clause above.
- ii) However, the following shall not be considered as such a supervening cause
- iii) Lack of commercial feasibility or viability or profitability or availability of funds
- iv) If caused by either party's breach of its obligations under this Contract or failure to act in goo d faith or use commercially reasonable due diligence to prevent such an event.

3) Closure of Contract

The contract shall stand closed upon

- 1) Successful performance of all obligations by both parties, including completion of Defect Liabilityobligations and final payment.
- Termination and settlements after that, if any, as per Termination due to Breach, Default, a nd Insolvency or Termination for Default/ Convenience of Procuring Entity and Frustration.
- 19. **Statutory Variation Clause:** Unless otherwise stated in the contract, statutory increase in applicable GST rate only during the original delivery period shall be to Procuring Entity's account. Any increase in t he rates of GST beyond the original completion date during the extended delivery period shall be borne by the contractor. The benefit of any reduction in GST rate must be passed on to the Procuring Entity d uring the original and extended delivery period. However, GST rate amendments shall be considered fo r quoted HSN code only, against documentary evidence, provided such an increase of GST rates takes p lace after the last date of bid submission.

20. Time for Delivery of services and Extensions Thereof

The time and uninterrupted delivery of Services shall be deemed to be the essence of the contract. Subject to any requirement in the contract as to the completion of any portions or portions of the Services before completion of the whole; the contractor shall fully and finally complete the whole of the services comprised in the contract as per the Delivery and Completion Schedule stipulated in Format 1.1: Description of Services. If at any time during the currency of the contract, the contractor encounters conditions hindering the timely performance of services, the contractor shall promptly inform the Procuring Entity in writing about the same and its likely duration. He must make a request to the Procuring Entity for an extension of the delivery schedule. On receiving the contractor's communication, the Procuring Entity shall examine the situation and, at its discretion, may agree to extend the completion schedule, with or without liquidated damages and with and without denial clause by issuing an amendment to the contract in terms of the following clauses.

20.1. Extension Due to Modification

The Contract Manager might grant a reasonable extension of the completion date if any modificat ions ordered materially increase the time for delivery of the services. The contractor shall be responsible for requesting such extension of the date as soon as the cause thereof shall arise and in a ny case not less than one month before the expiry of the date fixed for completion of the services

20.2. Extension for Delay Not Due to Contractor

If in the opinion of the contractor, the progress of Services has any time been delayed due to follo wing reasons, then within 15 days of such happening causing delay, he shall give notice thereof i

n writing to the Contract Manager, but shall nevertheless do due diligence to bring down or make good the delays and to proceed with the services:

- (a) any act or neglect of other contractor employed by the Procuring Entity or in executing the work/service not forming part of the contract but on which Contractor's performance necess arily depends or
- (b) proceeding taken or threatened by or dispute with external third parties arising otherwise t han from the contractor's own default etc. or
- (c) any act or neglect of Procuring Entity's employees or
- (d) delay authorized by the Contract Manager pending arbitration or
- (e) the contractor not having received in due time necessary instructions from the Procuring En tity for which he shall have especially applied in writing to the Contract Manager or his authorized representative.
- (f) hand over possession of the site or the necessary facilities/ documents/ data or instructions by the Procuring Entity to the contractor or
- (g) give the necessary notice to commence the services, or
- (h) any other delay caused by the Procuring Entity due to any other cause whatsoever.
- (i) the contractor may also indicate the period for which the Services is likely to be delayed an d ask for a necessary extension of time. On receipt of such request from the contractor, the Contract Manager shall consider the same and grant such extension of time as in his opinion is reasonable regarding the nature and period of delay and the type and quantum of work aff ected thereby. No other compensation shall be payable for works so carried forward to the e xtended period. The same rates, terms, and conditions as the original Contract shall apply d uring the extended period.

20.3. Extension of Time for Delay Due to Contractor

If the contractor fails to deliver the Services within the fixed/ extended period for reasons other th an those stipulated in contract, the Procuring Entity may, if satisfied that the service delivery can still be completed within a reasonable time, extend the period further.

On such extension, the Procuring Entity shall be entitled without prejudice to any other right and remedy available on that behalf to recover from the contractor as agreed damages and not by way of penalty Liquidated Damages as per contract clauses.

Provided further, that if the Procuring Entity is not satisfied that the service can be completed by the contractor or in the event of failure on the part of the contractor to complete the service within the extension of time allowed further as aforesaid, the Procuring Entity shall be entitled without prejudice to any other right or remedy available in that behalf, treat the delay as a breach of cont ract and avail any or all the remedies thereunder, whether or not actual damage is caused by such default.

Inordinate Delays: Delays due to the contractor of more than one-fourth (25%) of the total comple tion period shall be treated as inordinate delays. Such inordinate delays shall be noted as poor p erformance and be held against the contractor in future tenders. A show-cause notice shall be iss ued to the contractor before declaring it a poor performance. Such delays may be considered as a breach of the contract at the option of the Procuring Entity.

21. Suspension of Services

21.1. Suspension Ordered by Contract Manager

The contractor shall, on the order of the Contract Manager, suspend the progress of the Services or any part thereof for such time or times and in such manner as the Contract Manager may consi der necessary, and shall during such suspension, adequately protect and secure the site and asse ts so far as is necessary in the opinion of the Contract Manager. If such suspension is -Provided fo r in the contract, orNecessary for the proper execution of the Services or because of extraneous c onditions or by some default on the part of the contractor and orNecessary for the safety of the S ervices or any part thereof

21.2. Extension of Time and Compensation

The contractor shall not be entitled to the extra costs, if any, incurred by him during the period of

suspension of the service, but in the event of any suspension ordered by the Contract Manager for reasons other than aforementioned and when each such period of suspension exceeds 14 days, the Contract Manager shall extend the time of service for completion of the Services as he may consider proper, having regard to the period or periods of such suspensions and such compensations as the Contract Manager may consider reasonable in respect of expenses incurred by the contractor during the periods of such suspension.

21.3. Suspension Lasting More Than 3 Months

If the Contract Manager suspends the Services or any part thereof for more than three months at a time, the contractor may serve a written notice on the Contract Manager requesting permission to proceed with the suspended part(s) of service. If such permission is not granted within 15 days from the receipt thereof, the contractor by further written notice may, treat the suspended part(s) of the service as deleted from the Contract. If the whole of the services has been suspended, he may treat it as a breach of the contract by the Procuring Entity and avail any or all remedies provided in this regard in the contract.

21.4. Force Majeure

- (a) On the occurrence of any unforeseen event, beyond the control of either Party, directly interf ering with the delivery of Services arising during the currency of the contract, such as war, hos tilities, acts of the public enemy, civil commotion, sabotage, fires, floods, explosions, epidemic s, quarantine restrictions, strikes, lockouts, or acts of God, the affected Party shall, within a we ek from the commencement thereof, notify the same in writing to the other Party with reasona ble evidence thereof. Unless otherwise directed by the Procuring Entity in writing, the contract or shall continue to perform its obligations under the contract as far as reasonably practicable and shall seek all reasonable alternative means for performance not prevented by the Force M ajeure event. If the force majeure condition(s) mentioned above be in force for 90 days or mor e at any time, either party shall have the option to terminate the contract on expiry of 90 days of commencement of such force majeure by giving 14 days' notice to the other party in writin g. In case of such termination, no damages shall be claimed by either party against the other, save and except those which had occurred under any other clause of this Contract before such termination.
- (b) Notwithstanding the remedial provisions contained in **Damages and Deductions Thereof a nd Termination due to Breach, Default, and Insolvency,** none of the Party shall seek any such remedies or damages for the delay and/ or failure of the other Party in fulfilling its obligat ions under the contract if it is the result of an event of Force Majeure.
- **22. Permits, Approvals and Licenses:** Whenever the delivery of Services and incidental Goods/ Works requires the contractor to obtain permits, approvals, and licenses from local public authorities, it shall be the contractor's sole responsibility to obtain these and keep these current and valid. Such requirements may include but not be restricted to licences or environmental clearance if required. If requested by the contractor, the Procuring Entity shall make its best effort to assist the contractor in complying with such requirements in a timely and expeditious manner, without any dilution of the Contractor's responsibility in this regard.

23. Labour Codes and Related Obligations

23.1. Independent Contractor

The contractor's status shall be that of an independent contractor and Primary Employer of staff deployed during the contract by him or his sub-contractors or other associates. The contractor, it s employees, agents, and subcontractors performing under this Contract are not employees or ag ents of the Procuring Organisation or Procuring Entity or Central or State Government or their ag encies/ Enterprises, simply by Services delivered under this Contract.

23.2. Obligations of the contractor under Labour Codes and Rules

a) In cases where Services are to be performed by the contractor at the premises of the Procuri ng Entity or Beneficiary of Services, the contractor shall comply with the provisions of the Labo ur Codes including Code on Wages, 2019, The Industrial Relations Code 2020, Code on the So cial Security 2020, and The Occupational Safety, Health and Working Conditions 2020, and Dr aft Rules made thereunder, as modified from time-to-time, wherever applicable and shall also indemnify the Procuring Entity from and against any claims under the aforesaid Labour codes and the Rules.

- b) The contractor shall obtain a valid licence under the aforesaid Labour codes and the Rules as modified from time to time before the commencement of the contract and continue to have a valid licence until the completion of the contract. Any failure to fulfil this requirement, the Proc uring Entity shall treat it as a breach of contract for default as per the contract and avail any o r all remedies thereunder.
- c) In respect of all labour directly or indirectly employed in the contract for the performance of the contractor's part of the contract, the contractor shall comply with or cause to comply with the provisions of the aforesaid Labour codes and the Rules wherever applicable. The contractor shall be solely responsible for submitting all the necessary returns under these Codes and the Rules. Nevertheless, the contractor shall submit monthly returns to the Procuring Entity to confirm compliance with such Codes and rules. Failure to do so shall entitle Procuring Entity to take any measure to ensure compliance to such codes and rules by the contractor and his associates, including, but not limited to, withholding contractor's on-account bills.
- d) The contractor shall pay the wages as per the Code on Wages to their workers not below the rate of minimum wages, as notified by the State Government or Central Government, whichev er is higher, through the bank transfer. The contractor shall, notwithstanding the contract's pr ovisions to the contrary, cause to be paid the wages to labour directly or indirectly engaged on the contract, including any engaged by his Sub-Contractors in connection with the said contract as if he had immediately employed the labour. The Procuring Entity shall, without any commitments or being obliged to do, may its discretion, monitor that such payments are being made. The contractor shall be required to submit, every month, documentary evidence in the form of a Bank Statement of having transferred the gross minimum wages to each worker. Failure to do so shall entail Procuring Entity taking up any measure to ensure the payment of wages including, but not limited to, withholding contractor's on-account bills.
- e) In every case in which, by virtue of the provisions of the aforesaid Labour codes and the Rule s, the Procuring Entity is obliged to pay any amount of wages to a workman employed by the c ontractor or his Sub-Contractor in execution of the contract or to incur any expenditure in pro viding welfare and health amenities required to be provided under the aforesaid Labour codes and the Rules or to incur any expenditure on account of the contingent liability of the Procurin g Entity due to the contractor's failure to fulfil his statutory obligations under the aforesaid La bour codes and the Rules the Procuring Entity shall recover from the contractor, the amount of wages so paid or the amount of expenditure so incurred, and without prejudice to the rights of the Procuring Entity under the aforesaid Labour codes and the Rules, the Procuring Entity shall be at liberty to recover such amount or part thereof by deducting it from the security de posit and/ or from any sum due by the Procuring Entity to the contractor whether under the co ntract or otherwise. The Procuring Entity shall not be bound to contest any claim made agains t it under the aforesaid Labour codes and the Rules except on the contractor's written request, and upon giving the Procuring Entity complete security for all costs, for which the Procuring E ntity might become liable in contesting such claim. The decision of the Procuring Entity regard ing the amount recoverable from the contractor as stated above shall be final and binding on the contractor.

23.3. Occupational Safety, Health, Working Conditions, Social Security, and Industrial Relations Requirements:

As per Labour Codes, which included Code on Wages, 2019, The Industrial Relations Code 2020, Code on the Social Security 2020, and The Occupational Safety, Health and Working Conditions 2 020 and rules thereunder, the following provisions shall be ensured by the contractor.

23.3.1. Provisions for Workers:

At his own expense, the contractor shall make adequate arrangements for the housing, supply of drinking water, and provision of clean sanitation, including urinals, etc., for his staff and workers, directly or through the petty contractors or sub-contractors.

The contractor shall also provide a temporary creche (Bal-mandir) where 50 or more wo rkers are employed at a time.

Suitable sites on Procuring Entity's land, if available, but without any obligation to do so , may be allotted to the contractor for the erection of labour camps, either free of charg e or on such terms and conditions that the Procuring Entity may prescribe.

All camp sites shall be maintained in clean and sanitary conditions by the contractor at his own cost.

During the execution of services, unless otherwise stipulated in the contract, the contractor shall at his own cost provide the following materials as is necessary for:

- (a) The safety, hygiene, satisfaction, elegance, acceptance, proper handling of assets a nd shall ensure that no damage, injury, or loss is caused or likely to be caused to an y person or assets or hindrance to other works/ services.
- (b) Environmental requirements to conserve energy, water, wood, paper, and other res ources, reduce waste, phase out the use of ozone-depleting substances, and minimis e the release of greenhouse gases, volatile organic compounds, and other substance s damaging health and the environment.
- 23.3.2. **Medical Facilities:** the contractor shall provide medical facilities at the site as prescr ibed by the Contract Manager on the advice of the Procuring Entity's Medical Authority c ommensurate with the strength of the contractor's resident staff and workers. Such facilities shall include a First-Aid facility manned with staff trained in first aid as per labour c odes or the Contract Manager's directions.

23.3.3. Medical Certificate of Fitness for Labour

The contractor shall not employ a person below 18 years of age. For delivery of Services under the contract, unless a medical certificate of fitness in the prescribed form under la bour codes (or as directed by the contract manager) is granted to each worker by a cert ifying surgeon certifying that he is fit to work as an adult, is obtained and kept in the cu stody of the contractor or a person nominated by him in this behalf and the person carri es with his, while at work, a token giving a reference to such certificate.

- (i) Period of Validity of Medical Fitness Certificate: A certificate of fitness granted or r enewed for the above-said purposes shall be valid only for one year at a time. The certifying surgeon shall revoke a certificate granted or renewed if, in his opinion, t he holder of it is no longer fit for work in the capacity stated therein. Where a certifying surgeon refuses to grant or renew a certificate or revoke a certificate, he shall, if so required by the person concerned, state his reasons in writing for doing so.
- (ii) Medical Re-Examination of Labour: Where any official appointed on this behalf by the Ministry of Labour believes that any person employed in connection with the e xecution of any work under this Contract in the age group 18 to 65 years is withou t a certificate of fitness or is having a certificate of fitness but no longer fit to work in the capacity stated in the certificate, he may serve on the contractor, or the per son nominated by him in this regard, a notice requiring that a certifying surgeon a nd such person shall examine such persons shall not if the concerned official so dir ects, be employed or permitted to do any work under this Contract unless he has b een medically examined and certified that he has been granted a certificate of fitn ess or a fresh certificate of fitness, as the case may be.

24. Governing Laws and Jurisdiction

24.1. Governing Laws and Jurisdiction

This Contract, its meaning and interpretation, and the relation between the Parties shall be gover ned by the Laws of India for the time being in force.

Irrespective of the place of delivery, or the place of performance or the place of payments under the contract, the contract shall be deemed to have been made at the place from which the Letter of Award (LoA, or the contract Agreement, in the absence of LoA) has been issued. The courts of such a place shall alone have jurisdiction to decide any dispute arising out or in respect of the contract.

24.2. Changes in Laws and Regulations

Unless otherwise stipulated in the contract, if after the last deadline for the bid submission (Techn o-commercial), any law, regulation, ordinance, order or bye-law having the force of law is enacted, promulgated, abrogated, or changed in India (which shall be deemed to include any change in interpretation or application by the competent authorities) that subsequently affects the Delivery
