Only such firms need to tender who can produce satisfactory evidence that they have the necessary experience & financial resources to undertake such work as per criteria mentioned below.

- 1) Experience of having successfully completed similar work during last 07 years ending last day of month previous to the one in which applications are invited should be either of the following:
- a) One similar completed works costing not less than the amount equal to Rs.7,19,101.60/-. OR
- b) Two similar completed works each costing not less than the amount equal to Rs.4,49,438.50/-. OR
- c) Three similar completed works each costing not less than the amount equal to Rs.3,59,550.80/-.

'Similar work' means the bidder shall be Authorized Service Provider of M/s Cummins India Li mited and the bidder shall have experience of having successfully completed similar job of AM C of minimum 1010 kVA D.G. Set.
