Only such firms need to tender who can produce satisfactory evidence that they have the necessary experience & financial resources to undertake such work as per criteria mentioned below.

- i) Experience of having successfully completed SIMILAR WORK during last 07 years ending last day of month previous to the one in which applications are invited should be either of the following:
- a) One similar completed works costing not less than the amount equal to Rs.4,69,337.00/-

Or

b) Two similar completed works each costing not less than the amount equal to Rs.2,93,336.00/-

Or

c) Three similar completed works each costing not less than the amount equal to Rs.2,34,668.00/-

"Similar work" means experience in Fabrication/Repairing work of Booms of underground Machine OR Fabrication job related with underground Machine. The bidder will have to submit copy of the relevant work order / LOI / LOA clearly indicating Work Order Value (in INR) and its completion certificate, from the client, as documentary evidence in support of their experience / credential, failing which offer may be sum marily rejected.

The submitted Work Orders / LOI / LOA and Completion Certificateshall be either in English or Hind i only. Credentials other than English or Hindi language shall not be considered.

- i.e. 2021-22 should be at least Rs 1,76,001.00/-. Annual Report containing Profit & Loss account a nd Balance sheet along with ITR duly audited by CA/Cost Accountant for last 3 FYs must be submitted.
- ii) Geographical Presence: Proof of having Registered Office and workshop located and registered within the districts of East Singhbhum/ West Singhbhum/ Saraikela & Kharaswa districts of the buyer i.e. J harkhand where the services needed to be provided. Documentary evidence must be provided in the form of Municipality trade license or other such documents as per the following which satisfies as a proof of having the office establishment.
- i. Trade License issued by the local authority in the name of the Firm OR
- ii. Incorporation Certificate of the firm clearly mentioning office address OR
- iii. Electricity bill for last one year in the name of the Firm OR
- iv. GSTIN registration
- v. Udyam/MSME/NSIC/SSI
- iii) Workshop facility should be located within a range of 50 KM where the service needs to be provided.
- iv) PAN should be registered with the State of Jharkhand Only.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
