- i) Experience of having successfully completed similar work during last 07 years ending last day of month previous to the one in which applications are invited should be either of the f ollowing:
- a) One similar completed works costing not less than the amount equal to Rs.1,35,936/-.

b) Two similar completed works each costing not less than the amount equal to Rs.84,960/-.

c) Three similar completed works each costing not less than the amount equal to Rs.67,968/-.

- a) The contractor shall depute engineer for routine performance inspection of the 01 NOS. 10 10 kVA D.G. set. There shall be maximum 12 visits per DG in a year including maintenance and breakdown during entire contract period.
- b) In case of breakdown, the contractor's engineer shall attend to the breakdown and restore the set as and when required without any additional charge.
- c) Any spares required shall be supplied by UCIL if available in our stock.
- d) The Contractor shall attend the Breakdown within 2 hours of breakdown report made to the m by UCIL.

2. Schedule maintenance:

- a) The contractor's engineer shall perform schedule maintenance of D.G. set with prior intimation of 1 to 2 days from UCIL.
- b) The contractor's engineer shall perform schedule maintenance of D.G. set with prior intima tion of 1 to 2 days from UCIL Arranging to repair and/or re-order all damaged or short supply items.
- c) Top overhauling or de-carbonization of cylinder heads, repair of fuel pump, injector, turboc hargers and any other sub assemblies is beyond the scope of contract. In case repair / calib ration is required for these components it would be taken up by the contractor at an additional cost towards spares and repair / calibration charge on prior intimation to UCIL.
- d) Lubricating oil and spares recommended by the Contractor shall be supplied by UCIL as an d when required for maintenance and breakdown jobs.
- e) If any problem occurs in alternator and controller the contractor's engineer shall attend DG set for restoration of the system.
 - 3. The contractor shall arrange their own vehicle to attend breakdown, routine maintenanc e. However, UCIL may provide vehicle (to and fro) to attend breakdown during odd hours i.e. 6.00 PM to 6.00 AM based on availability of vehicle.
 - 4. The job site is situated at Main Receiving Station (MRS) of Turamdih Mines, Sundarnagar , Singhbhum East, district of Jharkhand State.
 - 5. Turamdih is situated in district East Singhbhum of Jharkhand, at a distance of about 6 k m from Tata Nagar Railway station, S.E. Railway.
 - 6. <u>Payment terms</u>: Payments will be done on Performa invoice or after submission of Service report on per visit basis..
 - 7. Safety precautions and discipline shall be maintained during execution of work, failing w hich, the work order is liable to be cancelled.

- 8. The Contractor shall be fully and finally responsible for proper job, safe and satisfactory operation of DG set.
- 9. Safety Measures: All safety rules & codes as applicable shall have to be followed by the operators.

- 11. Creating bid for items from irrelevant categories.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
