A. Experience Criteria

The bidder shall have experience of successfully completed similar works during last 7 year s ending last day of month previous to the one in which applications are invited should be either of the following (a or b or c):

a) one similar completed work costing not less than Rs 39,86,465 /-, or

- b) two similar completed works costing not less than Rs 24,91,541 /- each, or
- c) three similar completed works costing not less than Rs 19,93,233 /- each.

B. Financial Criteria

The Average Annual financial turnover during the last 3 years, ending on 31St March of the previous financial year should be at least Rs 14,94,925 /-.

Similar Work means execution of Supply of Rotary Kiln or Supply, Erection & Commissioning of Rotary Kiln or Supply of Mechanical Seal for Rotary Kiln or Design, Supply, Erection & Commiss ioning of Mechanical Seal for Rotary Kiln in any Central/ State Govt. Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

This Bid is governed by the <u>General Terms and Conditions/सामान्य नियम और शर्त</u>, conditions stipulated in Bid and <u>Service Level Agreement</u> specific to this Service as provided in the Marketplace.
