#### A. Experience Criteria

The bidder shall have experience of successfully completed similar works during last 7 year s ending last day of month previous to the one in which applications are invited should be ei ther of the following (a or b or c) :

a) one similar completed work costing not less than Rs 39,86,465 /-, or

b) two similar completed works costing not less than Rs 24,91,541 /- each, or

c) three similar completed works costing not less than Rs 19,93,233 /- each.

## **B. Financial Criteria**

The Average Annual financial turnover during the last 3 years, ending on 31<sup>st</sup> March of the previous financial year should be at least Rs 14,94,925 /-.

If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for percentage of 15% of total value.

Any clause(s) incorporated by the Buyer regarding following shall be treated as null and void and would not be considered as part of bid:-

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
