(a) Contractors Scope

- 1. The work will be carried out in Turamdih Mines.
- 2. The work will be carried out in A shift, B Shift or General Shift.
- 3. Transportation of men/ machine/ material and its charges will have to be borne by the contractor and no extra charges will be paid for the same by UCIL.
- 4. One (01) No. machine is to be provided by the party as per specification provided.(as per Annexure 1X)
- 5. Three (3) nos. manpower to be provided for the machine. (2 Skilled +1 Un-Skilled), Total 3 nos.
- 6. Work will be carried out on Sunday also (with one day leave in a week).
- 7. The work may be carried out in single or different shifts for the machine as per requirement of Engineer in -Charge or its Representative.
- 8. Length of out-put hose of machine should be 15 mtr. (approx.).
- 9. Length of electrical cable of machine should be 8 to 10 mtr (approx).
- 10. The machine should have chemical cleaning facility and chemical has to be provided by the party, no extr a charges will be paid for the same.
- 11. All PPE (Personal protective Equipment) like Safety Helmet, Gloves, Gum boot, Water proof Apron for prot ection from dirt and water, safety Goggles is to be provided by the contractor.
- 12. Maintenance of provided machine will be in contractor's scope and no extra material will be provided fro m UCIL.

- 1. Electrical Power of 220/440 Volt, as required will be provided by UCIL with a cable of length 50 to 100 mtr with a connection point for operation of the Machine. Two no's electrical female socket point will be provid ed. For operation of machine; Power supply will be free at two points where electric supply is available.
- 2. Source of water and a sufficient length of connecting Pipe (with metal snap coupling at the end) will be pr ovided by UCIL.

- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
