- One similar nature of work not less than Rs. 08.22 lakh i.e.80 % of the estimated value of the work or
- Two similar nature of work not less than Rs. 05.14 lakh each i.e.50 % of the estimated value of the work or
- Three similar nature of work not less than Rs. 04.11 lakh each i.e. 40 % of the estimated value of the work.

2. Minimum average turnover of Rs. 03.08 Lakh i.e. 30 % of the estimated value of the work for last 3(three ) financial years and submission of duly audited copy of Profit & Loss account and Balance sheet of financial years 2020-21, 2021-2022 & 2022-23 by Chartered Accountant.

3. The Bidder shall submit registration copies of PAN, GST, MSME/NSIC, PF, ESIC and Income Tax Return Statement.

4. Similar Works means-“Any Civil Work / Garbage Disposal work” with Govt. / PSU / Public Limited Organization / Private Limited Organization.”

5. Relaxation of conditions of prior turnover and prior experience : Pre-qualification criteria with respect to Prior Turnover and Prior experience may relax all MSE's and Start-ups as per GOI guidelines subject to meeting of Quality and Technical specifications. UCIL may consider allowing the participation of “MSE's and Start up” companies with capability to execute the supply/ services, as per technical specifications/ perform t

he job as per scope of work specified in the tender and subject to meeting extant & relevant guidelines of Government of India. This should be confirmed and substantiated in the technical bid. The bidder who intends to participate as "Start-up" company should enclose the Certificate of Recognition issued by Department of Industrial Policy and Promotion, Ministry of Commerce & Industry, Govt. of India during submission of Technical bid. (AS DEFINED IN GAZETTE NOTIFICATION NO. D.L-33004/99 DATED 18.02.2016 AND 23.05.2017 OF MINISTRY OF COMMERCE AND INDUSTRY), AS AMENDMED TIME TO TIME). The MSE's and Start-up's must enclose registration copies of PAN, GST, ESIC & PF No. of the firm/organization. Note - The bidders seeking relaxation for prior experience and turnover must enclose the certificate over the relevant criteria as mentioned in the bid, otherwise the bidder will not be considered for exemption.

6. GEOGRAPHIC PRESENCE: Office registration certificate: Registered office or at least one of the registered branch office of the bidder shall be located and registered within the geographical limits of Dist - East Singhbhum, Jharkhand state where the services need to be provided.
