- a. Average Annual turnover during last 03 years ending 31st March of the previous financial year should be at least 30% of the estimated cost i.e. **Rs. 2.26 lakhs**
- b. Experience of having successfully completed similar works during last 7 years ending last day of month previous to the one in which applications are invited should be either of the following :
 - i) Three similar completed works costing not less than the amount equal to 40% of the estimated cost i.e. **Rs. 3.01 lakhs each OR** ii) Two similar completed works costing not less than the amount equal to 50% of the estimated cost i.e. **Rs. 3.77 lakhs each OR** iii) One similar completed works costing not less than the amount equal to 80% of the estimated cost i.e. **Rs. 6.03 lakhs .**

Similar works means:Experience in "Civil Construction work".

Documentary evidence in the form of work order copies specifying the work with completion certificate and audited balance sheet for the year 2015-2016; 2016-2017 & 2017-2018 should be submitted.

NIT No. , name of the work etc and submit the same in the office of DGM(I/P&IRs) , located in the Old Administrative Building, Jaduguda on or before the date of opening of Technical Part, failing which bid/tender of the concerned party will not be opened/ considered. Tenders received without Earnest Money Deposit , EPF No., GST code, work order copy and its completion certificate are likely to be rejected. Physical submission of tender shall not be accepted.
