The original EMD of the bidder and cost of tender document should be submitted by 3.00 PM on or before the opening of techno-commercial bid, failing which their offer will be rejected . If bidder claims exemption certificate of cost of tender & EMD, hard copy of MSME, NSIC, SSI, DG&SD certificate must be submitted before opening of techno-commercial bid.

Pre- qualification Criteria :

- a). Average Annual turnover during last 03 years ending 31st March of the previous financial year should be at least 30% of the estimated cost i.e. **Rs 7.92 lakhs**
- b) Experience of having successfully completed similar works during last 7 years ending last day of month previous to the one in which applications are invited should be either of the following :
 - i) Three similar completed works costing not less than the amount equal to 40% of the estimated cost i.e. **Rs. 10.56 lakhs each OR**
 - ii) Two similar completed works costing not less than the amount equal to 50% of the estimated cost i.e. **Rs. 13.20 lakhs each OR**
 - iii) One similar completed works costing not less than the amount equal to 80% of the estimated cost i.e. **Rs. 21.13 lakhs each.**
- c.) Similar works means: **Washing and drying of uniform work in any industry/ institution (Govt./PSU/Private).**
- d) **Documentary evidence in the form of work order copies specifying the work with completion certificate and audited balance sheet for the last three years should be submitted.**
- e) **Bidders must attach completion certificate with executed amount against each work order.**

The tenderer shall upload scan copy of Cost of tender document and EMD along with required PQC documents in UCIL e-proc site on or before the date fixed for submission of the bid. **Physical submission of tender shall not be accepted. Tenders received without Cost of Tender Document , Earnest Money , EPF No., GST code, work order copy and its completion certificate are likely to be rejected.** The tenderer should enclose an authenticated/notarized copy of their valid registration certificate (current) with NSIC, MSME, SSI, DG&SD for grant of exemption towards cost of tender and Earnest Money Deposit. Tenderers are advised to visit/inspect the site for execution of work before submission of tender.

The tenderer shall enclose the original copy of cost of tender document and EMD in the form of Demand Draft/SBI Challan in an envelope and copy of uploaded PQC documents in a separate envelope and submit the same in the envelope marked as "technical bid" , superscribing details viz.
