**Pre- qualification Criteria :**

- Average Annual turnover during last 03 years ending 31<sup>st</sup> March of the previous financial year should be at least 30% of the estimated cost.
- Experience of having successfully completed similar works during last 7 years ending last day of month previous to the one in which applications are invited should be either of the following :
  - Three similar completed works costing not less than the amount equal to 40% of the estimated cost i.e. **Rs. 21.72 lakhs** each **OR** ii) Two similar completed works costing not less than the amount equal to 50% of the estimated cost i.e. **Rs. 27.15 lakhs** each **OR** iii) One similar completed works costing not less than the amount equal to 80% of the estimated cost i.e. **Rs. 43.44 lakhs** each.

Similar works means: Civil works / jobs.

**Documentary evidence in the form of work order copies specifying the work with completion certificate and audited balance sheet for the year 2014-2015; 2015-2016 & 2016-2017 should be submitted.**

The tenderer shall submit copy of work order with schedule and its completion certificate as documentary evidence.

"URANIUM CORPORATION OF INDIA LIMITED" payable at State Bank of India , Jadugoda Branch , Code No. 0227 and other documents as prescribed above must be submitted along with the technical proposal failing which the offer will not be considered. Alternatively , cost of tender fee may also be paid through SBI Collect Challan. This will operate at all branches of SBI in India. Format of Challan is enclosed with this tender document. Cost of tender document in SBI Challan (UCIL copy) shall be uploaded in UCIL e-proc site <http://www.tenderwizard.com/UCILEPROC>. on or before the date fixed for receiving the bid. Physical submission of tender shall not be accepted. Offers will be opened on due date as mentioned above by the Corporation's authorized representative(s) in the presence of Tenderers who are present. Tenders received without Cost of Tender Document , Earnest Money , EPF No., GST code, work order copy and its completion certificate are likely to be rejected. Tenderer shall submit the original copy/hard copy of EMD and cost of tender document as prescribed in a separate envelope and shall enclose the same in the envelope superscribing details viz. NIT No. , name of the work and submit the same in the administrative department on or before the date of opening of tender, failing which tender of the concerned party will not be opened. Scan copies of EMD, challan will also have to be submitted with e-tender.

Two separate work order will be issued to lowest bidder (L-1) and second lowest bidder (L-2) respectively in the ratio of **60:40** after opening of tender and finalization of L-1 party. The final offer amount of L-1 party will be splitted into two parts in which **60%** of amount /quantities are to be awarded to L-1 tenderer and balance **40%** quantities will be awarded to L-2 on the basis of same rate, terms and conditions of L-1. Hence those tenderers who are interested or agree to accept the above clause may apply for tender. Earnest money will be forfeited if any of them do not agree/accept the above clause after opening of tender and finalization of L-1 and L-2 party. The Corporation reserves the right to accept or reject any or all the tenders in full or part and the tenderers shall be bound to perform the same at his quoted rates.
