- a. Average Annual turnover during last 03 years ending 31st March of the previous financial year should be at least 30% of the estimated cost i.e. **Rs. 4.92 lakhs**
- b. Experience of having successfully completed similar works during last 7 years ending last day of month previous to the one in which applications are invited should be either of the following :
- i) Three similar completed works costing not less than the amount equal to 40% of the estimated cost i.e. **Rs. 6.56 lakhs** each **OR** ii) Two similar completed works costing not less than the amount equal to 50% of the estimated cost i.e. **Rs. 8.20 lakhs** each **OR** iii) One similar completed works costing not less than the amount equal to 80% of the estimated cost i.e. **Rs. 13.12 lakhs** .

Similar works means: Cleaning and Sweeping /Sanitation work/Civil construction work

Documentary evidence in the form of work order copies specifying the work with completion certificate and audited balance sheet for the year 2014-2015; 2015-2016 & 2016-2017 should be submitted.

Tenders received without Cost of Tender Document , Earnest Money , EPF No., GST code, work order copy and its completion certificate are likely to be rejected. The tenderer should enclose an authenticated/notarized copy of their valid registration certificate (current) with NSIC, MSME, SSI, DG&SD for grant of exemption

The tenderer shall upload/submit Scan copies of EMD, cost of tender document, copy of work order and completion certificate and other related papers/certificate with e-tender. The tenderer shall also submit hard copy of the work order with schedule of items and quantities, completion certificate with date and executed amount of job, earnest money deposit and cost of tender /exemption certificate (NSIC/MSME) for documentary evidence along with original copy/hard copy of EMD , cost of tender document, as prescribed in a separate envelope and shall enclose the same in the envelope superscribing details viz. NIT No. , name of the work and submit the same in the office of DGM(I/P&IRs) , located in the Old Administrative Building, Jaduguda on the stipulated date, failing which bid/tender of the concerned party will not be opened/ considered.

Offers will be opened on due date as mentioned above by the Corporation's authorized representative(s) in the presence of Tenderers who would like to be present.
