5. Prequalification criteria:

The Tenderer who wish to participate in the Tender shall fulfill the following Qualifying Criteria.

A. Experience Criteria

The bidder shall have experience of successfully completed similar works during last 7 years ending on 31.03.2018 should be either of the following (a or b or c) :

- a) one similar completed work costing not less than Rs 1,84,714/-, or
- b) two similar completed works costing not less than Rs 1,15,446/- each, or
- c) three similar completed works costing not less than Rs 92,357/- each.

B. Financial Criteria

The Average Annual financial turnover during the last 3 years, ending on 31.03.2018 should be at least Rs 69,268/-.

Similar Work means execution of Thermal Insulation job of Steam line/ Boiler/ Heat Exchanger etc. in any industry.

All steel items, welding electrodes and hardware like fasteners, washers and gaskets etc. as well as Aluminium sheet, mineral wool, chicken mesh, steel wire, screws etc. will be brought by the party and

shall engage required manpower, supervisor, tools & tackles with safety appliances.

The bidder shall submit documentary evidence by way of copies of work order, completion certificate, audited balance sheet including profit and loss account, necessary undertaking etc. along with bid, failing which tenderer will be disqualified.
