The eligible criteria to qualify in Technical Part are as below:-

1. Average Annual financial turnover during the last 3 years, ending 31st March of the previous financial year/A.Y. should be at least Rs. **6.10 Lakhs** certified by C.A.
2. Experience of having successfully completed “**Similar works**” during last 07 years ending last day of month previous to the one in which application are invited should be either of the following:
 - a) Three similar completed each works costing not less than the amount equal to **Rs. 8.13 Lakhs** or
 - b) Two similar completed each works costing not less than the amount equal to **Rs. 10.16 Lakhs** or
 - c) One similar completed work costing not less than the amount equal to **Rs. 16.26 Lakhs**.
3. **Bidders must attach completion certificate against each work.**
4. Similar works means “**Jungle cutting work / Civil maintenance work/Deployment of manpower.**”

The scan copy of EMD & Cost of tender document is to be uploaded on web while submitting bid through e-tendering system. Tender without cost of tender document and EMD will be summarily rejected.

The tenderers are advised to visit/inspection of the site for execution of work before submission of tender.

The Price Part of Technically qualified bidder only will be opened later on and the date of opening will be communicated to the bidder in advance.
