The bidder shall have experience of successfully completed similar works during last 7 years ending on 31.01.2019 should be either of the following (a or b or c) :

- a)** one similar completed work costing not less than Rs 33,61,846.40/-, or
- b)** two similar completed works costing not less than Rs 21,01,154.00/- each, or
- c)** three similar completed works costing not less than Rs 16,80,923.20/- each

**B. Financial Criteria**

The Average Annual financial turnover during the last 3 years, ending on 31.03.2018 should be at least Rs 12,60,692.40/-.

**Similar Work** means execution of either In-situ Re – Rubber lining work or Supply of MSRL Tank/ Vessel in any Organisation.
