4. The offer must be valid for six months from the date of tender opening, and no contractor shall be allowed to withdraw his/their offer within this period
5. There will be no defect liability period for this work.
6. The price quoted should be firm and no escalation on any account whatsoever will be entertained/paid by the Corporation.
7. Payment would be released by Jamshedpur/Jaduguda cheque.
8. First R. A & final bill will be paid for this work.
9. The price quoted by renderer should be firm and no escalation on any account what-so ever will be entertained /paid by the Corporation.
