Permanent resident within 10KM surrounding Jaduguda Mines. Documents of permanent residence are any of the following:-

  - b) Voters IDE card/Ration card.
- 2) Experience in the line of business photocopy of documentary evidence e.g.,Aadhar Card Trade license, Income tax return need to be submitted.
- 3) Financial strength i.e. photocopy of Bank Pass Book F.D/NSC/KVP etc. in his own name or if in the parents name, undertaking from parents need to be submitted as proof.
