3. The offer must be valid for six months from the date of tender opening, and no contractor shall be allowed to withdraw his/their offer within this period
4. There will be no defect liability period for this work.
5. The price quoted should be firm and no escalation on any account whatsoever will be entertained/paid by the Corporation.
6. Payment would be released by Jamshedpur/Jaduguda cheque.
7. One R. A & final bill will be paid for this work.
8. All the rates quoted by Tender shall be inclusive of cost of all materials, labour, tools, tackles, plant and machinery necessary to complete the work at no extra cost to corporation for any item.
12. No any carriage/transportation for any material except otherwise stated in schedule of quantities shall be paid by the department for this work. Contractor should quote their rates accordingly.

13. Quantity of an individual item may vary to any extent and be excluded altogether. Contractor will carryout all works up-to a total variation of $\pm 10\%$ (Ten) on the contract price and all quoted rates shall remain firm within this limit.
