Labour supply of 25 (Twenty five) manpower /day for regular removal of spillage cleaning in various locations of Turamdih Mill. Material to be cleaned will includes boulder breaking, accumulation, cleaning, scraping, hosing etc. discharging the accumulated material on to trolley, tractor trolley, dumper / trucks, charging into chutes, bunkers, conveyors, tanks, pits etc.

Working period & Responsibility:

8.00 A.M. to 1.00 P.M. & 2.00 P.M. to 5.00 P.M. on all working days. One supervisor shall be engaged for every 12 workmen. The job to be carried out will be explained to the contractor or his supervisor every day & they will be responsible for carrying out the assigned quantity of work.

Payment:

Insurance:

You are to arrange Insurance coverage for manpower engaged for the work.

Gate Pass:

Bidders have to arrange gate pass on their own for 30 (Thirty) persons at least so that full quota of manpower (25 Nos.) could be supplied.

Award of contract:

Contract for labour supply will be awarded to successful bidder L1.

Penalty:

Penalty will be imposed on pro-data basis for short supply of manpower than desired 25(Twenty five) manpower on day-to-day supply as below:

If concerned Engineer-in-Charge finds that jobs are not being done properly and there are slackness in work or progress is not satisfactory, then reminder shall be issued to the party for the improvement and even then not improved then contract shall be cancelled



Safety:

You have to arrange all tools & tackles at your own cost like shovels, Gumboot, Gloves, Helmets, Goggles, etc. to all the persons engaged daily.

Firm Price:

Price quoted shall remain firm till the completion of the work.

Rules and Regulations:

You have to follow all security, safety and labour rules of the Corporation.

Security Deposit:

You have to submit an amount equivalent to 5% of the awarded value of the work as security deposit in form of Demand Draft in favour of UCIL payable at State Bank of India, Jaduguda.
