Prequalification criteria (PQC):

A. Experience Criteria

1. Experience of having successfully completed similar works during last 07 (seven) years ending last day of the month previous to the one in which applications are invited should be either of the following:
 - a) One similar completed works costing not less than Rs.2,19,359/- or
 - b) Two similar completed works costing not less than Rs. 1,37,099 /- or
 - c) Three similar completed works costing not less than Rs. 1,09,679/-

B. Financial Criteria

Average annual financial turnover during the last 03 (three) years, ending 31st March of the previous financial year 2020-21, should not be less than Rs. 82,259/-. For this audited balance sheet for the financial year 2019-20, 2020-21 & 2021-22 (Certified copy by CA can also be submitted) to be submitted.

Scope of job:

- 200 nos. of 200 NB Pipes laid over the length of 1 km are to be dismantled in Jaduguda Tailings Pond, collected at one place and then to be loaded on Truck using Hydra or TIL and transported to Turamdih Pond where the pipes are to be unloaded.
- The job shall involve 1 no. Fitter/Welder (Skilled), 1 no. Rigger/ Asst. Welder (Semi-skilled) and 06 nos. Helpers (Unskilled) for dismantling of pipes and during loading and unloading too.
- Cutting and welding, if any, shall be catered by the contractor.
- Any other miscellaneous job as and when directed by the Engineer-In-Charge.
- Job shall be carried out in shifts or as directed by the Engineer-In-Charge in General shift (8:00 AM to 5:00 PM) only on all working days (Excluding holidays & Sundays).
- The job to be carried out will be explained to the contractor or his supplied manpower at the beginning of the contract & they will be responsible for carrying out the assigned quantity of work.

Terms and Conditions:

1. Basis of Evaluation

Offer submitted by the bidder shall be in single part. Evaluation of L1 (Lowest) bidder shall be done based on their lowest quoted rate in totality after qualifying PQC. Bidder should quote their rate both in figures as well as in words. In case of any discrepancy in figure and words, rate written in words will be considered as final.

2. Rate

Bidders shall quote rates(s) / price(s) as per price format, Annexure - PF enclosed along with Enquiry. The quoted price shall be firm for this job.

3. Validity

The offer shall be valid for 180 days from the date of submission of offer.

4. Payment

- 01 R.A. bill shall be paid.
- Payment to the workmen is to be done through bank transaction only.
- EPF and Bank Challans are to be submitted along with RA bill on monthly basis.

5. **ESI:** You have to arrange ESI coverage for manpower engaged for the work.

6. **Gate Pass:** Bidders have to arrange gate pass on their own for 12 (Twelve) persons at least so that full quota of manpower (10 Nos.) could be supplied.

7. **Penalty:** Penalty will be imposed as per manpower basis for Skilled, Semi-skilled and Unskilled wage rate.

8. Agreed Liquidated Damage

If successful bidder fails to execute the order within the agreed completion period, they shall be liable to pay as agreed liquidated damages a sum @1/2% of the order value per week or part thereof of delay subject to a maximum of 5%. In case of delay beyond 10 weeks. UCIL reserves the right to cancel the order and levy penalties.

9. Cancellation of Order

It will be your endeavour to execute the work order to our satisfaction. In case of your failure to do so, the order is liable to be cancelled.

11. Disputes


