The Tenderers are advised to visit the site to acquaint themselves as to the n ature and location of the work, the general and local conditions particularly tho se bearing upon transportation, physical condition of the site conditions of the ground, quality and quantity of surface to be encountered, the character of eq uipment and facilities needed preliminary to and during the progress of the wo rk, and all other matters which can be of, in any way affect the work the cost t hereof under the contract. Tenderer must have qualified persons with full kno wledge and experience to carry out these jobs.
- 2. <u>VALIDITY OF TENDER</u>: The offer shall be valid for at least <u>Six Months</u>.
- 3. Period of Contract: Time of completion for this work shall be 01 (One)Year.
- 4. <u>TENDERER'S ADDRESS</u>: Tenderer's with valid address and telephone number (s) for contacting them for all 24 hours shall be given then only their case will be considered. Tenderers without valid addr ess and telephone numbers shall be rejected.

4.1. Performance Security (Security deposit): Total amount of Performance Security will be 10 % of t he awarded value of work. The contractor has to deposit 5% of the total value of work as initial Performan ce Security in the form of DD/DAC/TDR/FOR from SBI or any Indian nationalized bank at the time of agreem ent within 15 days of issue of the work order. In addition to the above further amount to the extent of 5% of the value of work shall be deducted from the Running Account bills by way of percentage deductions. S uch percentage deduction shall be @ 10% of the running account bills till the full amount of Performance S ecurity is realized / retained by the Corporation.

- 5. Income Tax, Sales Tax will be deducted as per norms of the Corporation, if applicable.
- 6. The quoted rate must be inclusive of all taxes and duties. The quoted rate must also be inclusive of GST, if applicable. UCIL shall not pay any GST.
- 7. Contractor has to give a certificate of liability for damage done by their employees/workers. Contrac tor has to provide detail address of their employees/workers engaged for this work.

15. Payment terms:

Only one bill shall be payable every month against submission of duly certified bill after joint measurement . Bill payment shall be payable only through e-payment. The decision of Engineer In charge in this matter shall be final.

- 16. **Penalty:** Contractor shall ensure to maintain minimum 437 numbers of skilled workmen and 138 number s of semiskilled/unskilled workmen deployed in each month.
 - Penalty shall be imposed as per following:
 - a) Penalty for non-deployment of less than minimum 437 numbers of skilled workmen and 138 numbers of semiskilled/unskilled workmen:

For skilled person: Rs 300/head/day

For semiskilled/unskilled person: Rs 200/head/day

a) Party shall submit labour insurance policy before commencement of work. Tools-tackles & s afety appliances as per NIT shall be brought before start of work. Failing to this outstanding p ayment will not be released.

Risk and Cost Pay:-

Failure to supply required numbers of manpower on a sustained manner may attract Risk and Cost Pay. En gineer In-charge shall intimate on writing to contractor to maintain the required numbers of manpower as per NIT terms. If a contractor fails to improve the supply as per requirement within 15 day of intimation on writing, management shall have full right to execute the work by some other contractor. UCIL shall have re serve to take appropriate action including blacklisting in case of invocation of this clause.

- 17. During execution of the contract, if it is observe that contractor is not able to supply required number of w ork force and work is getting hamper. Then the competent authority shall have the right to get the work do ne by engaging other capable external Agency/Agencies at the risk and cost of the Contractor and manag ement may terminate the work order.
- 18. Party shall submit labour insurance policy before commencement of work. Failing of this outstanding pay ment will not be release.

PROCEDURE FOR ENGAGING PERSONS AS PER THIS TENDER:

- **a.** <u>Intimation of Appointment & Termination</u>: For each person intended to be appointed or ter minated by the contractor as per this tender, the tenderer will have to submit a letter to the Engin eer-in-charge declaring his intention to appoint or terminate, as the case may be, accompanied by such other particulars, documents and in such format as may be prescribed by the Engineer-in-charge.
- b. <u>Medical Examination</u>: All persons before their actual engagement in any work will have to be medically examined and in case found to be medically fit will be considered for engagement. MEDI CAL EXAMINATION (IME and PME) is to be done (for all contract labours) and their Medical Reports will be deposit to the office of Mine Manager before engaging them in the actual operations.

The IME and PME should be done as per the form "O" and also include the following:

- i. Chest X-RAY (Single posterior and Alterior)
- ii. Spiro gram (Pulmonary function test, including determination of forced vital

Capacity (FVC) and Forced Expiratory volume at 1 second (FEVI).

Note: <u>L-1 bidder is requested to collect form "O" during the receiving of LOI.</u>

c. <u>Vocational Training</u>: All the persons who are required to be imparted vocational training under the Mines Vocational rules, 1966 will have to be imparted vocational training at the Group VTC, Jad ugoda/Narwapahar before engaging them in the actual operations. Please collect the letter of VTC training from the office of Mine Manager after receiving of LOI.

Note: All Medical Examination and VTC training shall be done in between receipt of LOI and startin g of work.

- 20. All the work shall be executed as per existing site conditions and no extra claim shall be entertained.
 - 21. All Safety precautions should be maintained during execution of work. Contractor should arrange all the applicable Safety appliances like Safety belt, helmet, gloves and gumboot etc and tools to his e mployees engaged for this work at their own cost & documentary evidence shall be submitted for p rocurement and providing the same. UCIL shall not provide any safety appliance under any circumst ances. All the jobs must be done with utmost safety precautions as stipulated by DGMS, AERB and other statutory authorities.
 - 22. <u>INSURANCE</u>: The insurance will be covered as per rules and the insurance coverage for number of p ersons engaged for the work shall be for the whole period of contract and is to be submitted to corp oration before commencement of the work. The contractor should also ensure the adequate numbe r of workmen is provided for this work.
 - 23. Contractor shall be solely responsible for any damages, theft, pilferage during lifting, loading, unloa ding, shifting and transportation of materials, machine. Proportionate amount shall be recovered for such damages from final payment and discretion of Engineer-in-charge in this matter will be final.
 - 24. All the rates quoted by Tenderer shall be inclusive of necessary staging, scaffolding and all other arr angement whichever is necessary to complete the work at no extra cost to the corporation for any i tem of the work.
 - 25. In case of stoppage of work by local people/Bandh or any other reason, no idle charges will be paid by corporation towards Labour, Plant and Machinery etc to the contractor for this work.

- 26. No carriage/transportation for any material except otherwise stated in schedule of quantities shall b e paid by the corporation. Contractor should quote their rates for the item accordingly.
- 27. Contractors shall strictly abide by the security rules and regulations enforced by the owner.
- 28. MEDICAL CARE: The contractor shall be fully responsible for first aid and emergency medical treatm ent to his employees. Necessary arrangement for this purpose shall be made by the contractor at t he site. In serious case medical facilities of UCIL may be available on chargeable basis.
- 29. All the labour laws with rules shall be followed strictly as per contract labour (Regulation and aboliti on) Act 1970. All registers, form stipulated under minimum wages (central rules) Act 1950 must be maintained by the contractor and to be furnished to the corporation before the commencement of w ork. In case of non-submission of the above registers/forms to the corporation regularly, the contrac tor shall not be allowed to continue the work. The contractor has to pay minimum wages as per rule s. The contractor will also be required to deposit PF contribution (both) regarding his employees.

In the event of breach of aforesaid conditions the contractor shall be open for action as deemed pr oper by the contract labour authorities of the Central Government.

As per the provision of Contract labour (Regulation & Abolition) Act 1970 and central rules thereof, payment of wages to his employees is to be made within the stipulated time period in the presenc e of the officer – in – charge for the work.

- 30. There will be 06 (Six) months defect liability period for this work.
- 31. The contractor shall draw the material either on chargeable basis or free of cost from the departme nt or stores at Jaduguda/Narwapahar/Turamdih as stipulated in the contract from time to time depe nding upon the requirement at site. Transportation of material from Turamdih stores to the work sit e shall be done by the contractor only. Drawal of material surplus to the requirement is prohibited. If, however, after completion of work surplus material/scrap are left with the contractor, the same m ust be returned to the stores or as directed by Engineer-in-charge.
- 32. <u>MODE OF PAYMENT AGAINST RA BILLS</u>: Bill payment shall be payable only through e-payment. Cont actor has to submit their e-payment details to Accounts Department Jaduguda/Turamdih. Required document for e-payment: (i) Application for e-payment (ii) Cancelled Cheque (iii) Pan Card Xerox. If already registered with e-payment then please ignore.
- 33. The value of contract is only estimated value for a period of one year and it may vary to the extent of \pm 10% of the total value of contract.
- 34. xxx.
- 35. Normal working will be six days a week. However, the contractor may be required to deploy workm en on Sundays, if the need arises. Sometimes it may be required that due to unavoidable reasons t he work could not be completed during a shift and in such cases, the contractor may be asked to d eploy work men in C shift also.

36. Tools & Tackles

The L1 bidder have to provide tools & tackles of approx. Rs. 1,00,000/- as per the requirement and instruction of Engineer-In-Charge and the expenditure towards the same will be reimbursed to the m by the corporation on submission of documents / proof of receipt. The tools and tackles provide d by the contractor as per the estimated amount of Rs. 1,00,000/- against the tender will be comp any's asset after completion of the contract.

- 37. All other terms and conditions shall be applicable as per General Conditions of UCIL's tender norms.
- 38. In the event of any confusion or ambiguity between GeM SLA (Service Level Agreement) conditions; UCIL' s Additional Terms & Conditions (ATC), then UCIL's ATC shall supersede all GeM SLA conditions and shall b e binding on the contractor.

General Conditions of Contract

A) INTERPRETATIONS AND DEFINITIONS

1. Singular and Plural

Where the context so requires, words importing the singular only also include the plural and vice versa.

2. Heading and Marginal Notes to conditions:

Heading and marginal notes to these General Conditions shall not be deemed to form part there of or be taken into consideration in the interpretation or construction thereof or of the Contract.

3. **Definitions:**

- a) Corporation' shall mean Uranium Corporation of India Limited having it's registered office at Jadugoda Mines, Post office and Town Jadugoda Mines 83 2102, in the state of Jharkhand and includes a duly authorized representative of the Corporation or any other person empowered in this behalf by the Corporation to discharge all or any of its function.
- b) The `Accepting Authority' shall mean the authority mentioned in Schedule F.
- c) The `Contract' shall mean the notice inviting the tender, the tender, and acceptance thereof an d the formal agreement, if any, executed between the Corporation and the Contractor together with the documents referred to therein including these conditions, Designs, Drawings, Schedule of Quantities with rates and amounts and Schedule of Rates. All these documents taken togeth er shall be deemed to form one Contract and shall be complementary to one another.
- d) The `Contractor' shall mean the individual or firm or company whether incorporated or not, un dertaking the works and shall include legal representatives of such individual or persons compo sing such firm or unincorporated company, or successors of such firm or company as the case may be and permitted assigns or such individual or firm or company.
- e) The `Contract Sum' shall mean:
 - i) In the case of Lump Sum Contracts the sum for which the tender is accepted.

ii) In the case of percentage Rate Contracts the estimated value of the works as mentioned in t he tender adjusted by the Contractor's percentage.

iii) In the case of Item Rate Contracts the cost of the works arrived at after multiplying of the qu antities shown in Schedule of Quantities by the item rates quoted by the Tenderer or as finally a ccepted for the various items.

f) A `Day' shall mean a day of 24 hours from midnight to midnight irrespective of the number of hours worked in that day.

iii) In the case of Item Rate Contracts the cost of the works arrived at after multiplying of the qu antities shown in Schedule of Quantities by the item rates quoted by the Tenderer or as finally a ccepted for the various items.

- g) Engineer-in-charge' shall mean the Engineering Officer appointed by the Corporation or his dul y authorized representative who shall direct, supervise and be in-charge of the works for purpos e of this Contract.
- h) `Excepted Risks' are risks due to riots (otherwise than among Contractors' Employees) and civil commotion (in so far as both these are uninsurable), war (whether declared or not), invasion, ac t of foreign enemies, hostilities, civil war, rebellion, revolution, insurrection, damage from aircraf t, acts of god such as earth quake, lightning and unprecedented floods and other causes over w hich the Contractor has no control and accepted as such by the Accepting authority.
- i) `Market Rate' shall be the rate as decided by the Engineer-in-charge on the basis of the cost of materials and labour at the site where the work is to be executed, plus the percentage mentione d in Schedule F to cover all overheads and profit.
- j) Schedule(s) referred to in these conditions shall mean the relevant Schedule(s) annexed to the tender papers issued by the Corporation or the standard Schedule of Rates prescribed by the Co rporation and the amendments thereto issued from time to time.
- k) The `Site' shall mean the lands and/or other places on, under, in or through which the work is t o be executed under the Contract including any other lands or places which may be allotted by the Corporation or used for the purposes of the Contract.
- I) Temporary Works' shall mean all temporary works of every kind required in or about the exec ution, completion, maintenance of the works.
- m) `Urgent Works' shall mean any urgent measures, which, in the opinion of Engineer-in-Charge, b ecome necessary during the progress of the works, obviate any risk of accident or failure of whic h become necessary for security.
- n) A `Week' shall mean seven days without regard to the number of hours worked any day in tha t week.
- o) The `Works' shall mean the works to be executed in accordance with the Contract or part(s) th ereof as the case may be and shall include all extra or additional, altered or substituted works or temporary and urgent works as required for performance of the Contract.

B) SCOPE AND PERFORMANCE

4. Contract Documents:

The Contractor shall be furnished, free of charge, two certified true copies of the Contract docum ents except standard specification, the Schedule of Rate and of all further drawings, which may be issued during the progress of the works. He shall keep one copy of the Documents on the site in g ood order and the same shall at all reasonable times be available for inspection and use by the En gineer-in-Charge, his representative or other Inspecting Officer.

- 4.1 None of these documents shall be used by the Contractor for any purpose other than that of this Contract.
- 4.2 The Contractor shall take necessary steps to ensure that all persons employed on any work in co nnection with Contract have noticed that the Indian official secret act 1923(XIX of 1923) applied to them and shall continue so to apply even after the execution of such works under the Contract.

5. Works to be carried out:

The work to be carried out under the Contract shall except as otherwise provided in these condit ions, include all labour, materials, tools, equipment and transport which may be required in prepar ation of and for and in the full and entire execution and completion of the works. The descriptions given in the Schedule of Quantities shall, unless otherwise stated, be held to include waste on mat erials, carriage and cartage carrying in return of empties, hoisting, setting, fitting and fixing in posi tion and all other labourers necessary in and for the full and entire execution and completion as af oresaid in accordance with good practice and recognized principles.

6. Inspection of site:

The Contractor shall inspect and examine the site and its surrounding and shall satisfy himself b efore submitting his tender as to the nature of the ground and sub-soils(so far as is practicable), th e form and nature of the site, the quantities and nature of work and materials necessary for the co mpletion of the works and the means of access to the site, the accommodation he may require, av ailability of labour, water, electric power. In general he shall himself obtain all necessary informati on as to risks, contingencies and other circumstances which may influence or affect his tender. No extra charges consequent on any misunderstanding or otherwise shall be allowed.

7. Sufficiency of Tender:

Description of item in the Schedule of quantities is brief and therefore, shall be read in conjuncti on with the relevant drawings and specifications and the Contractor's rate shall be deemed to be f or such complete work unless otherwise specified by the Contractor while tendering. No claim, wh atsoever, shall be entertained by the Corporation on account of insufficiency of any rate as quoted in the Schedule of Quantities and rates. The Contractor shall be deemed to have satisfied himself before tendering as to the correctness and sufficiency of his tender of the works and of the rates a nd prices quoted in the Schedule of Quantities, in which rates and prices shall, except as otherwise provided, cover all his obligations under the Contract and all matters and things necessary for the proper completion, maintenance of works and shall also cover the cost of necessary protection, inc luding labour, materials and equipment to ensure safety and protection against all risks, accidents compensation for injury to life and damage to property if any caused by the Contractor's operation s connected with the work. The rates shall be firm and shall not be subject to change due to variat ion during the entire period of execution of the work in cost of materials, labour conditions or any o ther conditions whatsoever. The rates quoted by the Tenderer shall be inclusive of all taxes, dutie s and other statutory levies.

8. Discrepancies and Adjustment of Errors:

The several documents forming the Contract are to be taken as mutually explanatory of one ano ther, detailed drawing being followed preference to small-scale drawings and the figured dimensio ns in preference to drawing measured scale and the special conditions in preference to General Co nditions.

- 8.1 If there are varying or conflicting provisions made in any one document forming part of the Contr act, the Accepting Authority shall be the deciding authority with regard to the intention of the docu ment.
- 8.2 Any error in description, quantity or rate in Schedule of Quantities or any omission there from sh all not vitiate the Contract or release the Contractor from the execution of the whole or any part of the works comprised there in according to drawings and specifications or from any of his obligatio ns under the Contract.
- 8.3 If on check there are found to be difference between the rates given by the Contractor in words and figures or in the amount worked out by him in the Schedule of Quantities and general summar y the same shall be adjusted in accordance with the following rules:
 - a) In the event of a discrepancy between description in words and figures quoted by a Tenderer, t he description in words shall prevail.
 - b) In the event of error occurring in the amount column of Schedule of Quantities as a result of wr ong extension of the Unit rate and quantity, the Unit rate shall be regarded, as firm and extensio n shall be amended on the basis of the rate.
 - c) All errors in totalling in the amount column and carrying forwarded totals shall be corrected.
 - d) The totals of various sections of Schedule of Quantity appended and amended shall be carried over to the general summary and the tendered such amended accordingly. The tendered sum s o altered shall, for the purpose of the tenders be substituted for sum originally tendered and con sidered for acceptance instead of the original sum quoted by the Tenderer. Any rounding off of totals in various sections of Schedule of quantities or in general summary by the Tenderer shall be ignored.
 - e) In case of lump sum Contracts (based on bills of quantities/ quantity not shown as provisional), should any error in quantities or any omissions of items be discovered, the cumulative effects of which varies Rs. 20,000/- whichever is less, then the errors shall be rectified and the rectificatio

ns dealt with as for deviations/variations under conditions 10 and 11 hereof, and the value there of shall be added or deducted from the Contract sum, as the case may be, provided that there s hall be no rectification of any errors, omissions or wrong estimates in the prices inserted by the Contractor in the Bills of quantities.

9. Performance Security (Security deposit) :

Total amount of Performance Security shall be limited to 3 % of the awarded value of work. Fifty percent of this amount shall have to be deposited as initial Performance Security at the time of execution of agreement

- (a) Acceptable mode of payment of Initial Performance Security.
- i) For deposit up to Rs. 5000/- : Cash/Demand Draft payable at SBI or any other nationalized bank payabl e at Jaduguda/Hartopa.
- ii) For deposit beyond Rs. 5000/- and up to Rs. 1.00 Lakh.: DAC/TDR/FDR etc. from any nationalized bank of schedule Banks duly pledged in favour of UCIL. But in case of Earnest Money of amount more than Rs. 50, 000/-, the Tenderer should submit Bank Guarantee issued by SBI, Jamshedpur/Hartopa or PNB, Jamshedpur or as mentioned in Para 9(a)(iii).
- iii) For deposit beyond Rs. 1.00 Lakhs: Bank Guarantee issued by SBI, Jaduguda/ Hartopa or Punjab Nation al Bank, Jamshedpur. Bank Guarantee obtained from any Indian nationalized bank of schedule banks to b e jointly, severally bound with the Contractor to the purchaser for the amount same above. The terms of t he said guarantee shall be such as shall be approved by the purchaser and the obtaining of such guarantee e and the cost of guarantee to be so entered shall be at the expenses, in all respects, of the Contractor. T he said guarantee shall be valid till the expiry of the defect liability period and issue of the final certificate by the Engineer, and with a claim period of Six months beyond it's required validity.

In addition to the above, further amount to the extent of the 1.5% of awarded value of the work wil I be deducted from the Running Account bills by way of percentage deductions. Such percentage d eduction shall be @ 10% of the running account bills till the full amount of performance security is realized/retained by the Corporation.

(b) All compensation or other sums of money payable by the Contractor under the terms of this conta ct or any other contact or any other account whatsoever may be deducted from or paid by sale of a sufficient part of his performance security or from the interest arising there from or from any su ms which may be due or become due to the Contractor by the Corporation or any account whatso ever and in the event of his performance security be reduced by reason of any such deduction or s ale as aforesaid, the Contractor shall within fourteen days of receipt of notice of demand from the Engineer-in-charge make good the deficit.

(c) **Refund of Performance Security (Security deposit):**

Initial Performance Security shall be refunded to the Contractor on the Engineer-in-charge certifyi ng in writing that the work has been completed as per condition 31 hereof etc.

(d) On expiry of the Defects liability period (referred to in condition 33 hereof) or after payment of the Final bill payable whichever is later, the Engineer-in-charge shall on request from the Contractor re fund to him the remaining portion of the Performance Security provided the Engineer-in-charge is s atisfied that there is no demand outstanding against the Contractor.

10. **Deviation/Variation Extent & Pricing**:

The Engineer-in-charge shall have power (i) to make alteration in, omissions from, additions to, or substitution for the original specification, drawings design and instructions that may appear to h im to be necessary or advisable during the progress of the work and (ii) to omit a part of the works in case of non availability of a portion of the site or for any other reasons and the Contractor shall b e bound to carry out the works in accordance with any instructions given to him in writing signed b y the Engineer-in-charge and such alterations, omissions additions or substitutions shall form part of the Contract as if originally provided therein and any altered, additional or substituted work whi ch the Contractor may be directed to do in the manner above specified as part of the works, shall

be carried out by the Contractor on the same conditions in all respects including price on which ag reed to do the main work except as hereinafter provided. No work which radically changes the ori ginal nature of the Contract shall be ordered by the Engineer-in-charge as a deviation and in the ev ent of any deviation being ordered which in the opinion of the Contractor changes the original natu re of the Contract, he shall nevertheless carry it out and the disagreement as to the nature of the work and the rate to be paid therefore shall be resolved in accordance with condition 52.

- 10.1 The time for completion of the works shall, in the event of any deviations resulting in additional c ost over the Contract sum being ordered, is extended as follows if requested by the Contractor.
 - a) In the proportion which the additional cost of the altered additional or substituted work, bears to the original Contract sum plus
 - b) 25% of the time calculated in (a) above or such further additional time as may be considered re asonable by the Engineer-in-charge.
- 10. b.1Rate for such additional altered or substituted work shall be determined by the Engineer-incharge as follows: -
 - If the rate for additional, altered or substituted items of works is specified in the Schedule of Qu antities, the Contractor shall carry out the additional, altered or substituted item at the same rat e. In the case of composite tenders, where two or more Schedules of Quantities may form part o f the Contract, the applicable rate shall be taken from the Schedule of Quantities of that particula r part in which the deviation is involved, failing that, at the lowest applicable rate for the same it em of work in the other Schedule of Quantities.
 - ii) If rate for any altered, additional or substituted item of work is not specified in the Schedule of Q uantities, the rate for that item shall be derived from the rate for the nearest similar item specified therein. In case of composite Tenders, where two or more Schedule of Quantities form part of the Contract, the rate shall be derived from the nearest similar item in the Bills of Quantiti es of the particular part of works in which the deviation is involved, failing that, from the lowest of the nearest similar item in other Schedule of Quantities.
 - iii) If the rate for any additional, altered or substituted item of work cannot be determined in the ma nner specified in sub-paras (i) and (ii) above, then such item of the work shall be carried out at t he rate entered in the C.P.W.D. Schedule of Rates (current) then plus/minus the percentage by w hich the tendered amount of the work actually awarded is higher or lower than the estimated am ount of the works actually awarded. (Applicable to measurement Contract is based on item rates or lump sum Contracts based on Bills of Quantities or percentage rate Contracts).
 - iv) If the rate for any altered, additional or substituted item of work cannot be determined in the ma nner specified in sub-Para (i) to (iii) above, the Contractor shall within 14 days of the date of rece ipt of the order to carry out the said work, inform the Engineer-in-charge of the rate which he pro posed to claim for such item of work, supported by analysis of the rate claimed, and the Enginee r-in-charge shall within three months thereafter, after giving due consideration to the rate claime d by the Contractor determine the rate on the basis of market rate(s). In the event of the Contra ctor failing to inform the Engineer-in-charge within the stipulated period of time, the rate, which he proposes to claim, the rate for such item shall be determined by the Engineer-in-charge on th e basis of market rate(s). for this purpose the purchase voucher etc. shall be produced by the C ontractor to the Engineer-in-charge.

11. Suspension of works:

The Contractor shall on receipt of the order in writing of the Engineer-in-charge suspend the pr ocess of the works or any part thereof for such time and in such manner, as the Engineer-in-char ge may consider necessary for and of the following reasons.

- i) On account of any default on part of the Contractor or
 - ii) For proper execution of the works or part thereof for reasons other than the default of the Contractor; or
 - iii) For safety of the works or part thereof.

12. TIME AND EXTENSION FOR DELAY:

The time allowed for execution of the works as specified in the Schedule - 'F' or the extended tim

e, in accordance with these conditions shall be of the essence of the Contract. The execution of th e work shall commence from the date of 15th day after the date on which the Engineer-in-charge i ssues written orders to commence the work or from the date of handing over the site whichever is later. If the Contractor commits default in commencing the execution of the work as aforesaid, Cor poration shall without prejudice to any other right or remedy be at liberty to forfeit the Earnest Mo ney/Performance Security absolutely.

13.1 As soon as possible, after the Contract is concluded, the Engineer-in-charge and the Contractor sh all agree upon a Time and Progress Chart. The Chart shall be prepared in direct relation to the tim e stated in the Contract Documents for completion of items of the work. It shall indicate the force of the dates of commencement and completion of various trades or sections of the work and may b e amended as necessary by agreement between the Engineer-in-charge and the Contractor within the limitation of time imposed in the Contract documents, and further to ensure good progress duri ng the execution of the work, the Contractor shall minimum in all cases in which the time allowed f or any work exceed one month (save for special jobs) complete 1/8th of the whole of the work befor re 1/4th of the whole time allowed in the Contract has elapsed 3/8th before 3/4th of such time has elapsed.

13.2 If the works be delayed by

- (a) Force major, or
- (b) Abnormally bad weather, or
- (c) Serious loss or damage by fire, or
- (d) Civil commotion, local combination of workmen, strike or engaged by Corporation in exec uting work not forming part of the Contract, or
- (e) Delay on the part of other Contractor or tradesman engaged by Corporation in executing work on to forming part of the Contract, or
- (f) Non-availability of stores which are the responsibility of Corporation to supply, or
- (g) Non-availability or break-down of Tools and Plant to be supplied or supplied by Corporatio n or
- (h) Any other cause, which, in the absolute discretion of the Corporation, is beyond the Contra ctor's control.
 Then upon the happening of any such event causing delays, the Contract shall immediatel y give notice thereof in writing to the Engineer-in-charge but shall nevertheless use consta ntly his best endeavors to prevent or make good the delay and shall do all that may be rea sonably required to the satisfaction of the Engineer-in-charge to proceed with the work.
- 13.3 Request for extension of time to be eligible for consideration shall be made by the Contractor in writing within fourteen days of the happening of the event causing delays. The Contractor may also, if practicable indicate, in such request, the period for which extension is desired.
- 13.4 In any such case, the Corporation may give a fair and reasonable extension of time for completion of the work. Such extension shall be communicated to the Contractor by the Engineer-in-charge in writing within 3 months of the date of receipt of such requests by the Engineer-in-charge.
- 14. The Contractor shall arrange at his own expenses all tools, plant and equipment (hereinafter refe r to as T & P) required for execution of the work.
- 14.1 If the Contractor required any item of T & P on hire from the Corporation, the Corporation will, if s uch item is available and the same can be spared, hire it to the Contractor at a rate to be fixed by the Engineer-in-charge.
- 14.2 The period of hire will be reckoned from the commencement of the day of issue up to the end of t he day of return (including all recognized holidays) irrespective of the actual hour of issue and retu rn. The Contractor will be exempt from levy of any charges for the number of days he is called up on in writing by the Engineer-in-charge to suspend execution of the work, provided Corporation's T & P in question has, in fact, remained idle with the Contractor because of the suspension, provided the Contractor, in case the period of suspension, exceeds 11 days returns Corporation's T & P to th e place from where the same was issued.
- 14.3 The Contractor shall be responsible for care and custody of Corporation's T & P (including employment of Security gad) during the period Corporation's T & P r emain with him and any damage (fair wear and tear excepted) to any of the eq

uipment shall be made good at the Contractor's expense to the satisfaction of the Engineer-in-charge, unless, such damage is caused because of negligence of crew provided by the Corporation.

- 14.4 The Corporation give no guarantee in respect of output of his T & P hired to the Contractor and no reduction in rates or any compensation shall be allowed on the ground that outturn or performanc e of Corporation's T & P was not to the Contractor's expectations.
- 14.5 Corporation's T & P hired to the Contractor shall be returned at the place of issue (unless otherwis e directed) by the Contractor to the Engineer-in-charge on completion of the work or section of the work or earlier on termination of the hire by the Corporation as hereinafter provided on a written n otice by the Engineer-in-charge. The Corporation shall be entitled to terminate the hire on two da ys notice without assigning any reason whatsoever on account of termination of hire of Corporation n's T & P by the Corporation. In such an event however, a reasonable extension of time shall be gi ven by the Engineer-in-charge.
- 14.6 A Log Book for recording hours during which every item of Corporation's T & P issued to the Contr actor has worked each day, shall be maintained by the member of the crew-in-charge thereof or a ny representative of the Engineer-in-charge appointed in that behalf and shall be daily attested by the Contractor or his authorized agent. In case the Contractor contest correctness of any entry an d/or fails to sign the Log Book, the decision of the Engineer-in-charge shall be final and binding on him.

Hire charges shall be calculated in accordance with the Log Book recorded time or as per term hiri ng as the case be.

15.0 **MATERIALS**:

- 15(a) The Contractor shall, at his own expense, provide all materials required for the works other than th ose, which are to be supplied by the Corporation.
- 15(a)1. All materials to be provided by the Contractor shall be, in conformity with the specification laid do wn in the relevant Indian Standard and the Contractor shall, if required by the Engineer-in-charge, furnish proof, to the satisfaction of the Engineer-in-charge, that the material so comply with the sp ecifications.
- 15(a)2 The Contractor shall at his own expense and without delay supply to the Engineer-in-charge sampl es of materials proposed to be used in the works. The Engineer-in-charge shall, within seven days of supply of samples or within such further period as he may require, intimate to the Contractor in writing, whether samples are approved by him or not. If samples are not approved, the Contractor shall forthwith arrange to supply to the Engineer-in-charge, for his approval, fresh samples complyi ng with the specifications laid down in the Contract.
- 15(a)3. The Engineer-in-charge shall have powers to require removal of all of the materials brought at site by the Contractor which are not in accordance with the Contract specifications or do not conform i n character or quality to samples approved by him. In case of default on the part of the Contractor in removing rejected materials, the Engineer-in-Charge shall have full powers to procure other pro per materials to be substituted for rejected materials and in the event of the Contractor refusing to comply; he may cause the same to be supplied by other. All costs, which may accrue upon such r emoval and/or substitution, shall be borne by the Contractor.
- 15(a)4. The Contractor shall indemnify the Corporation servant or employee of the Corporation against an y action, claim or proceeding relating to infringement or use of any patent or design or any other c harges which may be payable in respect of or any article or materials or part thereof included in th e Contract. In the event of any claim being made or action being made or action being brought ag ainst the Corporation in respect of any such matters as aforesaid, the Contractor shall furnish inde mnity immediately, provided that such indemnity shall not apply when such infringement has take n place in complying with the specific directions/issued by the Corporation. But the Contractor shall I pay any royalties or other charges payable in respect of any such use, the amount so being reim bursed to the Contractor only if the use was the result of any drawing and/or specification issued af ter submission of the Tender.
- 15(a)5. All charges on account of Octroi, Terminal or Sales Tax and other duties or materials obtained for t he works from any source (excluding materials supplied by the Corporation) shall be borne by the

Contractor.

15(a)6.The Engineer-in-charge shall be entitled to have tests carried out for any materials supplied by the Contractor other than those for which satisfactory proof has already been furnished, at the cost of the Contractor and the Contractor shall provide at his expense all facilities, which the Engineer-incharge may require for the purpose.

15(b) Materials to be supplied by the Corporation:

Materials to be supplied by the Corporation are shown in Schedule - B which also stipulates quan tum, place of issue and rate(s) to be charged in respect thereof.

- 15(b)1. If after acceptance of the tender, the Contractor desires the Corporation to supply any other mater ials, such materials may be supplied by the Corporation, if available, at rates to be fixed by the En gineer-in-Charge and all on payment before the materials are issued to the Contractor.
- 15(b)2. For the materials listed in Schedule-B, which the Corporation has agreed to supply the Contractor, he shall give reasonable notice in writing about his requirements to the Engineer-in-charge in acco rdance with the agreed phases of programme. Such materials shall be supplied for the purpose of the Contract of aforesaid Schedule, shall be set off or deducted, as and when materials are consu med in item of work for which payment is being made to the Contractor, or from any sums then du e or which may after become due to the Contractor from/under the Contract. At the time of submi ssion of bills the Contractor shall properly account for the materials issued to him to the satisfactio n of the Engineer-in-charge and certify that balance of materials supplied is available at site.
- 15(b)3. The Contractor shall bear the cost of loading, transporting to site, unloading, storing under cover a s required, assembling and joining the several parts together as necessary, incorporating of fixing materials in the works including all preparatory work of whatever description as may be required.
- 15(b)4. All materials issued to the Contractor by the Corporation for fixing in the works (including preparat ory work), and being surplus on completion or on foreclosure of the work be returned by the Contr actor at his expense, at wear and tear and/or waste. If the Contractor is required to deliver such materials at a place other than the place of issue, he shall do so and the transportation charges fro m the site to such place, less the transportation charges which would have been incurred by the C ontractor had such materials been delivered at the place of issue, shall be borne by the Corporatio n.
- 15(b)5. Surplus materials returned by the Contractor shall be credited to him by the Engineer-in-charge at rates not exceeding those at which these were originally issued to him after taking into considerati on any determination or damage which may have been caused to the said materials whilst in the c ustody of the Contractor.
- 15(b)6. If on completion of works the Contractor fails to return surplus materials out of these supplied by t he Corporation, then in addition to any other liability which the Contractor would incur, the Engine er-in-charge may, by a written notice to the Contractor require him pay within a fortnight of receip t of the notice, for such unreturned surplus materials at double the issue rates.

15(b)7. Delay in obtaining materials by the Corporation:

Owing to difficulty in obtaining certain controlled and other materials in the market, the Corpora tion has undertaken to supply them as specified in Schedule - B, there may be delay in obtaining t hese materials by the Corporation and the Contractor is therefore, required to keep himself in touc h with the day to day position regarding the supply of materials from the Engineer-in-charge and to so adjust the progress of the work that their labour may not remain idle nor may there by any othe r claim due to or arising from delay in obtaining the materials. It should be clearly understood that no claim whatsoever shall be entertained by the Corporation on account of delay in supplying mat erials.

15(c) <u>GENERAL</u>

Materials required for the works, whether brought by the Contractor or supplied by the Corporati on, shall be stored by the Contractor only at places approved by the Engineer-in-charge. Storage and safe custody of materials shall be the responsibility of the Contractor.

15(c)1. Corporation official concerned with the Contract shall be at liberty any time to inspect and exami ne any materials intended to the use in or on the works, either on the site or at factory or worksho p or other place(s), where such materials are assembled, fabricated, manufactured or any place(s)

where these are lying or from which these are being obtained and the Contractor shall give such fa cilities as may be required for such inspection and examination.

15(c)2. Materials supplied by the Corporation and brought to the site by the Contractor shall not be remov ed off the site without the prior written approval of the Engineer-in-Charge. But whenever the wor ks

are finally completed, the Contractor shall at his own expense forthwith return to the all-surplus m aterials originally supplied to him as per stipulation in the Contracts.

16. **LABOUR**

The Contractor shall employ labour in sufficient numbers to maintain the required rate of progre ss and of quality to ensure workmanship of the degree specified in the Contract and to the satisfac tion of the Engineer-in-Charge. The Contractor shall not employ in connection with the works any person who has not completed his eighteen years of age.

- 16.1 The Contractor shall furnish to the Engineer-in-Charge at the intervals as decided by E.I.C., a distribu tion return of the number and description by trades of the work, people employed on the works. T he Contractor shall also submit on the 4th and 19th of every month to the Engineer-in-Charge a tr ue statement showing in respect of the second half of the preceding month and the first half of the current month (i) the accident that occurred during the said fortnight showing the circumstances under which they happened and the extent of damages and injury caused by them and (ii) the nu mber of female workers who have been allowed Maternity Benefit as provided in the Maternity Ben efit Act 1961 or Rules made there under and the amount paid to them.
- 16.2 The Contractor shall pay to labour employed by him wages not less than fair wages as defined in th e Contract Labour (Regulation & Abolition) Act, 1970 and Rules made there under.
- 16.3 The Contractor shall in respect of labour employed by him comply with or cause to be complied wit h the Contract Labour (Regulation & Abolition) Act, 1970 and Rules made there under in regard to all matters provided therein.
- 16.4 The Contractor shall comply with the provision of the payment of Wages Act, 1936, Minimum Wages Act, 1948, Employees Liability Act, 1938, Workmen's Compensation Act, 1923, Industrial Dispute A ct, 1947, Maternity Benefit Act, 1961 and Mines Act, 1952 or any modifications thereof or any othe r Law relating thereto and rules made there under from time to time.
- 16.4(a) The Contractor shall be liable to pay his contribution and the Employees Contribution to the Emplo yees State Insurance scheme in respect of all labour employed by him for the execution of the Con tract, in accordance with provision of `The Employees State Insurance Act, 1948' as amended from time to time and as applicable in this case. In case the Contractor fails to submit full details of his account of labour employed and the contribution payable, the Engineer- in-Charge shall recover fro m the running bills of Contractor an amount of Contribution as assessed by him. The amount so re covered shall be adjusted against the actual contribution payable under Employees State Insuranc e scheme.
- 16.5 The Engineer-in-charge shall on a report having been made by an Inspecting staff as defined under t he Contract Labour (Regulation) Act, 1970 and rules made there under have the power to deduct t he money, due to the Contractor, any sum required estimated to be required for making good the l oss suffered by a worker or workers by reason of no fulfilment of the conditions of the Contract for the benefit of workers, non-payment of wages or of deduction made from his or their wages which are not justified by the terms of the Contract or non-observance of the said act.
- 16.6 The Contractor shall indemnify the Corporation against any payment to be made under and for obs ervance of the Contract Labour (Regulation & Abolition) Act, 1970 and Rules made there under wit hout prejudice to his right to claim indemnity from his Sub-Contractors.
- 16.7 In the event of the Contractor committing a default or breach of any of the provisions of aforesaid A ct and rules made amended/amended from time to time, or furnishing any information or submitti ng or filling any Form/Register/Slip under the provisions of the Law which is materially incorrect, th en on the report of the Inspecting Officer, the Contractor shall without prejudice pay to the Corpor ation a sum not exceeding liabilities for such defaults including liquidated damages etc. for every d efault, breach or furnishing, making, submitting, filling materially incorrect statement, as may be fi xed by the Labour Department and the Contractor should indemnify the Corporation against all su ch liabilities.

16.7.1 Model Rules for Labour Welfare:

The Contractor shall at his own expense comply with or cause to be complied with Model Rules f or Labour Welfare as provided under the Rules framed by the appropriate government from time t o time for the protection of health and for making sanitary arrangements for workers employed dir ectly or indirectly on the works. In case the Contractor fails to make arrangements as aforesaid, th e Engineer-in-charge shall be entitled to do so and recover the cost thereof from the Contractor.

Failure to comply with Model Rules for Labour Welfare, Safety code or the provisions relating to re port on accidents and to grant Maternity Benefits to female workers shall make the Contractor liable to pay to the Corporation as liquidated damages an amount not exceeding Rs. 50.00 for eac h default on materially incorrect statement or reports from the Engineer-in-charge in such matters , based on reports from the Inspecting officers shall be final and binding and deductions for recove ry of such liquidated damages may be made from the any amount payable to the Contractor.

17. The Contractor shall not be permitted to enter on (other than for inspection purpose) or take pos session of the site until instructed to do so by the Engineer-in-charge in writing. The portion of the site to be occupied by the Contractor shall be defined and/or marked on the site plan, failing whic h these shall be indicated by the Engineer-in-charge at site and the Contractor shall on no account be allowed to extend his operations beyond these areas.

In respect of any land allotted to the Contractor for purpose of or in connection with the Contract , the Contractor shall be a licensee subject to the following and such other terms and the licenser may impose conditions as:

- i) That he shall pay a nominal license fee of Rs. 1 per year or part of a year for use and occ upation, in respect of each and every separate area of land allotted to him
- ii) That such use or occupation shall not confer any right of tenancy of the land to the Contra ctor
- iii) That the Contractor shall be liable to vacate the land on demand by the Engineer-in-charg e.
- iv) That the Contractor shall have no right to any construction over this land without the writ ten permission of the Engineer-in-charge. In case he is allowed to construct any structure he shall have to demolish and clear the same before handing over the completed work unl ess agreed to the Corporation.
- 17.1 The Contractor shall provide, if necessary or if required on the site all tempora ry access there to and shall alter, adopt and maintain same as required from t ime to time and shall take up and clear them away as and when no longer req uired and as and when ordered by the Engineer-in-charge and make good all d amage done to the site.

18. SETTING OF THE WORKS:

The Engineer-in-Charge shall supply dimensioned drawings, levels and other information necess ary to enable the Contractor to set out the work. The Contractor shall provide all labour and settin g out appliances required and set out the work and be responsible for the accuracy of the same. H e shall amend at his own cost and to the satisfaction of the Engineer-in-charge any error found at a ny stage which may arise through inaccurate setting out unless such error is based on incorrect da ta furnished in writing by the Engineer-in-charge, in which case cost of rectification shall be borne by the Corporation. The Contractor shall protect and preserve all benchmarks used in setting out t he works till end of the Defect Liability Period unless the Engineer-in-Charge directs their earlier re moval.

19. SIDE DRAINAGE:

All water, which may accumulate on the site during the progress of works or in trenches and exc avations, shall be removed from the site to the satisfaction of the Engineer-in-charge and at the Co ntractor expenses.

20. **NUISANCE**:

The Contractor shall not at any time do, cause or permit any nuisance on the site or do anything

which shall cause unnecessary disturbance, inconvenience to owners, tenants or occupiers of othe r properties near the site and to the public generally.

21. MATERIALS OBTAINED FROM EXCAVATION:

Materials of any kind obtained from excavation on the site shall remain the property of the Corpo ration and shall be disposed of as the Engineer-in-charge may direct.

22. TREASURE TROVE, FOSSILS ETC.:

All fossils, coins, articles of value or antiquity and structures and other remains or things of geol ogical or archaeological interest discovered on the site shall be the absolute property of the Corpor ation and the Contractor shall take reasonable precautions to prevent his workmen or any other pe rson from removing or damaging any such articles or thing and shall immediately open discovery t hereof and before removal, acquaint the Engineer-in-charge and obtain his directions as to the dis posal of the same at the expense of the Corporation.

23. **PROTECTION OF TREES**:

Tree designated by the Engineer-in-charge shall be protected from damage during the course of the works and earth level within 1.0 Mtr. of each such tree shall not be changed. Where necessary , such trees shall be protected by providing temporary fencing.

24. WATCHING AND LIGHTING:

The Contractor shall provide and maintain at his own expense all lights, guards, fencing and wat ching when and where necessary or required by the Engineer-in-charge for the protection of the w orks or for the safety and convenience of those employed on the works or the public.

25. CONTRACTOR'S SUPERVISION - SUPERVISORY STAFF:

The Contractor shall engage and keep at site, qualified technical staff/engineer with necessary s upporting supervisory staff of sufficient experience of all types of works covered by this Contract a nd they should have all necessary authority to receive materials from the Corporation, issue valid receipt for the same, engage labour etc. and proceed with the work as required for speedy executi on of the work.

26. **INSPECTIONS AND APPROVAL**:

All works embracing more than one process shall be subject to examination an d approval at each stage thereof and the Contractor shall given due notice to t he Engineer-in-Charge or his authorised representative when each stage is rea dy. In default of such notice the Engineer-in-Charge shall be entitled to apprai se the quality and extent thereof.

- 26.1 No work shall be covered up or put out of view without the approval of the Engineer-in-charge or h is authorized representative and the Contractor shall afford full opportunity for examination and m easurement of any work which is about to be covered up or put out of view and for examination fo undations before permanent work is placed thereon. The Contractor shall give the notice to the En gineer-in-Charge or his authorized representative whenever any such work or foundation is ready f or examination and the Engineer-in-charge or his representative shall without unreasonable delay, unless he considers it unnecessary and advises the Contractor accordingly; attend for the purpose of examining and measuring such work or of examining such foundation. In the event of the failur e of the Contractor, such work shall be uncovered at the Contractor's expense for examination by t he Engineer-in-Charge.
- 26.2 Corporation officers concerned with the Contract shall have powers at any time to inspect and ex amine any part of the works and the Contractor shall give such facilities as may be required for suc h inspection and examination.

27. DUTIES AND POWERS OF ENGINEER-IN-CHARGE'S REPRESENTATIVE

The duties of the Representative of the Engineer-in-Charge are to watch and supervise the works and to test and examine any materials to be used or workmanship employed in connection with th e works. He shall have no authority to order any work involving any extra payment by the Corpora tion or to make any variation in the works.

- 27.1 The Engineer-in-charge may from time to time in writing delegate to his Representative any of th e powers and authorities vested in the Engineer-in-charge and shall furnish to the Contractors a co py of all such written delegation of powers and authorities. Any written instruction or written appr oval given by the Representative of the Engineer-in-Charge to the Contractor within the terms of s uch delegation shall bind the Contractor and the Corporation as though it had been given by the E ngineer-in-charge.
- 27.2 Failure of the Representative of the Engineer-in-Charge to disapprove any work or materials shall not prejudice the power of the Engineer-in-Charge thereafter to disapprove such work or materials and to order pulling down, removal or breaking up thereof.
- 27.3 If the Contractor shall be dissatisfied with any decision of the Representative of the Engineer-in-C harge, he shall be entitled to refer matter to the Engineer-in-Charge who shall thereupon confirm, reverse vary such decision.

28. **REMOVAL OF WORKMEN**:

The Contractor shall employ in and about the execution of the works such persons as are skilled and experienced in their several trades and Engineer-in-Charge shall be at liberty to object to and require the Contractor or to remove from the works any person employed by the Contractor in or a bout the execution of the works who in the opinion of the Engineer-in-Charge misconducts himself or is incompetent or negligent in the proper performance of his duties and such person shall not b e again employed upon the works without permission of the Engineer-in-charge.

29. UNCOVERING AND MAKING GOOD:

The Contractor shall uncover any part of the works and/or make opening in or through the same as the Engineer-in-charge may from time to time direct for his verification and shall re-instate and make good such part to the satisfaction of the Engineer-in-charge. If any such part has been cover ed up or put out of view after being approved by the Engineer-in-Charge and subsequently found o n uncovering to be executed in accordance with the Contract, the expenses of uncovering and/or making opening or through reinstating and making good the same shall be borne by the Contracto r.

30. WORKING DURING NIGHT OR ON SUNDAYS AND HOLIDAYS

Subject to any provisions to the contrary contained in the Contract none of the permanent works shall be carried out during night or on Sundays or on authorized holidays without the permission in writing of the Engineer-in-Charge except when the work is unavoidable or absolutely necessary for the safety of life, property or works in which case the Contractor shall immediately advise the Engi neer-in-charge accordingly.

31.1 **COMPLETION CERTIFICATE:**

As soon as the work is complete, the Contractor shall give notice of such completion to the Engin eer-in-charge and within ten days of receipt of such notice the Engineer-in-charge shall inspect the work and shall furnish the Contractor with a certificate of completion indicating (a) the date of com pletion, (b) defects to be rectified by the Contractor and/or (c) items for which payment shall be m ade at reduced rates. When separate periods of completion have been specified for items or group s of item the Engineer-in-Charge shall issue separate completion certificates for such items or grou p of items. No certificate of completion shall be issued, nor shall the work be considered to be co mplete till the Contractor shall have removed from the premises on which the work has been exec uted all scaffolding, sheds and surplus materials, except such as are required for rectification of de fects, rubbish and all huts and sanitary arrangements required for his workmen on the site in conn ection with the execution of the work, as shall have been erected by the Contractor, the workmen and cleaned all dirt from all parts of building(s), in upon or about which the work has been execute d or of which the work has been executed or of which he may have had possession for the purpose of the execution thereof and cleaned floors, gutters and drains, eased doors and sashes oiled locks and fastenings labeled keys clearly and handed them over to the Engineer-in-Charge or his repres entative and made the whole premises fit for immediate occupation or use to the satisfaction of th e Engineer-in-charge. If the Contractor shall fail to comply with any of the requirements of this con ditions as aforesaid, on or before the date of completion of the works, the Engineer-in-charge may at the expense of the Contractor fulfill such requirements and dispose of the scaffoldings, surplus materials, and rubbish etc. as he thinks fit and the Contractor shall have no claim in respect of any such scaffolding or surplus materials except for any sum actually realized by the sale thereof less t he cost of fulfilling the requirements and any other amount that may be due from the Contractor, if the expense of fulfilling such requirements is more than the amount realized on such disposal as af oresaid the Contractor shall forthwith on demand pay such excess.

- 31.2 If at any time before completion of the work, items or groups of items for which separate periods of completion have been specified, have been completed the Engineer-in-charge with the consent of the Contractor takes possession of any part of the same (any such parts being hereinafter in thi s conditions referred to as the relevant part) then not withstanding any thing expressed or implied elsewhere in this Contract.
- 31.2 (a) Within ten days of the date of completion of such items or group of items or of possession of the re levant part the Engineer-in-charge shall issue completion certificate for the relevant part as in co nditions 31(1) as above provided the Contractor fulfils his obligations under that condition for th e relevant part.
 - (b) The Defects Liability Period in respect of such items and the relevant part shall be deemed to ha ve commenced from the certified date of completion of such items or the relevant part as the ca se may be.
 - (c) The Contractor may reduce the value insured to extent of full value of the completed items or re levant part as estimated by the Engineer-in-charge for this purpose. This estimate shall be appli cable for this purpose only and for no other.
 - (d) For the purpose of ascertaining compensation for delay in completion of the work relevant part will be deemed to form a separate item or group, with date of completion as given in the Contra ct or as extended under the relevant condition and actual date of completion as certified by the Engineer-in-charge under this condition.

32. COMPENSATION FOR DELAY

(a) Liquidated Damages (LD) shall be levied where reasons are attributable to supplier / contractor s for delays in execution of purchase order/ contract. LD shall be levied @0.5% per week or part th ere of on the value of unfinished supply/work order for each week of delay subject to a maximum o f 5% of the total value of contract (excluding taxes and duties)

(b) Wherever the supply/work is on turnkey or having a bearing in commissioning and performance of the system in total, LD is to be imposed on total value, in such cases.

(c) If separate period of completion is specified for certain item of work or group of items of work, at the time of issuing the order, the LD can be levied on the total value of item of work or group of items of work which are completed beyond the agreed contract period. This aspect should be brou ght out in the tender document.

(d) If it is equally applicable to import orders then suitable provision to this effect has to be made i n the order and L.C.

(e) All the proposals for waiver of LD shall be vetted by concerned SPC/WTC.

(f) The Unit heads are authorized to waive LD arising out of POs/WOs issued under their delegated powers.

(g) In all other cases approval for waiver of LD shall be accorded by CMD and proposal need to be sent through D (T)/D (F).

33. **DEFECTS LIABILITY PERIOD**

The Contractor shall be responsible to make good and remedy at his own expense within such p eriod as may be stipulated by the Engineer-in-charge, any defect which may develop or may be n oticed before the expiry of the period mentioned in hereto from the certified date of completion an d intimation of which has been sent to the Contractor within seven days of the expiry of the said p eriod by a letter sent by hand delivery or by registered post.

- 34. From commencement to completion of the works, the Contractor shall take full responsibility for the care thereof and for taking precautions to prevent loss or damage and to minimize loss or dam age to the greatest extent possible and shall be liable for any damage or loss that may occur to th e works or any part thereof and all Government T & P from any cause whatsoever (save and excep t the Excepted Risks) and shall at his own cost repair and make good the same so that at completi on of the work, Corporation's T & P shall be in good order and condition and in conformity in every respect with the requirements of the Contract and instruction of the Engineer-in-charge.
- 34.1 Provided always that the Contractor shall not be entitled to payment unless the Contractor shall i

nsure the works (from commencement to completion), the Corporation's T & P hired by the Contra ctor and all materials at site to their full value (as to Corporation's T & P according to the value ind icated in Schedule-C), against the risk or damage from whatever cause arising other than the Exce pted Risks. The said insurance shall be in joint name of the Corporation and the Contractor, The C ontractor shall deposit with the Engineer-in-charge the said policy or policies. All money payable b y the insurers under such policy or policies shall be recovered by the Corporation and shall be paid to the Contractor in instalments by the Engineer-in-charge for the purpose of re-building or replace ment or repairs of the works and/or goods destroyed or damaged as the case may be. Provided ho wever if the amount payable by the insurers in respect of any claim under such a policy is not in e xcess of the amount mentioned in Schedule - F the same may be recovered by the Contractor dire ctly from the insurers and shall be utilized by him for the purpose of re-building or replacement or repairs of the works and/or goods destroyed or damaged as the case may be.

- 34.2 If the Contractor has blanket insurance policy for all his works and the policy covers all the items t o be insured under this condition, the said policy shall be assigned by the Contractor in favour of t he Corporation, provided however, if any amount is payable under the policy by the insurers in res pect of works other than the work under this Contract, the same may be recovered by the Contract or directly from the insurers.
- 34.3 Where the Corporation building or a part thereof is rented by the Contractor he shall insure the en tire building if the building or any part thereof is used by him for the purpose of storing or using m aterials of combustible nature, as to which the decision of the Engineer-in-Charge shall be final and binding.
- 34.4 The Contractor shall indemnify and keep indemnified the Corporation against all losses and claim s for injuries or damage to any person or any property whatsoever which may arise out of or in con sequence of the construction and maintenance of works and against all Claims, demands, proceedi ngs, damages, cost of charge and expenses whatsoever in respect of or in relation thereto provide d always that nothing herein contained shall be deemed to render the Contractor liable for or in re spect of or to indemnify the Corporation against any compensation or damage caused by the Exce pted Risks.
- 34.5 The Contractor shall at all times Indemnify the Corporation against all claims, damages, or compe nsation under the provisions of payment of wages Act - 1936, Minimum Wages Act - 1948, Employe r's Liability act - 1938, The workmen's Compensation Act - 1923, Industrial Disputes Act - 1947, an d Maternity Benefit Act - 1961, E.P.F and M.P. Act, 1952 or any modifications thereof or any other I aw relating thereto and rules made there under from time to time or as consequence of any accide nt or injury to any workmen or other persons in or about the works, whether in the employment of the Contractor or not, (save and except where such accident or injury has resulted from any act of the Corporation, it's agents or servants) and against all cost, charges and expenses of any suit acti on or proceedings arising out of such accident or injury and against all sum or sums which may wit h the consent of the Contractor be paid to compromise or compound any such claim, without limit ing his obligations and liabilities as above provided. The Contractor shall insure against all claims, damages or compensation payable under the Workmen's Compensation Act - 1923 or any modifica tion thereof or any other Law relating thereto.
- 34.6 The aforesaid insurance policy/policies shall provide that they shall not be cancelled till the Engin eer-in-charge has agreed to there
- 34.7 The Contractor shall prove to the Engineer-in-charge from time to time that he has taken out all t he insurance policies referred to above and has paid the necessary premiums for keeping the polic ies alive till expiry of the Defect Liability Period, if any.
- 34.8 The Contractor shall ensure that similar insurance policies are taken out by his Sub-Contractors (if any) and shall be responsible for any claims or losses to the Corporation resulting from their failur e to obtain adequate insurance protection in connection thereof. The Contractor shall produce or cause to be produced by his Sub-Contractors (if any) as the case may be, the relevant policy or pol icies and premium receipts as and when required by the Engineer-in-charge.
- 34.9 If the Contractor and/or his Sub-Contractor (if any) shall fail to effect and keep in force the insura nce referred to above or any other insurance which he/they may be required to effect under the te rms of the Contract, then and in any such case the Corporation may, without being bound to, effec t and keep in force any such insurance and pay such premium or premiums as may be necessary f or that purpose and from time to time deduct the amount so paid by the Corporation from any mo ney due or which may become due to the Contractor or recover the same as debt due from the Co ntractor.

35. FACILITIES TO OTHER CONTRACTORS:

The Contractor shall, in accordance with requirement of the Engineer-in-charge , afford all reasonable facilities to other Contractors engaged contemporaneou sly on separate Contracts in connection with the works and for departmental la bour and labour of any other properly authorized authority or statutory body w hich may be employed at the site on execution on any work not included in the Contract or of any Contract which the Corporation may enter into the connectio n with or ancillary to the works.

36. NOTICES TO LOCAL BODIES

The Contractor shall comply with and give all notices required under any governmental authority , interment, rule or order made under any act of parliament, state laws or any regulation or bye-la ws of any local authorities relating to the works. He shall before making any variation from the Co ntract; drawings necessitated by such compliance give to the Engineer-in-charge a written notice g iving reasons for the proposed variation and obtain the Engineer-in-charge's instructions thereon.

36.1 The Contractor shall pay and indemnify the Corporation against any liability in respect of any fees or charges payable under any Act of parliament, state laws or any Government instrument, rule or order and any regulations or by-laws of any local authority in respect of the works.

37. SUB CONTRACTS

The Contractor shall not sublet any portion of the Contract without the prior wri tten approval of the Accepting authority.

38. INSTRUCTIONS AND NOTICES

Subject as otherwise provided in this Contract, all notices to be given on behalf of the Corporatio n and all other actions to be taken on its behalf may be given or taken by Engineer-in-charge or a ny officer for the time being entrusted with the functions, duties and powers of the Engineer-in-charge.

- 38.1 All instructions, notices and communications etc. under the Contract shall be given in writing and if sent by registered post to the last known place of above or business of the Contractor shall be d eemed to have been served on the date when in the ordinary course of post these would have been n delivered to him.
- 38.2 The Contractor or his agent shall be in attendance at the site/ sites during all working hours and s hall superintend the execution of the works with such additional assistance in each trade as the En gineer-in-charge may consider necessary. Orders given to the Contractor's agent shall be consider ed to have the same force as if they had been given to him.
- 38.3 The Engineer-in-charge shall communicate or confirm his instructions to the Contractor in respect of the execution of work in a "Work site order Book" maintained in the office of the Engineer-in-cha rge and the Contractor or his authorized representative shall confirm receipt of such instruction by the Contractor, he shall be furnished a certified true copy of such instructions.

39. FORE CLOSURE OF CONTRACT IN FULL OR IN PART DUE TO ABANDONMENT OR REDU CTION IN SCOPE OF WORK:

If at any time after acceptance of the tender, the Corporation shall decide to a bandon or reduce the scope of the works for any reason, whatsoever hence not require the whole or any part of the work to be carried out, the Engineer-in-Ch arge shall give notice in writing to that effect to the Contractor and the Contra ctor shall have no claim to any payment of compensation or otherwise whatso ever, on account of any profit or advantage or which he might have derived fro m the execution of the works in full, which he did not derive in consequence of the fore closure of the whole or part of the works.

- 39.1 The Contractor shall be paid at Contract rates full amount for works executed at site, and in additi on, a reasonable amount as certified by the Engineer-in-charge for the items hereunder mentioned which could not be utilized on the work to the full extent because of the foreclosure.
 - (a) Any expenditure incurred on preliminary site work e.g. temporary access roads, tempora ry labour huts, staff quarters and site office, storage, accommodation and water storage ta nks.
 - (b) i) The Corporation shall have the option to take over Contractor's Materials or any part there of either brought to site or of which the Contractor is legally bound to accept delivery from suppliers (for incorporation in or incidental to the work), provided however, the Corporatio n shall be bound to take over the materials or such portions thereof as the Contractor does not desire to retain. For materials taken over or to be taken over by the Corporation, cost of such materials shall, however, take into account purchase price, cost of transportation a nd deterioration or damage which may have been caused to materials whilst in the custod y of the Contractor.
 - ii) For Contractor's materials not retained by the Corporation, reasonable cost of transportati on of such materials from site to Contractor's permanent stores or to his other works, whic hever is less. If materials are not transported to either of the said places, no cost of transp ortation shall be payable.
 - (c) If any materials supplied by the Corporation are rendered surplus, the same except norm al wastage shall be returned by the Contractor to the Corporation at rates not exceeding t hose at which these were originally issued less allowance for any deterioration or damage which may have been caused whilst the materials were in the custody of the Contractor. I n addition, cost of transporting such materials from site to the Corporation stores if so requ ired by the Corporation.
 - (d) Reasonable compensation for transfer of T & P from site to Contractor's permanent stores or to his other works, whichever is less. If T & P are not transported to either of the said pl aces, no cost of transportation shall be payable.

The Contractor shall if required by the Engineer-in-charge furnish to him books of account, wage books, time sheets and other relevant documents as may be necessary to enable hi m to certify the reasonable amount payable under this condition.

40. TERMINATION OF CONTRACT FOR DEATH:

If the Contractor is an individual or a proprietary concern and the individual or the proprietary dies and if the Contractor is a partnership in concern and one o f the partners dies, then unless the Accepting Authority is satisfied that the leg al representative of the individual Contractor or of the proprietor of the proprie tary concern and in the case of partnership, the surviving partners, are capable of carrying out and complete the Contract, the Accepting Authority shall be ent itled to cancel the Contract as to its incomplete part without the Corporation b eing in any way liable to payment of any compensation to the estate of the de ceased Contractor and/or to the surviving partners of the Contractors firm on a ccount of the cancellation of the Contract. The decision of the Accepting autho rity that the legal representatives of the deceased Contractor or the surviving partners of the Contractor's firm cannot carry out and complete the Contract sh all be final and binding on the partners. In the event of such cancellation the C orporation shall not hold the estate of the deceased Contractor and/or the survi ving partners of the Contractor's firm liable in damages for not completing the Contract.

41. CANCELLATION OF CONTRACT IN FULL OR IN PART:

If the Contractor:

- a) At any time makes default in proceeding with the works with due diligence and continued to d o so after a notice in writing of 7 days from the Engineer-in-charge or
- b) Commits default the works or items of work with individual dates of completion, and does not c omplete them within the period specified in notice given in writing in that behalf by the Engine er-in-charge.
- c) Fail to complete the works or items of work with individual dates of completion, and does not c omplete them within the period specified in notice given in writing in that behalf by the Engine er-in-charge.
- d) Shall offer or give or agree to give to any person in Corporation's service or to any other perso n on his behalf consideration, any gift or of any kinds as an inducements or reward for doing o r forbearing to or for having done or forborne to do any act in relation to the obtaining or exec ution of this or any other Contract for the Corporation.
- e) Shall enter into a Contract with the Corporation in connection with which commission has bee n paid or agreed to be paid by him or to his knowledge, unless the particulars of any such com mission and terms of payment thereof have previously been disclosed in writing to the Accepti ng Engineer-in-charge.
- f) Shall obtain a Contract with the Corporation as a reward offering tendering or by other non b onafied methods of competitive tendering or
- g) Being an individual, or if a firm any partner thereof, shall at any time be adjusted insolvent or have a receivers order for administration of his estate, made against him or shall take any proceeding, liquidation or composition (other than a voluntary liquidation for the purpose of amalgamation or reconstruction) under any Insolvency Act for the time being in force or make any conveyance or assignment of his effects or composition or arrangement for the benefit of his creditors or purpose so to do, or if any application be made under any Insolvency Act for the time being in force for sequestration of his estate or if a trust deed be executed by him for b enefit of his creditor, shall be given to the Contractor for value of the work executed by him up to the time of cancellation, the value of Contractor's materials taken over and incorporated in t he work, and use of tackle and machinery belonging the Contractor work or
- b) Being a Corporation, shall pass a resolution or the Court shall make an order for the liquidation of its affairs, or a Receiver or Manager on behalf of the debenture holders shall be appointed or a circumstance shall arise which entitle the court or debenture holders to appoint a Receiver or Manager or
- i) Shall suffer an execution being levied on his goods and allow to be contained for a period of 2 1 days or
- j) Assigns, transfers, sublets (engagement of labour on a piece basis or of labour with materials not to be incorporated in the work, shall not be deemed to be subletting) or attemp ts to transfer or sublet the entire works or any portion thereof, without the prior written approv al of the Accepting Authority.

The Accepting Authority may, without prejudice to any other right to remedy, which shall hav e accrued or shall accrue thereafter, the Corporation by written notice cancel the Contract as a whole or only such items of work on default from the Contract.

- 41.1 The accepting authority shall on such cancellation have power to
 - (a) Take possession of the site and any materials, constructional plant, implements, stores etc. th ereon, and/or
 - (b) Carryout the incomplete work by any means at the risk and cost of the Contractor.
- 41.2 On cancellation of the Contract in full or in part, the Engineer-in-Charge shall determine what amo unt, if any, is recoverable from the Contractor for completion of the works or part of the works or in case the works or part of the works is not to be completed, the loss or damage suffered by the Cor

poration. In determining the amount, credit shall be given to the Contractor for the value of the w ork executed by the Contractor upto the time of cancellation, the value of Contractor's materials ta ken over and incorporated in the work, and use of tackle and machinery belonging to the Contract or.

41.3 Any excess expenditure incurred or to be incurred by the Corporation in completing the works or part of the works or the excess loss or damages suffered or may be suffered by the Corporation as aforesaid after allowing such credit shall be recovered from any moneys due to the Contractor on any account, and if such moneys are not sufficient the Contractor shall be called upon in writing to pay same within 30 days.

If the Contractor shall fail to pay the required sum within the aforesaid period of 30 days, the Engi neer-in-charge shall have the right to sell any or all of the Contractor's unused materials, construct ional plant, Implements, temporary building etc. and apply the proceeds of sale thereof, towards t he satisfaction of any sums due from the Contractor under the Contract and if thereafter there be any balance outstanding from the Contractor, it shall be recovered in accordance with the provisio ns of the Contract.

41.4 Any sums in excess of the amounts due to the Corporation and unsold materials, constructional pl ant etc. shall returned to the Contractor, provided always that if cost or anticipated cost of complet ion by the Corporation of the works is less than the amount which the Contractor would have been paid had he completed the works or part of the works, such benefit shall not accrue to the Contract or.

42. LIABILITY FOR DAMAGE/DEFECTS OR IMPERFECTIONS AND RECTIFICATION THEREOF:

If the Contractor or his workmen or employees shall injure or destroy any part of the building in which they may be working or any building, road, fence etc. c ontiguous to the premises on which the work or any part of it is being executed or if any damage shall happen to the work while in that progress, the Contracto r shall upon receipt of a notice in writing in that behalf make the same good at his own expense. If it shall appear to the Engineer-in-charge or his representa tive at any time during construction or re-construction or prior to the expiratio n of the Defects Liability Period, that any works has been executed with unsou nd, imperfect or unskilful workmanship or that any materials are of a inferior q uality to that Contract for, or otherwise not in accordance with the Contract, or that any defect, shrinkage or other fault have appeared in the work arising out of defective or improper materials or workmanship, the Contractor shall, upon r eceipt of a notice in writing in that behalf from the Engineer-in-Charge, forthwit h rectify or remove and reconstruct the work so specified in whole or in part, a s the case may require or as the case may be and/or remove the materials or a rticles at his own expense not withstanding that the same may have been to d o so within the period to be specified by the Engineer-in-charge, may rectify or remove and re-execute the work and or remove and replace with other materi als or articles complained of, as the case may be, by other means at the risk a nd expense of the Contractor.

In case of repairs and maintenance works, splashes and droppings from white washing, painting, etc. shall be removed and surface cleaned simultaneously with completion of these items of work in individual rooms, quarters or premise s etc. where the work is done, without waiting for completion of all other items of work in the Contract. In case the Contractor fails to comply with the require ments of this condition, the Engineer-in-charge shall have the right to get the work done by other means at the cost of the Contractor. Before taking such ac tion, however, the Engineer-in-charge shall give three days notice in writing to Contractor.

43. URGENT WORKS:

If any urgent work (in respect whereof the decision of the Engineer-in-Charge shall be final and b inding) becomes necessary and the Contractor unable or unwilling at once to carry it out, the Engi neer-in-Charge may by his own or other work people carry it out as he may consider necessary. If the urgent work were such as the Contractor is liable under the Contract to carry out at his expens e, all expenses incurred on it by the Corporation shall be recoverable from the Contractor and be a djusted or set off against any sum payable to him.

44. CHANGE IN CONSTITUTION:

Where the Contractor is a partnership firm, prior approval in writing of the accepting authority sh all be obtained before any change is made to the constitution of the firm. Where the Contractor is an individual or a Hindu Undivided Family-business concern, such approval as aforesaid shall likewise be obtained before the Contractor enters into any partnership agreement where under th e partnership, firm would have the right to carry out the work hereby undertaken by the Contracto r. If prior approval as aforesaid is not obtained, the Contract shall be deemed to have been assign ed in contravention of condition 41(j) hereof and the same action may be taken and the same cons equences shall ensure as provided for in the said condition 41.

45. **TRAINING OF APPRENTICES:**

The Contractor shall during the currency of the Contract, when called upon by the Engineer-in-ch arge engage and also ensure engagement by Sub-Contractors and others employed by the Contra ctor in connection with the works, such number of apprentices in the categories as directed by E.I. C. and for such periods as may be required by the Engineer-in-charge. The Contractor shall train t hem as required under the Apprentices Act, 1961 and shall be responsible for all obligations, the e mployer under the Act including the liability to make payment of apprentices as required under the act.

46. VALUATIONS AND PAYMENT:

RECORDS AND MEASUREMENT:

The Engineer-in-charge, shall except as otherwise stated ascertain and determine the value of the works done in accordance with the measurement recorded and the Contract rates for each such ite ms of work.

- 46.1 All items having a financial value shall be entered in Measurement Book, Level Book etc. prescrib ed by the Corporation so that a complete record is obtained of all work performed under the Cont ract.
- 46.2 Measurements shall be taken jointly by the Engineer-in-charge or his authorized representative a nd by the Contractor or his authorized representative.
- 46.3 Before taking measurements of any work, the Engineer-in-charge or the persons deputed by him f or the purpose shall give a reasonable notice to the Contractor. If the Contractors fails to attend or send an authorized representative for measurement after such a notice or fails to countersign or t o record the objection within a week from the date of measurement, then in any such event, meas urements taken by the Engineer-in-charge or by person deputed by him shall be taken to be corre ct measurements of the work.
- 46.4 The Contractor shall, without extra charge, provide assistance with every appliance, labour and ot her things necessary for measurement.
- 46.5 Measurement shall be signed and dated by both parties each day on the site on completion of me asurement. If the Contractor objects to any of the measurements recorded on behalf of the Corpor ation, a note to that effect shall be made in the Measurement Book against the item objected to a nd such note shall be signed and dated by both parties engaged in taking measurements.
- 46.6 Where mode of measurement is not otherwise specified, the measurement shall be taken at site as per the latest I.S. Code of practice at the time of tendering.

47. METHOD OF MEASUREMENTS:

Except where any general or detailed description of the work in quantities exp ressly shows to the contrary, Schedule of Quantities shall be deemed to have been prepared and measurements shall be taken in accordance with the proce dure set forth in the Schedule of Rates/Specifications not withstanding any pro vision in the relevant standard Method of Measurement or any general or local custom. In the case of items, which are not covered by the Schedule of Rates/ Specifications, measurements shall be taken in accordance with the relevant S tandard Method of Measurement issued by the Indian Standard Institution.

48. **PAYMENT ON ACCOUNT**:

Interim bills shall be submitted by the Contractors at intervals mentioned in Schedule - F on or b efore the date fixed by the Engineer-in-charge for the work executed. The Engineer-in-charge shall then arrange to have the bill verified by taking or causing to be taken, where necessary, the requis ite measurements of the work.

- 48.1 Payment on account for amount admissible shall be made on the Engineer-in-charge certifying th e sum to which the Contractor is considered entitled by way of interim payment for all work execut ed after deducting there from the accounts already paid, the Performance Security and such other amounts as may be deductible or recoverable in terms of the Contract.
- 48.2 Any interim certificate given relating to work done or materials supplied may be modified or corre cted by any subsequent interim certificate or by the final certificate. No certificate of the Engineer -in-charge supporting an interim payment shall of itself be conclusive evidence that any work or m aterials to which it relates is/are in accordance with the Contract.
- 48.3 Pending consideration of extension of date of completion, interim payments shall continue to be made as herein provided.

49. TIME LIMIT FOR PAYMENT OF FINAL BILL:

The Contractor shall submit the Final Bill within three months of physical completion of the work s. The Contractor shall make no further claims after submission of the bill (final) and these shall b e deemed to have been waived and extinguished. Payment of those items of the bill in respect of which there is no dispute and of items in dispute, for quantities and at rates as approved by Engin eer-in-charge, shall be made within the period specified hereunder, the period being reckoned fro m the date of receipt of the bill by the Engineer-in-charge.

- a) Contract amount not exceeding Rs. 5 Lakhs..... Four months
- b) Contract amount exceeding Rs. 5 Lakhs...... Six months
- 50. After payment of the amount of the final bill payable as aforesaid has been made, the Contractor may, if he so desires, reconsider his position in respect of the disputed portion of the final bill and i f he fails to do so within 90 days his disputed claim shall be deals with as provided in the Contract, provided however, no reimbursement or refund shall be made if the increase/decrease is not more than + 10% of the said price, and if so the reimbursement or refund shall be made only on the exc ess over + 10% provided that any increase will not be payable if such increase has become operat ive after the Contract extended date of completion of the works or items of work in question.

51. OVER PAYMENTS AND UNDER PAYMENTS

Whenever any claim for the payment of a sum of money to the Corporation ari ses out of or under this Contract against the Contractor, the same may be ded ucted by the Corporation from any sum then due or which at any time thereaft er may become due to the Contractor under this Contract and failing that, und er any other Contract with the Corporation (which may be available with the Co rporation) or from his Performance Securitys or he shall pay the claim on dema nd.

51.1 The Corporation reserves the right to carry out post payment audit and technical examination of t

he final bill including all supporting vouchers, abstracts, etc. The Corporation further reserves the right to enforce recovery of any over payment when detected, notwithstanding the fact that amou nt of the final bill may be included by one of the parties as an item of dispute before an arbitrator a ppointed under condition 52 of this Contract and notwithstanding the fact that the amount of the final bill figures the arbitration award.

- 51.2 If as a result of such audit and technical examination any over payment discovered in respect of a ny work done by the Contractor or alleged to have been done by him under the Contract, it shall b e recovered by the Corporation from the Contractor by any or all of the methods prescribed above or if any under payment is discovered, the amount shall be duly paid to the Contractor by the Corp oration.
- 51.3 Provided that the aforesaid right of the Corporation to adjust over payment against amounts due to the Contractor under any other Contract with the Corporation shall not extend beyond the perio d of two years from the date of payment of the final bill or in case the final bill is a Minus bill, from the date the amount payable by the Contractor under the minus final bill is communicated to the C ontractor.
- 51.4 Any amount due to the Contractor under this Contract for under payment may be adjusted agains t any amount then due or which may at any time thereafter become due before payment is made to the Contractor, from him to the Corporation on any other Contract or amount whatsoever.

ARBITRATION AND LAW

52.1 **ARBITRATION:**

Except where otherwise provided for in the Contract, all questions and disputes relating to the meaning of the specifications, designs, drawings and instructions herein before mentioned and as t o the quality of workmanship or materials used on the work or as to any other question, claim, righ t, matter or thing whatsoever in any way arising out of or relating to the Contract, designs, drawin gs, specifications, estimates, instructions, orders or these conditions or otherwise concerning the works, or the execution or failure to execute the same, whether arising during the progress of the work or after the completion or abandonment thereof, shall be referred to the sole arbitration of th e Chairman & Managing Director of Uranium Corporation of India Limited, Jaduguda and if the Chair man and Managing Director is unable or unwilling to act to the sole arbitration, of some other pers on appointed by the Chairman & Managing Director, willing to act as such arbitrator. There will be no objection if the arbitrator so appointed is an employee of Uranium Corporation of India Limited, J aduguda and that he had to deal with the matters to which the Contract relates and that in the cou rse of his duties as such he had expressed views on all or any of the matters in dispute or differen ce. The arbitrator to whom the matter is originally referred being transferred or vacating his office or being unable to act for any reasons, such Chairman & Managing Director as aforesaid at the tra nsfer, vacation of the office of inability to act, shall appoint another person to act as arbitrator in a ccordance with the terms of the Contract. Such person shall be entitled to proceed with the reference from the stage at which his predecessor left it. It is also a terms of this Contract that no person other than a person appointed by such Chairman & Managing Director, as aforesaid should act as arbitrator and if for any reason, that is not possible, the matter is not to be referred to arbitr ation at all. In all cases where the amount of the claim in dispute is Rs. 50,000/-(Rupees Fifty Thou sand) and above, the arbitrator shall give reasons for the award.

Subject as aforesaid, the provisions of the Arbitration Act, 1940 or any statutory modification or reenactment thereof and the rules made there under and for the time being in force, shall apply the arbitration proceeding under this clause. It is a term of the Contract that the party invoking arbitra tion shall specify the dispute or disputes to be referred to arbitration under the clause together wit h the amount for amounts claimed in respect of each such dispute.

It is also a term of the Contract that if the Contractor does not make any demand for arbitration in respect of any claim(s) in writing within 90 days of receiving the intimation from the Corporation that the bill is ready for acceptance of the Contractor, the claim of the Contractor will be deemed to have been waived and absolutely barred and the company shall be discharged and released of al liabilities under the Contract in respect of these claims.

The arbitrator(s) may from time to time with consent of the parties enlarge the time, for making and publishing the award.

The decision of the Engineer-in-charge regarding the quantum of reduction as well as justificatio n thereof in respect of rates for substandard work, which may be decided to be accepted, will be fi

nal and would not be open to arbitration. The arbitrator shall be deemed to have entered on the re ference on the date he issues notice to both the parties fixing the date of the first hearing.

The venue of Arbitration shall be such place as may be fixed by the Arbitrator, in his sole discreti on. The award of the Arbitrator shall be final, conclusive and binding all the parties to this Contrac t.

52.2 COST OF ARBITRATION:

Upon every or any such reference, the costs of and incidental to the reference and award respectiv ely shall be in the discretion of the arbitrator, who may determine the amount thereof, or direct th e same to be taxed as between solicitor and client, or as between party and party and shall direct by whom and to whom and in what manner the same shall be borne and paid.

52.3 WORK TO CONTINUE:

Work under the Contract shall be continued by the Contractor during the arbitration proceedings, u nless otherwise directed in writing by the Corporation or the Engineer-in-charge or unless the matt er is such that the works cannot possibly be continued until the decision of the arbitrator is obtaine d and except as those which are otherwise expressly provided in the Contract, no payment due or payable by the Corporation shall be withheld on account of such arbitration proceeding unless it is the subject matter or one of the subject matters of the arbitration.

53. **LAWS GOVERNING THE CONTRACT:**

This Contract shall be governed by the Indian Laws for the time being in force and it shall be deem ed to have been executed at Jaduguda, District Singhbhum (East), Jharkhand within the ordinary Ci vil Jurisdiction of the competent courts in the district of Singhbhum (East).

Special Guidelines Regarding Wages

_

Important guidelines for Contractor regarding compliances of statutory provision under Mini mum Wages Act, Payment of Wages Act, Contractors Labour (Regulation & Abolition) Act, 19 70, The Employees Provident Funds Act, 1952, Employees State Insurance Act 1948 Mines Act and Interstate Migrant Workmen Act 1979 etc.

The Bidders/Contractor are requested for compliance to the following guidelines strictly:-

1. Labour escalation will be paid as per formula mentioned below:-

WEV = Wages escalation value

VWD = Value of Work Done.

W0 = Minimum labour wages based on Administrative Instruction as on bid opening date. W1 = Revised Minimum labour wages based on Administrative Instruction during the period of Executio n of work.

- 2. The file having following documents should be provided to Personnel Office, Turamdih.
 - a) A copy of Work Order
 - b) A copy of Insurance
 - c) A copy of ID card (Voter/ Aadhar/ Ration card etc.) of all engaged labours
 - d) A copy of Labour License
 - e) A copy of PF Account statement of all engaged labours
 - f) Copy of passbook of current National Bank of all engaged labours (for bank payment)

Note: - Separate file should be provided for each running work order.

- 3. Following registers and records should be maintained under Minimum Wages Act/ Payment of Wages Act and Contractors Labour (Regulation & Abolition) Act, 1970 etc.
 - a) Muster Roll (Attendance Register)
 - b) Register of wages
 - c) Register of Deductions
 - d) Register of Over-time
 - e) Register of Fines
 - f) Register of Advance
 - g) Wage Slip
- 4. Wage slip in Form XIX should be provided to each labour at least a day prior to the disbursement of wage s.

Note: - make 02 copy of wage slip (one for labour and another for own record)

- 5. The wages of every person employed as contract labour in an establishment or by a contractor where les s than one thousand such persons are employed **shall be paid before the expiry of the seventh day** and in other cases before the expiry of tenth day after the last day of the wage period in respect of which t he wages are payable.
- 6. A notice of payment showing the wage period and time of disbursement of wages shall be sent by the con tractor to the Personnel Office in advance (atleast 2-3 days earlier).
- 7. At the time of forwarding any correspondence to CISF or any other agency through Personnel Deptt., dupl icate copy must be provided to Personnel Deptt. Which will be enclosed in the file as record?
- 8. At the time of clearance of Bill/ Measurement Book by Personnel Deptt., 02 (two) nos. of Xerox copy of Mu ster Roll (Attendance Register) and Register of wages should be provided to Personnel Deptt.

Note: - Second copy will be forwarded to Accounts Section, Turamdih by Personnel Deptt.

- 9. In case of payment of wages more than 5000 Rs. to any labour, the signature of that labour in the register of wages is mandatory on the revenue stamp.
- 10. A Notice Board showing the rates of wages, hours of work, wage periods, dates of payment of wages, nam es and addresses of the Inspectors having jurisdiction, and date of payment of unpaid wages, and an abstr act of the Act and rules shall be displayed in English and in Hindi and in the local language understood by t he majority of the workers in conspicuous places at the establishment and the work site by the contracto r, as the case may be.
- 11. In case of engaged five or more Inter-State migrant workmen (all engaged labours except who is employ ed mainly in a managerial or administrative capacity and supervisory capacity workmen) on any day of th e preceding twelve months, A license of Inter-State migrant issued by ALC, Chaibasa should be provided t o Personnel Office.

- 12. All contractor should submit details in the prescribed format in monthly basis which will be used for maki ng report to DGMS & ALC etc..
- 13. All persons deployed by the contractor for working in mine must undergo vocational training, initial medi cal examination & PME.
- 14. Notices of intimating **Commencement of job/Completion of job** should be provided to Addl. Manager (Pers.) Turamdih.
- 15. Payment of all engaged labours should be made through bank.
- 16. Guidelines issued by statutory body and Personnel Office etc. time to time must be followed.

As per the terms of Tender document and statutory provision of various Labours Acts, it is clearly i ndicated that non-compliance of any terms, the company shall have the right to terminate the cont ract or Blacklisted for further business with us.

SPECIAL GUIDELINES AS PER DGMS

- a) Prepare written Safe Operating Procedure (SOP) for the work to be carried out, including an assessment of risk, wherever possible and safe methods to deal with it/them.

- g) All persons deployed by the contractor for working in Mine must undergo vocational training, initia I medical examination, PME. They should be issued card stating the name of the contractor and the work and its validity period, indicating status of VT & IME.
- Every person deployed by the contractor in a Mine must wear safety gadgets to be provided by th e contractor. If the contractor is unable to provide, owner, agent and Manager of the Mine shall pro vide the same.
- i) The contractor shall submit to DGMS returns indicating Name of his firm, Registration number, Ma ne and address of person heading the firm, Nature of work, Type of deployment of work persons, N umber of work persons deployed, How many work persons hold VT Certificate, How many work per sons undergone IME and type of medical coverage given to the work persons. The return shall be s ubmitted quarterly (by 10th of April, July, October and January) for contracts of more than one year. However, for contracts of less than one year, returns shall be submitted monthly.

SAFETY OF CONTRACTOR' S EMPLOYEES

1. The contractor shall at all times, take all reasonable precautions for the safety of employees, including th ose of sub-contractors in the performance of his contract and shall comply with all applicable provisions of both Central as well as the State Safety Laws, in additions, to the safety provision already included the saf ety requirements recommended by the V.T. Centre, Narwapahar/Turamdih for a specific contract.

In the event that the contractor fails to comply with these provisions, the Engineer-in-charge may, without prejudice to any other legal or contractual rights, issue an order stopping all or any parts of the work, thereafter a start order for resumption of work may be issued at the discretion of the c ontracting office. information Name of the informant Nature and location of incident being reported Name of Supervisor/Engineer-in-charge, Location and Telephone No. Where he can be reached

- 5. Contractor shall submit their investigation reports, through their Engineer-in-charge, to V.T. Centre imm ediately but not later than three working days after the occurrence of accident in the Form A (see Append ix 2).
- 6. In the case of Type _ B accidents (see Appendix _ 1), Contractor shall submit their investigation reports, through their Engineer-in-charge, to V.T. Centre immediately but not later th an three working days after the occurrence of accident in the Form-A.
- 7. Monthly summary of accidents and cases of fire shall be prepared by each contractor in Form B (See Ap pendix 3) and be sent to V.T. Centre, Narwapahar/Turamdih by the seventh of next month.
- 8. Principal contractor shall report the man days lost and occurrence of accidents under the jurisdiction of s ub-contractors.
- **9.** Contractor shall submit a narrative report on safety activities and fire incidents for each month along wit h Form B. The review should contain such items as personnel and programme change, major project star ted and major problems.

further dealings related to the contract process. In such a case while an enquiry is being conducted by

the BUYER the proceedings under the contract would not be stalled.

Commitments of BIDDERS

3 The BIDDER commit itself to take all measures necessary to prevent corrupt p ractices, unfair

means and illegal activities during any stage of its bid or during any pre-contract or post-contract

stage in order to secure the contract or in furtherance to secure it and in partic ular commit itself to the

followings:-

3.1. The BIDDER will not offer, directly or through intermediaries, any bribe, gift, consideration,

reward, favour, any material or immaterial benefit or other advantage, commiss ion, fees, brokerage or

inducement to any official of the BUYER, connected directly or indirectly with th e bidding process,

or to any person, organization or third party related to the contract in exchange for any advantage in

the bidding, evaluation, contracting and implementation of the contract.

3.2 The BIDDER further undertakes that it has not given, offered or promised to give, directly or

indirectly any bribe, gift, consideration, reward, favour, any material or immater ial benefit or other

advantage, commission, fees, brokerage or inducement to any official of the BU YER or otherwise in

procuring the Contract or forbearing to do or having done any act in relation to t he obtaining or

execution of the contract or any other contract for showing or forbearing to sho w favour or disfavor

to any person in relation to the contract or any other contract.

3.3 The BIDDER further confirms and declares to the BUYER that the BIDDER has not engaged

any individual or firm or company whether Indian or foreign to intercede, facilita te or in any way to

recommend to the BUYER or any of its functionaries, whether officially or unoffic ially to the award

of the contract to the BIDDER, nor has any amount been paid, promised or inten ded to be paid to any

such individual, firm or company in respect of any such intercession, facilitation or recommendation.

3.4 The BIDDER, either while presenting the bid or during pre-contract negotiati ons or before

signing the contract, shall disclose any payments he has made, is committed to or intends to make to

officials of the BUYER or their family members, agents, brokers or any other inte rmediaries in

connection with the contract and the details of services agreed upon for such pa yments.

3.5 The BIDDER will not collude with other parties interested in the contract to i mpair the

transparency, fairness and progress of the bidding process, bid evaluation, cont racting and

implementation of the contract.

3.6 The BIDDER will not accept any advantage in exchange for any corrupt practice, unfair

means and illegal activities.

3.7 The BIDDER shall not use improperly, for purposes of competition or person al gain, or pass

on to others, any information provided by the BUYER as part of the business rel ationship, regarding

plans, technical proposals and business details, including information contained in any electronic data

carrier. The BIDDER also undertakes to exercise due and adequate care lest any such information is divulged.

3.8 The BIDDER commits to refrain from giving any complaint directly or throug h any other

manner without supporting it with full and verifiable facts.

3.9 The BIDDER shall not instigate or cause to instigate any third person to com mit any of the

actions mentioned above.

3.10 If the BIDDER or any employee of the BIDDER or any person acting on beh alf of the

BIDDER, either directly or indirectly, is a relative of any of the officers of the BU YER, or

alternatively, if any relative of an officer of the BUYER has financial interest/stak e in the BIDDER's

firm, the same shall be disclosed by the BIDDER at the time of fill of tender.

The term 'relative' for this purpose would be as defined in Section 6 of the Com panies Act

1956

3.11 The BIDDER shall not lend to or borrow any money from or enter into any monetary dealings

or transactions, directly or indirectly, with any employee of the BUYER.

4 Previous Transgression:

4.1 The BIDDER declares that no previous transgression occurred in the last thr ee years

immediately before signing of this Integrity Pact, with any other company in an y country in respect of

any corrupt practices envisaged hereunder or with any Public Sector Enterprise in India or any

Government Department in India that could justify BIDDER's exclusion from the tender process.

4.2 The BIDDER agrees that if it makes incorrect statement on this subject, BID DER can be

disqualified from the tender process or the contract, if already awarded, can be terminated for such

reason.

5 Earnest Money (Security Deposit)

5.1 While submitting commercial bid, the BIDDER shall deposit an amount _ ____ (to be

specified in RFP) as Earnest Money / Security Deposit, with the BUYER through a ny of the

following instruments:

(i) Bank Draft or a Pay order in favour of _____

(ii) A confirmed guarantee by an Indian Nationalized Bank, promising payment of the guaranteed

sum to the BUYER on demand within three working days without any demur wh atsoever and without

seeking any reasons whatsoever. The demand for payment by the BUYER shall

be treated as

conclusive proof of payment.

(iii) Any other mode or through any other instrument (to be specified by the RFP).

5.2 The Earnest Money / Security Deposit shall be valid upto complete conclusio $\ensuremath{\mathsf{n}}$ of the

contractual obligations to the complete satisfaction of both the BIDDER and the BUYER.

5.3 In case of the successful BIDDER a clause would also be incorporated in the Article

pertaining to Performance Bond in the Purchase Contract that the provisions of Sanctions for

Violation shall be applicable for forfeiture of Performance Bond in case of a deci sion by the BUYER

to forfeit the same without assigning any reason for imposing sanction for violat ion of this Pact.

5.4 No interest shall be payable by the BUYER to the BIDDER on Earnest Money / Security

Deposit for the period of its currency.

6 Sanctions for Violations

6.1 Any breach of the aforesaid provisions by the BIDDER or any one employed by it or acting

on its behalf (whether with or without the knowledge of the BIDDER) shall entitle the BUYER to

take all or any one of the followings actions, wherever required:-

(i) To immediately call off the pre contract negotiations without assigning any r eason or giving

any compensation to the BIDDER. However, the proceedings with the other BID DER(s) would continue.

(ii) The Earnest Money Deposit (in pre-contract stage) and/or Security Deposit / Performance

Bond (after the contract is signed) shall stand forfeited either fully or partially, a s decided by the

BUYER and the BUYER shall not be required to assign any reason therefore.

(iii) To immediately cancel the contract, if already signed, without giving any co

mpensation to the

BIDDER.

(iv) To recover all sums already paid by the $\ensuremath{\mathsf{BUYER}}$, and in case of an Indian $\ensuremath{\mathsf{BID}}$ $\ensuremath{\mathsf{DER}}$ with

interest thereon at 2% higher than the prevailing Prime Lending Rate of State B ank of India, while in

case of BIDDER from a country other than India with interest thereon at 2% higher the LIBOR. If

any outstanding payment is due to the BIDDER from the BUYER in connection w ith any other

contract for any other stores, such outstanding payment could also be utilized t o recover the aforesaid

sum and interest.

(v) To encash the advance bank guarantee and performance bond / warranty bo nd, if furnished by

the BIDDER, in order to recover the payments, already made by the BUYER, alo ng with interest.

(vi) To cancel all or any other Contracts with BIDDER. The BIDDER shall be liable to pay

compensation for any loss or damage to the BUYER resulting from such cancella tion / rescission and

the BUYER shall be entitled to deduct the amount so payable from the money(s) due to the BIDDER.

(vii) To debar the BIDDER from participating in future bidding processes of India n Rare Earths

Limited for a minimum period of five years, which may be further extended at t he discretion of the

UCIL.

(viii) To recover all sums paid in violation of this Pact by BIDDER(s) to any middl eman or agent or

broker with a view to securing the contract.

(ix) In cases where irrevocable Letters of Credit have been received in respect o f any contract

signed by the BUYER with the BIDDER, the same shall not be opened.

(x) Forfeiture of Performance Bond in case of a decision by the $\ensuremath{\mathsf{BUYER}}$ to forfeit the same

without assigning any reason for imposing sanction for violation of this Pact.

6.2 The BUYER will be entitled to take all or any of the actions mentioned at Par a 6.1 (i) to (x) of

this Pact also on the Commission by the BIDDER or any one employed by it or a cting on its behalf

(whether with or without the knowledge of the BIDDER), of an offence as define d in Chapter IX of

the Indian Penal code, 1860 or Prevention of Corruption Act, 1988 or any other s tatute enacted for

prevention of corruption.

6.3 The decision of the BUYER to the effect that a breach of the provisions of thi s Pact has been

committed by the BIDDER shall be final and conclusive on the BIDDER. However , the BIDDER can

approach the Independent Monitor(s) appointed for the purposes of this Pact.

7 Independent Monitors

7.1 The BUYER has appointed Independent Monitors (hereinafter referred to as Monitors) for

this Pact in consultation with the Central Vigilance Commission (Names and Add resses of the

Monitors to be given).

 $7.2\ {\rm The\ task}$ of the Monitors shall be to review independently and objectively, w hether and to

what extent the parties comply with the obligations under this Pact.

7.3 The Monitors shall not be subject to instructions by the representatives of th e parties and

perform their functions neutrally and independently.

7.4 Both the parties accept that the Monitors have the right to access all the do cuments relating to

the project/procurement, including minutes of meetings.

 $7.5~\mbox{As}$ soon as the Monitor notices, or has reason to believe, a violation of this P act, he will so

inform the Authority designated by the BUYER.

7.6 The BIDDER(s) accepts that the Monitor has the right to access without restr iction to all

Project documentation of the BUYER including that provided by the BIDDER. Th e BIDDER will

also grant the Monitor upon his request and demonstration of a valid interest, u nrestricted and

unconditional access to his project documentation. The same is applicable to Subcontractors. The

Monitor shall be under contractual obligation to treat the information and docu ments of the

BIDDER/Subcontractor(s) with confidentiality.

7.7 The BUYER will provide to the Monitor sufficient information about all meetings among the

parties related to the Project provided such meetings could have an impact on t he contractual relations

between the parties. The parties will offer to the Monitor the option to participat e in such meetings.

7.8 The Monitor will submit a written report to the designated Authority of BUYE R with 8 to 10 $\,$

weeks from the date of reference or intimation to him by the BUYER/BIDDER an d, should the

occasion arise, submit proposals for correcting problematic situations.

8 Facilitation of Investigation

In case of any allegation of violation of any provision of this Pact or payment of commission, the

BUYER or its agencies shall be entitled to examine all the documents including t he Books of

Accounts of the BIDDER and the BIDDER shall provide necessary information an d documents in

English and shall extend all possible help for the purpose of such examination.

9 Law and Place of Jurisdiction

This pact is subject to Indian Law. The place of performance and jurisdiction is t he seat of the

BUYER.

10 Other Legal Actions

The actions stipulated in this Integrity Pact are without prejudice to any other le gal action that may

follow in accordance with the provisions of the extant law in force relating to an y civil or criminal

proceedings.

11 Validity

11.1 The validity of this Integrity Pact shall be from date of its signing and upto the complete

execution of the contract to the satisfaction of both the BUYER and the BIDDER/ Seller, including

warranty period, whichever is later. In case BIDDER is unsuccessful, this Integrit y Pact shall expire

after six months from the date of signing of the contract.

11.2 Should one or several provisions of this Pact turn out to be invalid, the rem ainder of this Pact

shall remain valid. In this case, the parties will strive to come to an agreement t o their original

intensions.
