2. Experience of having successfully completed “**Similar works**” during last 07 years ending last day of month previous to the one in which application are invited should be either of the following:
  - a) Three Similar completed each works consisting not less than **40%** of estimated Cost or the amount equal to Rs **11.82** Lakhs

**SCOPE OF WORK :-**

For the work of **Deployment of Manpower for Annual Civil Maintenance works in UCIL Housing Colony Jaduguda for the year 2024 - 2025.**

Deployment of Unskilled and Semi - Skilled Workmen daily as and when required for maintenance of UCIL Housing colony Jaduguda for the year **2024 - 2025** shall be executed as per schedule of quantities in the residential areas and also in other areas of UCIL premises at Jaduguda Mines viz. Hospital, HP Unit, Bhatin Colony, Schools etc. . The civil maintenance work shall consist of Construction/repairing of garages, drains and approach roads, repair and maintenance of vacant quarters viz. floor, doors, windows, repairing and other civil works as per instruction of engineer-in-charge .

Minimum Two Nos. plumber, Two Nos. Carpenter and one No. sanitary mason and Five Nos. unskilled labour and one semi skilled civil mate for supervision of site work or Office works or as directed by the Engineer-in-charge. All materials will be supplied by the department (UCIL) free of cost but tools and tackles have to be arranged by the contractor at his own cost.

The Contractor shall carry out and complete the said work in every respect in accordance with the Contract and with the direction of and to the satisfaction of the Corporation. The Corporation may in his absolute discretion and from time to time issue further drawings and /or written instructions, details, directi



ons and explanations, which are hereafter collectively referred to as UCIL's instructions.
