Only such firms need to tender who possess valid **ELECTRICAL CONTRACTOR LICENSE Issued by Stat e Licensing Board** who can produce satisfactory evidence that they have the necessary experience & fin ancial resources to undertake such work as per criteria mentioned below.

- 1) Experience of having successfully completed **Similar Work** during last 07 years ending last day of month previous to the one in which applications are invited should be either of the following:
- a) One similar completed works costing not less than the amount equal to Rs. 23,35,670/-
- b) Two similar completed works each costing not less than the amount equal to Rs. 14,59,794 /-.
- c) Three similar completed works each costing not less than the amount equal to Rs. 11,67,835/-

If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-
