Only such firms need to tender who can produce satisfactory evidence that they have the necessary experience & financial resources to undertake such work as per criteria mentioned below.

**i) Experience of having successfully completed similar work in any Central / State Government Organization / PSU / Public Listed Company** during last 07 years (ending month of March prior to the bid opening) as indicated in the bid data sheet should be either of the following:

a) One similar completed works costing not less than the amount equal to **Rs.1164788.00/-**

Or

b) Two similar completed works each costing not less than the amount equal to **Rs.727992.50/-**

Or

c) Three similar completed works each costing not less than the amount equal to **Rs.582394.00/-**

**“Similar work”** means experience in **carrying out maintenance of window type and split type air conditioners**. The bidder will have to submit copy of the relevant work order / LOI / LOA clearly indicating Work Order Value (in INR) and its completion certificate from the client as documentary evidence in support of their experience / credential failing which offer shall be summarily rejected. **The submitted Work Orders / LOI / LOA and Completion Certificate shall be either English or Hindi only. Credentials other than English or Hindi language shall not be considered.**

ii) Proof of having Registered Office and workshop located and registered within the home state of the buyer i.e. Jharkhand where the services needed to be provided. Documentary evidence must be provided in the form of Municipality trade license or other such documents as per the following which satisfies as a proof of having the office establishment.

- i. Trade License issued by the local authority in the name of the Firm OR
- ii. Incorporation Certificate of the firm clearly mentioning office address OR
- iii. Electricity bill for last one year in the name of the Firm OR
- iv. GSTIN registration
- v. Udyam/MSME/NSIC/SSI

iii) The tenderer's average annual turnover during last 03 years, ending 31st March of the previous financial year i.e. 2023-24 should be at least **Rs. 4.00 Lakhs**. Annual Report containing Profit & Loss Account and Balance Sheet duly audited by CA/Cost Accountant for last 3 FYs must be submitted.

#### 9. **Purchase Preference (Centre)**

#### 10. **Payment**

**PAYMENT OF SALARIES AND WAGES:** Service Provider is required to pay Salaries / wages of contracted staff deployed at buyer location first i.e. on their own and then claim payment from Buyer alongwith all statutory documents like, PF, ESIC etc. as well as the bank statement of payment done to staff.

### 13. Generic

1. The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer.
2. The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior written consent of buyer.
3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

## Disclaimer/अस्वीकरण

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
