If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. ### **The Pre-qualification criteria (PQC)to qualify in Techno commercial Part are as below:-**

1. Average Annual financial turnover during the last 3 years, ending 31<sup>st</sup> March of the previous financial year should be at least 30% of the estimated cost i.e. **Rs 4.52 Lakhs**
2. Experience of having successfully completed “**Similar works**” at any Central / State Govt Organization / PSU / Public Listed Company during last 07 years ending last day of month previous to the one in which application are invited should be either of the following:
  - a) Three Similar completed each works consisting not less than **40%** of estimated Cost or the amount equal to **Rs 6.03 Lakhs**  
or
  - b) Two Similar completed each works consisting not less than **50%** of estimated Cost or the amount equal to **Rs 7.54 Lakhs**  
or
  - c) One Similar completed work consisting not less than **80%** of estimated Cost or the amount equal to **Rs. 12.06 Lakhs.**
- 3.**Similar works means** : Cleaning & Sweeping Works / Sanitation works / Civil Construction works / Civil Maintenance works /Manpower Supply etc.

### **4. Relaxation of conditions of prior turnover and prior experience :**

**Pre-qualification criteria with respect to Prior submission of Earnest Money Deposit (EMD) may relax for all MSEs and Start-ups [Whether Micro & Small Enterprises or Otherwise]** as per GOI guidelines subject to meeting of Quality and Technical specifications. ### **SCOPE OF WORK :-**

The entire area along the side of PWD road from Colony gate to Rear gate of UCIL are to be maintained clean. The detail are as follows :-

Deployment of Unskilled Workmen daily as and when required for Cutting / uprooting bushes, grass and other wild growth in the area. All waste materials, rubbish, plastic/ polythene bags, paper or any waste materials which makes the area dirty, will have to be collected and put in the existing dust bins and the same will have to be disposed off at a selected place in trucks/dumpers arranged by the contractor. Frequency of the disposal of wastes from the dust bins by the contractor will be as per requirement and as directed by UCIL. The area must look always clean.

Total Manpower engaged per day 6 nos. Unskilled Labour for cleaning , sweeping , cutting / uprooting bushes or grasses along the side of road.

Bleaching Powder, Carbolic Acid, Phenol, Safety Appliances, tools and tackles, Hand trolley/ tractor Trolley, Dress materials, Soap etc. shall be arranged by the contractor at his own cost which is re-imbursable.

**Note:-Contractors are advised to see the area get acquainted with the actual features of the I and where work is to be executed and get other related information before quoting their rates for carrying out the work successfully.**

### **Disclaimer/अस्वीकरण**

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
