You are invited to offer sealed quotation for the subject work schedule of quantity in duplicate) in the enclosed schedule of quantity based on the terms and conditions given below: -

1. TAXES: The quoted rates should be inclusive of all taxes and duties.
2. Completion time of work: Total work should be completed within **30 (Thirty) days**, from the date of commencement of work, which shall be within 07 days from the date of issue of work order.
3. The offer must be valid for six months from the date of tender opening, and no contractor shall be allowed to withdraw his/their offer within this period
4. There will be defect liability period for this work shall be 06 (Six) months from the date of completion of this work.
5. The price quoted should be firm and no escalation on any account whatsoever will be entertained / paid by the Corporation.
6. Payment would be released by Jamshedpur/Jaduguda cheque.
7. One RA & final bill will be paid for this work.
8. All the rates quoted by Tender shall be inclusive of cost of all materials, labour, tools, tackles, plant and machinery necessary to complete the work at no extra cost to corporation for any item.

9. No any carriage/transportation for any material except otherwise stated in schedule of quantities shall be paid by the department for this work. Contractor should quote their rates accordingly.
10. Quantity of an individual item may vary to any extent and be excluded altogether. Contractor will carryout all works up-to a total variation of $\pm 10\%$ (ten) on the contract price and all quoted rates shall remain firm within this limit.
11. **Contractor must quote their rates against all the items in Schedule of quantities supplied along with this tender. If any contractor fails to quote any of the items, they have to execute without any payment.**
12. Scope of Work: Laying 40 mm dia waste water pipe line with pump from Turamdih Hospital to ETP Turamdih Mill.
13. Contractor has to follow guidelines of AERB (Atomic Energy Regulatory Board) issued time to time.
14. Quotations must be submitted in the enclosed schedule of quantity (original and two copies in Xerox of the same) duly signed along with seal of the agency. Quotation shall be submitted in a sealed envelope and to be deposited in the office of Manager (Pers), Turamdih upto **25.11.2022** (12.00 Noon) and will be opened on same day at 3.30 P.M at Turamdih.
15. **No Material will be issued from Central / Departmental Store.**
16. **All other terms and conditions shall be applicable as per General conditions of UCIL's tender norms.**
17. Security Deposit: Total security deposit shall be 3% of awarded value of work. 1.5 % of security deposit shall be deposited during agreement and remaining 1.5% of awarded value of work shall be deposited / recovered from contractor's first running bills during the execution of the work.
18. WATER AND ELECTRICITY: Subject to availability, corporation shall supply water (for construction purpose) and electricity for lighting and construction/ fabrication purpose only at a suitable location near the working site on free of cost, any extension or distribution thereof, shall be arranged by the contractor at his own cost. Any misuse/ wastage of the services provided shall be charged at a penal rate as decided by the Engineer-in-charge and no claim shall be entertained in the event of any failure on the part of "Corporation to provide such services".
19. GOVERNMENT LABOUR ACT

The contractor has to follow strictly the Government Labour Act, which are and will be in force during the period of execution of work. All necessary arrangements for Labour's Security Insurances will have to be made by the contractor at his own cost.
20. CONTRACT LABOUR ACT

According to provision of Contract Labour (Regulation & Abolition) Act of 1970 and Contract (Regulation & Abolition) central rules, 1971, contractors engaging 20 or more

contract labour on any day are required to obtain the license from the Regional Labour Commissioner. In the event of the breach of aforesaid conditions, the contractor shall be open for action as deemed fit by the concerned labour authorities of the State/Central Government.


21. TAX & DUTIES

The quoted rate should be inclusive of all materials & including GST. Hence, no other taxes, duties etc will be paid extra, or any imposition of new Governmental taxes / duties during the contract execution etc. period.

22. The Contractor should quote their rates considering minimum wages of Un-Skilled / Semi Skilled labourers as per notification of A.L.C. (C), Chaibasa. In case of any increase in minimum wages, the same has to be paid by the Contractor.
 23. In case payment of labourers engaged for this work, has not been made on stipulated payment day, Corporation shall compel the contractor to stop the work besides taking other suitable steps to make the payment to the workers at risk and cost of the Contractor.
 24. Safety precautions shall be maintained by the contractor during the execution of work. Safety appliances like helmet, gum boot, safety belt, goggles, hand gloves etc shall be provided to the workmen by contractor at their own cost.
 25. Necessary workmen insurance coverage for **04 Nos workmen (minimum)** shall be obtained by the contractor for the workmen engaged at site and labour license, if applicable shall be obtained this work at their own cost for the whole period of the contract and shall be furnished to the corporation before commencement of the work without which contractor will not be allowed to start the work.
 26. Quantity of an individual item may vary to any extent and be excluded altogether. Contractor will carry out all works up to a total variation of $\pm 10\%$ (Ten) on the contract price and all quoted rates shall remain firm within this limit.
 27. **E.P.F. & paid holidays shall be paid by the contractor as per norms.**
 28. **Ex-gratia shall be paid by the contractor as per norms & PF is applicable as per the norms of UCIL.**
