2. The operators should be heavy vehicle license holder or minimum one year experienced in underground diesel vehicles.
3. The rates quoted should be inclusive of minimum wage for underground mines for skilled category, PF, Insurance, Bonus, etc. as applicable.
4. Cost of reimbursement for PPEs such as gumboot, helmet, safety jackets etc. @ Rs. 600 per manpower on production of original bill.
5. **Mode of Payment:** Monthly R A Bill & Final Bill
6. **Working Hours:** - In shifts the timing of which is as follows:-
  - a. **"A" Shift:** - 07:00 A.M. to 03:00 P.M.
  - b. **"B" Shift:** - 03:00 P.M. to 11:00 P.M.
  - c. **"C" Shift:** - 11:00 P.M. to 07:00 A.M.
7. **Mode of Measurement:** - The measurement shall be done based on actual man days supplied by the Service Provider



8. **Scope of Work:** The scope of work includes operating underground diesel vehicles like LHD/LPDT/ MT and dumping on to the hopper at the surface or hopper platform or in underground ore pass as per instruction of Engineer in Charge. It also requires operating vehicles like scissor lift, Passenger carrier, crane truck etc in each of three shifts in a day for 45 working days ( exclusive Sunday & holidays).
9. **Penalty:** Penalty amount shall be deducted if attendance of minimum 06 (six) operators is not maintained on daily basis. If attendance is less than 06 (six) operators than 5% penalty from total payment for each such day considering 8 operators i.e. 5 % of (8 X Manday Rate X no. of default days) shall be deducted from submitted monthly running bill amount.
10. **Recruitment of the local candidates:** During the process of employment of local candidates priority will be given.
11. **Security Deposit:** The security deposit for this tender will be 10%.The security amount of 5% shall be deposited during agreement and remaining 5% will be deducted from the running bills.
