- ii) Experience of having successfully completed similar works during last 7 years ending last day of the month previous to the one in which applications are invited should be either of the following:
  - a. Three Similar completed works costing not less than an amount equal to Rs.1,08,360/-  
or
  - b. Two similar completed works costing not less than an amount equal to Rs 1,35,450 /-  
or
  - c. One similar completed work costing not less than an amount equal to Rs. 2,16,720 /-.
- iii) Bidder shall furnish PAN, GST and PF Registration Number, IT returns of the last three financial years, Balance sheet and Profit and Loss statement of the last three financial years.

**Similar Job means "Works related to LT & HT Cable laying either Underground or Overhead".**

However in case of poor response, with a view to increase the competition, admission of additional documents to meet the Pre-Qualification Criteria may be allowed subject to the condition that

- 'Poor Response' implies when less than three bids are found suitable on the basis of submitted eligible documents as per NIT.
- The additional document should not be issued subsequent to last date of receipt of tender as mentioned in the NIT.
- The bidder submitting additional documents has submitted EMD and tender cost as prescribed in NIT.
- The opportunity of submission of additional documents will be given to all the bidders.
