The eligible criteria to qualify in Techno commercial Part are as below:-

1. Average Annual financial turnover during the last 03 (Three) consecutive financial years, ending 31st March of the previous financial year, should be at least 30% (17.51 Lakhs) of the estimated cost supported by the audited annual accounts of each year.
2. Bidder shall have successfully completed similar works during last 07 (Seven) years ending last day of month previous to the one in which application are invited should be either of the following:-
 - a) Three (03) similar completed works each costing not less than the amount equal to 40% (23.34 Lakhs) of the estimated cost
or
 - b) Two (02) similar completed works each costing not less than the amount equal to 50% (29.18 Lakhs) of the estimated cost
or
 - c) One (1) similar completed works costing not less than the amount equal to 80% (46.68 Lakhs) of the estimated cost.
3. Bidders must attach Work Order and work done certificate mentioned executed amount and date of completion.
4. Similar works means **“Experience in execution of work of any “Manpower Supply””**.
5. **GEOGRAPHIC PRESENCE**: Office registration certificate: Registered office or at least one of the registered branch offices of the bidder shall be located and registered within the geographical limits of **“Jharkhand State”**, where the services need to be provided. Documentary evidence must be provided in the form of Municipality

pality trade licence or other such documents as per the following which satisfies as a proof of having the office establishment.

- A) Trade licence issue by the local authority in the name of the Firm or
- B) Landline phone number in the name of the Firm or
- C) Electricity bill for last one year in the name of the Firm or

12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1

bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.
