- b) Two similar completed works costing not less than Rs. 1,72,959 /- or

## **B. Financial Criteria**

Average annual financial turnover during the last 03 (three) years, ending 31<sup>st</sup> March of the previous financial year 2023-24, should not be less than Rs. 1,03,775/-. For this audited balance sheet for the financial year 2021-22, 2022-23 & 2023-24 (Certified copy by CA can also be submitted) to be submitted.

**Similar Work** means *“Supply of Mechanical maintenance related jobs.”*

### **Scope of job:**

- The job is to layout the 150NB HDPE/MSRL (5-6m in length) from Eastern side of Talsa tailings dam to within plant premises near Slime Thickener. The pipeline shall be laid over a length of approx 1500 metres, passing through dam slope, across the dam, across the roadside pipe rack and overhead pipe rack inside plant premises.
- The job shall involve 02 nos. of Fitters (Skilled) and 08 nos. Helpers (Unskilled) for laying out the pipeline.
- All tools and tackles shall have to be arranged by the contractor.
- UCIL shall provide Pipes, bends, short-piece, nuts-bolts and gasket only at site.
- Any other miscellaneous job as and when directed by the Engineer-In-Charge.
- Job shall be carried out in General shifts only or as directed by the Engineer-In-Charge. General shift (8:00 AM to 5:00 PM) only on all working days (Excluding holidays & Sundays).
- The job to be carried out will be explained to the contractor or his supplied manpower at the beginning of the contract & they will be responsible for carrying out the assigned quantity of work safely.

### **Terms and Conditions:**

#### **1. Basis of Evaluation:**

Offer submitted by the bidder shall be in single part. Evaluation of L1 (Lowest) bidder shall be done based on their lowest quoted rate in totality after qualifying PQC. Bidder should quote their rate both in figures as well as in words. In case of

any discrepancy in figure and words, rate written in words will be considered as final.

**2. Rate:**

Bidders shall quote rates(s) / price(s) as per price format enclosed along with Enquiry. The quoted price shall be firm for this job.

**3. Validity:**

The offer shall be valid for 180 days from the date of submission of offer.

**4. Payment:**

- 01 R.A. bill shall be paid.
- Payment to the workmen is to be done through bank transaction only.
- EPF and Bank Challans are to be submitted along with RA bill for the month.

**5. ESI:**

You have to arrange ESI coverage, if any, for manpower engaged for the work.

**6. Safety, Medical & Height-Pass:**

All the job related safety gears/equipments shall have to be arranged by the contractor for the manpower engaged.

Safety training shall be provided by UCIL after Gate-pass issued.

Height -pass shall have to be provided before the onset of the job for all the engaged manpower.


Medical certificates as required by UCIL Safety department shall have to be produced by the contractor before the start of the job.

**7. Gate Pass:**

Bidders have to arrange gate pass on their own for 12 (Twelve) persons at least so that full quota of manpower (10 Nos.) could be supplied.

**8. Penalty:**

Penalty will be imposed as per manpower basis for Skilled, Semi-skilled and Unskilled wage rate.

### **9. Agreed Liquidated Damage:**

If successful bidder fails to execute the order within the agreed completion period, they shall be liable to pay as agreed liquidated damages a sum @1/2% of the order value per week or part thereof of delay subject to a maximum of 5%. In case of delay beyond 10 weeks. UCIL reserves the right to cancel the order and levy penalties.

### **10. Cancellation of Order:**

It will be your endeavour to execute the work order to our satisfaction. In case of your failure to do so, the order is liable to be cancelled.

### **11. Force Majeure:**

In the event of strike / lockouts, closure of work (whole or partial) breakdown of machinery, act of god or any other cause beyond our control, preventing or hindering the normal operation, we shall be at liberty to cancel this order at any time before completion of work without being liable to the bidder or other claims.

### **12. Disputes:**

Both parties agree in, disputes arising out of this order may be settled by arbitration, in accordance with the Indian Arbitration Act, 1940 & its subsequent amendment, by a sole arbitrator who shall be appointed by the Chairman & Managing Director of this organization (UCIL).
