Sub: For trouble shooting and overhauling of a HMT make NH 26 model lathe machine and a HMT make radial drill machine installed in Turamdih mine workshop.

Dear Sir,

You are invited to offer sealed quotation for the subject work schedule of quantity in duplicate in the enclosed schedule of quantity based on the terms and conditions given below: -

1. Basis of Evaluation

Offer submitted by the bidder shall be in single part. Evaluation of L1 (Lowest) bidder shall be done based on their lowest quoted in totality. Bidder should quote their total both in figures as well as in words. In case of any discrepancy in figure and words then written in words will be final. The quoted rates should be inclusive of all taxes.

2. Completion of work: Total work should be completed within 03 months from the date of issuing of work order.

3. The offer must be valid for six months from the date of tender opening, and no contractor shall be allowed to withdraw his/her offer within this period.

4. There will be 03 months defect liability period for this work.

5. Guarantee / Warranty of the repair should be 03 months or 1000 running hours. If any fault comes within this period it should be rectified free of cost.

5. The price quoted should be firm and no escalation on any account whatsoever will be entertained/paid by the corporation.

6. Payment would be released by Jamshedpur/Jaduguda - cheque / Payments would be released by RTGS/ e. Payment.

7. PAYMENT TERMS: Only one bill shall be payable against submission of duly certified bill after joint measurement. Bill payment shall be payable only through e-payment. The decision of Engineer-in-charge in this matter shall be final.

8. All the rates quoted by Tender shall be inclusive of cost of all materials, labour, tools, tackels, plant and machinery necessary to complete the work at no extra cost to corporation for any item.

9. In the event of a discrepancy between description in words and figures quoted by a Tenderer, the description in words shall prevail.

10. No any carriage/transportation for any material except otherwise stated in schedule of quantities shall be paid by the department for this work. Contractor should quote their rates accordingly.

11. Job is to be carried out at UCIL Turamdih workshop, transportation and material handling charges will be in contractor scope.

12. Scope of work: As mentioned in Annexure-II. All the material required for repairing will be under contractor's scope.

13. During execution the cost of consumables and required outside repairing will be in the scope of the contractor that will be reimbursed upon submission of valid documentary evidence.

13. Quotation must be submitted in the enclosed schedule of quantity (original and two copies in Xerox of the same) duly signed along with seal of the agency. Duly filled quotation shall be submitted in the sealed envelope and to be deposited in the office of Manager (Pers.), Turamdih upto 31/10/2025 (11:30 am) and it will be opened on 31/10/2025 i.e. same day at 3:30 pm at Turamdih.

14. All other terms and conditions shall be applicable as per General conditions of UCIL's tender norms.
