Pre-Qualification Criterion (POC):

- A. The bidder should be financially sound. The average annual financial turnover during the last 3 years should be at least Rs 11.12 Lakhs.

Note: The bidder shall submit documentary evidence by way of copies of audited balance sheet including profit and loss account, necessary undertaking etc. along with bid, failing which tenderer will be disqualified.

- B. The bidder should have experience of having successfully completed similar works during last 7 years ending 31.03.2025 as at (a) or (b) or (c) below.

(a) One similar completed work costing not less than Rs 29.66 Lakhs

(b) Two similar completed works each costing not less than Rs 18.54 Lakhs.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
