6. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within $L-1+ 15\%$ of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE

bidder subject to acceptance of L1 bid price.

7. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

PRE-QUALIFICATION CRITERIA (PQC)/ ELIGIBILITY CRITERIA:

1) PAST PERFORMANCE AND PROJECT / PAST EXPERIENCE etc. CRITERIA:

The bidder' having the experience of successfully execution (completion) of at least one (01) or more numbers of similar type of contract of "ANY KIND OF BRANDDED FOOD, SNACKS, MILKPACKET SUPPLY & DISTRIBUTION JOB" to any Central / State Govt. Organization / PSU / Public Listed Company/Pvt. Organization at last THREE (03) years ending on last date of the previous month in which BID issued.

1.i) The eligibility period shall be within the period of 3 years backwards starting from the last day of month previous to the publication date of BID.

1.ii) The work experience of the bidder for those works only shall be considered for evaluation purpose, which is completed before the last date of month previous to the one in which the BID has been published on GeM portal. Hence, the works which are incomplete/ ongoing, as on the last date of the month previous to the one in which the BID has been published on GeM Portal, shall not be considered against eligibility.

1.iii) In case the work is started prior to the eligibility period of 3 (THREE) years (counted backwards starting from the last date of the month previous to publica

tion date of BID and completed within the said eligibility period of 3 years, then the year of experience of the work within the said eligibility period shall be only considered against the eligibility.

DOCUMENTARY EVIDENCE IN SUPPORT OF PAST PERFORMANCE AND PROJECT/ PAST EXPERIENCE etc. CRITERIA: - In support of the claim of meeting this experience/ technical criteria, bidder must submit following documentary proof in Ge M portal.

2) FINANCIAL STANDING:

Average annual financial turnover during the last 3 (three) years, ending 31st March of the previous financial year should be at least Minimum Average Annual Turnover should be 30 % of the estimated value. (The "Previous financial year" shall be computed with respect to the Publication date of BID).

2.1. Experience of having successfully completed **"similar work"** during last 07 (Seven) years ending last day of month previous to the one in which application are invited should be either of the following:-

3) **GEOGRAPHIC PRESENCE:** Office registration certificate: One of the Registered Office or at least one of the registered Branch Office of the bidder shall be located and registered within the geographical limits of East Singhbhum of Jharkhand. Documentary evidence must be provided in the form of Municipality trade license or other such documents as per the following which satisfies as a proof of having the office establishment.
