3. The eligible criteria to qualify in Techno commercial Part are as below:-

1. Average Annual financial turnover during the last 3(Three) consecutive financial years, ending 31/03/2025 shall be at least 30% (Rs.8, 10,719.40) of the estimated cost supported by the audited annual accounts of each year signed by CA having UDIN Number.

2. Bidder shall have successfully completed similar works during last 7 (Seven) years ending on last day of month previous to the one in which applications are invited should be either of the following:

a) Three(3) similar completed works each costing not less than the amount equal to 40% (Rs.10,80,959.20) of the estimated cost

or
