2. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within  $L-1+ 15\%$  of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price.

3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Service providers must declare the applicability of additional charges during invoice creation and submit mandatory supporting documents to avail this option. The total invoice amount, including additional charges, shall not exceed the agreed-upon excess settlement percentage for the order.

Only such firms need to tender who can produce satisfactory evidence that they have the necessary experience & financial resources to undertake such work as per criteria mentioned below.

i) Experience of having successfully completed SIMILAR WORK during last 07 years ending last day of month previous to the one in which applications are invited should be either of the following:

a) One similar completed works costing not less than the amount equal to Rs.11.13 Lacks.

b) Two similar completed works each costing not less than the amount equal to Rs.6.96 Lacks.

Or

c) Three similar completed works each costing not less than the amount equal to Rs.5.56 Lacks.

“Similar work” means experience in Painting work related with Machine/ civil Structure/ Mechanical Structure. The bidder will have to submit copy of the relevant work order / LOI / LOA clearly indicating Work Order Value (in INR) and its completion certificate, from the client, as documentary evidence in support of their experience / credential, failing which offer shall be summarily rejected. The submitted Work Orders / LOI / LOA and Completion Certificate shall be either English or Hindi only.

Credentials other than English or Hindi language shall not be considered.

ii) The tenderer's average annual turnover during last 03 years, ending 31st March of the previous financial year should be at least Rs 4.17 Lacks. Annual Report containing Profit & Loss account and Balance sheet along with ITR duly audited by CA/Cost Accountant for last 3 FYs must be submitted.

ii) Geographical Presence: MSME should be registered within the State of JHARKHAND.

iii) Proof of having Registered Office and workshop located and registered within the home state of the buyer i.e. Jharkhand where the services needed to be provided.

Documentary evidence must be provided in the form of such documents as per the following which satisfies as a proof of having the office establishment.

i. Property ownership deed in the name of the Firm OR

ii. Incorporation Certificate of the firm clearly mentioning office address OR

4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
