  - iii) Validity period indicated by bidders is shorter than that specified in the tender en y.

#### 4. The Bid Security / EMD will be forfeited:

- a) If any Bidder withdraws their bid during the period of bid validity (including any subsequent exten ) specified by the Bidder on the Bid Form, or
- b) If a Successful Bidder fails:
  - i) To sign the contract within reasonable time and within the period of bid validity, and /or,
  - ii) To furnish Performance Security.
- c) If the Bidder furnished fraudulent document/information in their bid.

#### 5. Furnishing fraudulent information / document:
