 - or
 - One similar completed work costing not less than an amount equal to Rs. 4,36,624 /-.
- Bidder shall furnish PAN and GST Registration Number, Audited Profit & Loss statement of the last three financial years.

Similar Type of Works Means: “Transformer Oil Filtration / Testing of transformer oil / Rewinding & repairing of HT Transformers having HT voltage rating of 6.6KV & above / Calibration of Electrical Testing Instruments”.
