 - i. Three Similar completed works costing not less than an amount equal to Rs. 2,18,312/-.
or
 - ii. Two similar completed works costing not less than an amount equal to Rs. 2,72,890/-.
or
 - iii. One similar completed work costing not less than an amount equal to Rs. 4,36,624/-.
- c) Bidder shall furnish PAN and GST Registration Number, Audited Profit & Loss statement of the last three financial years.

Similar Type of Works Means: “Transformer Oil Filtration / Testing of transformer oil / Rewinding & repairing of HT Transformers having HT voltage rating of 6.6KV & above / Calibration of Electrical Testing Instruments”.
