EMD Exemption: Exemption from submission of EMD shall be availed on uploading valid documents as per prevailing GeM Guidelines.

The eligibility is to be decided strictly based on documents submitted at the time of receipt of tenders. This contract includes replacement of faulty spares like compressors, relays, thermostats, fan motors, power contractors, rewinding of motors, providing bearing to motors, drive belt, gas charging as required etc along with attending complaints and breakdown of all air conditioning units as stipulated above.
