Text Clause(s)

SCOPE OF WORK

JOB DESCRIPTION: Uranium Corporation, a public sector undertaking under the administrative control of Deptt. of Atomic Energy having its head quarter at Jagduguda Mines in the east Singhbhum district of Jharkhand.

The deployed manpower should be experienced and shall be capable to undertake the assigned job without any sort of training.

The daily jobs includes following:

- 1) The collection of dak within all the units of UCIL at Jharkhand i.e. Jaduguda, Bhatin, Bagjata, Narwapahar and Turamdih. The dak would be collected and delivered twice in a day i.e. at 9.00 AM and 11.00 AM. The deployed staff shall be responsible for safe and timely collection and delivery of dak in each unit/s during the shifts.
- 2) Collection and distribution of dak of intra units i.e. from Jaduguda to Bhatin to Narwapahar to Turamdih and Jaduguda to Bagjata and vice versa shall be done once in a day.
- 3) The deployed staff shall also provide the miscellaneous service at Jamshedpur such as deposit of cheques in different banks, collection of cheque books from different banks, submission of Government Challans at Treasury for due authorization and subsequent deposit of challans and cheques in the Banks, other misc. jobs with the Banks, Handing over of files/documents at Sales Tax Consultants/In-come Tax Consultants, Deposits of cheques with JSEB, any other job as may be decided by the Management from time to time.
- 4) In addition to this the deployed staff shall also provide service for Post Office work, Court work, BSNL, INDICOM & AIRTEL Office work etc. or any other job as may be decided by the Management from time to time from Jaduguda to Narwapahar, Turamdih to Jamshedpur and vice-versa in a day including miscellaneous courier service at Jamshedpur.
- 5) The contractor should deploy only such person/s who are cautious, skilled and experienced in their respective work and whose qualification and experience is as per the tender requirement.
- 6) However, relaxations in qualification and experience may be considered by the management on case-to-case basis for highly deserving candidates found suitable for the allotted job.
- 7) The Personnel to be deployed will have to work in General Shift and Special Shift.
- 8) The daily working time will be as under or may be decided by the management, from time to time.

- 9) UCIL may also at its own discretion completely change the allocation of persons at any of the local

- 10) UCIL may also at its own discretion allocate any or all of the above persons for any other nature of work at any other place and at any other time which may be totally different from what is indicated above.
- 11) **RESOURCES:** Contractor shall have to provide full time personnel. The necessary documents regarding their qualifications and experience should be submitted along with acceptance letter of work order.
- 12) If the regular person is going on leave or remain absent, then the contractor have to make alternate arrangement and the alternate person deputed shall have to get full feedback regarding works from the person who is absent or going on the leave.
- 13) Contractor shall furnish details of the qualifications and experience of all proposed contract employees including their experience in maintenance of communication system.
- 14) The contractor shall maintain log-book of the job carried out by them.
- 15) Out of the **07 Nos.** of manpower to be engaged by the contractor the breakup with respect to deployment shall be as follows:

12. Buyer added ATC Clauses which are in contravention of clauses defined in bid detail section, including specifications, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by the applicable GeM GTC.
13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogues or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.

For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or notifications, the corresponding provisions of the pre-existing labour enactments (such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules) shall continue to remain applicable.

The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:

- **All notified and enforceable provisions of the new Labour Codes as mentioned hereinabove; and**
- **All operative provisions of the erstwhile Labour Laws until their complete substitution.**

All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider. Any non-compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.

This Bid is governed by the General Terms and Conditions, conditions stipulated in Bid and Service Level Agreement specific to the Service, as the case may be, as provided in the Marketplace.

However, in case of Service, if any condition specified in General Terms and Conditions is contradicted by the conditions stipulated in Service Level Agreement specific to said Service, then it will over-ride the conditions in the General Terms and Conditions.

This Bid is governed by the [सामान्य नियम और शर्तें/General Terms and Conditions](#), conditions stipulated in Bid and [Service Level Agreement](#) specific to this Service as provided in the Marketplace. However in case if any condition specified in सामान्य नियम और शर्तें/General Terms and Conditions is contradicted by the conditions stipulated in Service Level Agreement, then it will over ride the conditions in the General Terms and Conditions.
