2. **Purchase preference to Micro and Small Enterprises (MSEs):** Purchase preference will be given to MSEs having valid Udyam Certificate and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the

manufacturer / OEM of the offered product on GeM. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service, and Buyer will decide eligibility for purchase preference based on documentary evidence submitted in case of product bids, whereas in case of services the eligibility is automatically validated. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for % (selected by Buyer) percentage of total quantity. The buyers are advised to refer the [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

3. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price.

4. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

5. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

- If number of technically qualified bidders are only 2 or 3.
- If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
- In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.
- If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1
- If L-1 is non-MII and H-1 is eligible MII and H-1 price is coming within price band of 20% of Non-MII L-1

1. **Buyer Added Bid Specific ATC**

PRE-QUALIFICATION CRITERIA (PQC)/ ELIGIBILITY CRITERIA

The followings are the Eligibility criteria for this Non-divisible service Contract.The bidder may visit the proposed work site to get well acquaint about the site work before filling the rate/submit the tender.

1. **PAST PERFORMANCE AND PROJECT / PAST EXPERIENCE etc. CRITERIA:**

Bidder shall have successfully completed similar works during last 7 (Seven) years ending on bid opening date as per any one of following:

1. Experience of having successfully completed similar works during last 7 years ending last day of month previous to the one in which applications are invited should be either of the following:

Three similar completed works costing not less than the amount equal to 40% of the estimated cost (272.8 Lakhs)

OR

Two similar completed works costing not less than the amount equal to 50% of the estimated cost (341.0 Lakhs)

OR

One similar completed work costing not less than the amount equal to 80% of the estimated cost (545.6 Lakhs)

The “Similar Work” means “Experience in execution of “Any type of Development works like Raise, Winze, Shaft, Decline, Drive, X-Cut, Drift, Ramp, Incline etc. in any Under Ground Mine.” (Work Order Copy & Completion Certificate / Invoice copy should be attached as supporting document)

2. FINANCIAL STANDING:

Average annual financial turnover during the last three financial years (i.e. 2022-23, 2023-24 and 2024-25) should be at least 30% of the estimated cost.

3. EPF registration copy, GSTIN copy & Make in India Compliance must be submitted along with the bid.

4. Any bid not complying PQC requirements shall be summarily rejected.

5. EMD exemption only to relevant MSME/MSE.

6. Turnover exemption only for relevant Startups as per government guidelines.

Scope of work:

1. The Development of Decline & Raises at Bagjata Mine includes development of **7-degree** Decline, Drifts, Ore Drive, X-Cuts Ramps and raises (both vertical and inclined) of different lengths, Raise-cross-cut, Raise/Level stripping, Rock Bolting etc. in different levels of Bagjata Mines.

2. Working levels of Bagjata Mines are accessed through a **7-degree** Decline from surface. The levels are further needed to be developed, along with raises, so that the blocks are prepared for stopping & production.

3. This development work also includes making other permanent excavations like Sumps, Pump Chambers, Electrical Sub-Station, Tool Rooms, First Aid Stations, and Fire Stations etc.

4. Extension of all necessary G.I. Pipelines, HDPE pipes, for compressed air and industrial water, drinking water, pump delivery pipes, stowing pipeline for sludge cleaning (as and when required in their sump) shall be in the scope of the contractor.

5. Shifting of Electrical Cables, Light fixtures, Gate End Boxes, starters & Ventilation Fans, also removal/extension of ventilation Ducts near/far to/from the working faces as and when required shall be done by the contractor to provide good ventilation, illumination.

6. This work also includes the digging, concreting and maintenance of proper drainage throughout the excavation of Decline, Cross-cut and Drift, to prevent the accumulation of water at the working faces etc.

7. The machineries like drill jumbo/Boomer, LHD/ST, MT/LPDT required for lateral development of underground will be provided by the company. But, the jack-hammer, air-leg, 32mm Tungsten carbide drill-rod, hose pipes, servonium oil and connector pipes required for Raise development is under the scope of contractor.

8. Issue of safety PPEs like Gum Boot, Helmet, Dust Masks, Ear plug, Ear Muffs, Hand gloves, Goggles, Uniforms with fluorescent stripes/ fluorescent jackets, etc as per Regulation 181 of MMR-1961 is in the scope of the contractor.

cope of the contractor. All the safety PPEs like helmet, gumboot, respirator, fluorescent jacket, ear plug, cap lamp belt, should be provided to the workmen by the contractor at his own cost.

9. All the statutory payments like EPF, ESIC, Leave with wages, Bonus etc., to be paid for all the engaged employees on time, without any delay to clear their monthly RA Bills.

Decline without Arching:

Decline in hard rock will be as per **Drawing No-1.**

Drifts /X-Cuts

The Drifts, Drives /X-Cuts as per **Drawing No-2** will be driven at 1 in 200 gradients. .

Ramp

The ramps as per **Drawing No-3** will be driven at 8-degree upwards/Downwards.

Manholes in Drives, Drifts and Declines

Manholes as per the statute will have to be excavated along Decline, Drifts, X-Cuts Drives, Ramps, etc on both the sides at 20mtr interval or as per the direction of the Engineer-in-Charge.

Loading Bays

Loading Bays as per **Drawing will** have to be developed for transferring the muck loaded by LHDs in to the Mine Trucks. The distance between any two consecutive Loading-bays shall be normally 150m or any other distance fixed by the Engineer-in-charge.

Sumps /Pump Chambers /Sub-Stations etc.

The drawings for these excavations will be provided before execution of the work.

Raises

Raises both vertical and inclined are to be developed manually. The cross-section of the raises shall be 2. m X 2. m. Suitable ladders shall have to be fitted for the persons to climb up and down safely. Platforms shall have to be erected at appropriate locations for persons to work comfortably at the face. The tickler pipes should be extended as per requirement for providing face ventilation. Raise faces shall comply all the safety norms as described in Metalliferous Mine Regulation 1961 & DGMS Circulars updated time to time.

Raise Drifts /X-Cuts

Raise Drifts /X-Cuts shall be 3.0 meter X 3.0 meter in dimensions if they are driven manually by using the Jack hammer (this is necessary at the places like old workings, non approachable areas, raise cross cuts) to avoid more loose formations. Grade line and centre line shall be maintained regularly, the same shall be certified with the Departmental surveyor strictly. Drifts /X-Cuts shall satisfy all norms as have been described in Metalliferous Mine Regulation 1961.

Manholes excavation in the raise and crosscut

Manholes as per the statute shall have to be excavated along the vertical or inclined raises developed/advanced. Raise Drifts, X-Cuts and Raises in any one side as per the direction of the Engineer-in-Charge.

Excavation by Stripping at levels/old workings/roof of the stopes

Stripping shall be made as per requirement using Jackhammer at all critical places and direction of Engineer-in-Charge. It shall satisfy all norms as have been described in Metalliferous Mine Regulation 1961.

Miscellaneous work

Other works like provision of rock bolts, fencing etc by using jackhammer drill, shall be completed as per the requirement and direction of Engineer-In-Charge.

The Additional Terms and Conditions (ATC) have been incorporated by the Buyer after approval of their Competent Authority. The Buyer is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any restriction arising in the bidding process due to these ATCs and including the modification of technical specifications and / or terms and conditions governing the bid. All representations / grievances pertaining to the ATC clauses shall be raised with the buyer organization directly and not with GeM. If any of the clause(s) is/are incorporated by the Buyer regarding the following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

1. Publishing Custom / BOQ bids for items for which regular GeM categories are available (unless such Custom / BOQ item is bunched with the major regular product Category Item).
2. Mandating procurement of / from specific Brand / Make / Model / Manufacturer / Dealer except in case of Single Bid / Proprietary Article Certificate (PAC) Buying.
3. Inclusion of disqualification criteria related to suspension of seller / service provider, where such suspension period has already expired.
4. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.

12. Buyer added ATC Clauses which are in contravention of clauses defined in bid detail section, including specifications, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by the applicable GeM GTC.
13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogues or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
